Council Proceedings. Regular Session. Regular monthly meeting of the common council occurred on the 3rd inst.

Councilmen all present except Mr. Stanley who was out of the city. The monthly reports of the City Recorder, Treasurer and Marshal were read and referred to Finance Committee.

Total 150 12 Also at the meeting held on the 31st ult., Councilman G. W. White tendered his resignation. Adjourned session held on the 4th inst., Mr. White's resignation was accepted and the Council resuming the consideration of bids for building reservoirs and laying water pipes, which contract was awarded Mr. W. H. Mitchell of Seattle, Wash., on a vote of five to one against other bidders.

At special adjourned sessions held on the 5th inst., an ordinance was passed authorizing and directing the Mayor and Recorder to make and sign contract on behalf of the City with Mr. Mitchell (which was done) and adopting form for "Water Bonds, Series B" in the sum of \$20,000, as follows: 25 \$100 bonds, Nos. 1 to 25 inclusive, 15 \$500 " " 26 to 40 " 10 \$1000 " " 41 to 50 "

said bond dated September 1, 1903, are due and payable Sept. 1, 1913, or one year from date at the option of the city. The form of bonds as prepared by the City Recorder with a few changes as to date and heading was unanimously adopted, and that officer directed to have them printed at once.

Mr. Mitchell, the contractor, started for Seattle on the evening of the 5th expecting to return and begin work with a large force of men in about ten days. By the terms of his contract he is to have the whole system complete and in working order Nov. 1st 1903.

The schooner Gem arrived at the dock of the P. F. & L. Co. on Wednesday, bringing in a large amount of freight for the Co. and took out a cargo of lumber from their mill here which goes to their large furniture manufacturing plant in Los Angeles, California. This Co. has been shipping their lumber by the way of the bay, but on account of the large consignments of freight to be brought in, this schooner which has transporting hardwood from their Curry county mill this season, come in here this trip. The schooner Repeat which carries a cargo of 500,000 feet is at the bay, also taking on a load of the Co's lumber.
