Ton of Opium is Seized At Seattle. Seattle, May 23.—Government officials and local police seized 2,000 pounds of contraband opium this morning. This is one of the biggest hauls ever made in Seattle. Three arrests were made Saturday and one of the men confessed where the drug was hidden and later it was found. The value is \$11 per pound.

The arrest and confiscation is the outcome of strenuous efforts on the part of secret service officers who have known for some time that an apparently organized gang of smugglers was operating between the Canadian coast cities and the towns of Seattle and Tacoma.
