Postoffice Robber Pulled.

In addition to the robbery of the postoffice at Tallman, Linn county, last Saturday night, the office at Spicer, a station on the narrow gauge was likewise entered and robbed. Janeway, station agent and operator at that place was suspected, and accordingly a deputy went out there Wednesday night, apprehended him, and Thursday took him to Portland, where he was examined and held to answer in the sum of \$500. If Janeway is suspected of being the perpetrator also of the Tallman robbery, he has not been charged with it. He is described as a smart looking fellow, and one who does not appear like a postoffice robber; but the evidence against him is strong.

The Asylum Well.

The Salem Statesman says: The arrival of the new pump for the asylum well is noted in another column. Thursday morning masons began bricking up the inside of the large excavation above the well in which is to be placed the pump. The pumps will be directly over the well, and twenty feet below the surface. Their foundation is the arched covering of the well proper, which is filled with concrete. The "pump room" will be surrounded about the edges on the surface with an iron fence, and will be covered with some kind of an awning. In a few weeks the asylum will be furnished water from its own well.

Died in Portland.

Miss Clara Harder, an estimable young woman, employed at the Revere house in Portland died at St. Vincent's hospital Friday morning of pneumonia. The remains were brought to Albany on the train, where here parents and aunt, who were in the Albany cemetery. A brother of the deceased arrived too late to see her alive. Many friends mourn her departure, who testified to the esteem in which she was held by strewing her coffin with flowers. Deceased was a native of Hamburg, Germany, and was 28 years of age.

Timber Cutting Case.

Dick Turpin and M. L. Gillespie were tried before Justice Humphrey yesterday on the charge of cutting timber on the land of Isom & Lanning near this city. The case of the latter was tried before a jury. In rendering a verdict the jury stood four for acquittal and two for conviction. On motion of the attorneys for the state the case was dismissed, as was also the case against Dick Turpin.

A BUSY SEASON.

Preparations for Extensive Brickmaking for New Buildings This Season.

In conversation with Mr. H. J. Clark, the enterprising brickmaker and contractor, we learn that he intends manufacturing brick on a very large scale this season. He informed us that he had ordered a brick machine from Ohio, with which he can make 25,000 brick per day. He has already commenced enlarging his brick yard and getting up his wood, when he once gets his yard in running order he will have unequal facilities; he says he can make as good brick, and a great deal cheaper than hand moulded brick. He thinks, after the 15th of May, the time he intends to have his first kiln burned, he will be able to fill any orders for brick, no matter how large. A large amount of building will be done this season, and a large quantity of brick will be used.
