THE NATION'S LOSS.

Chief Justice Waite Dies at His Residence in Washington.

DEATH SUDDEN AND UNEXPECTED.

Funeral Not Yet Arranged For—High Water in New York Abating—Shot For a Lion—E. K. Accident.

WASHINGTON, March 23.—Chief Justice Waite died at his residence in this city at 6:30 o'clock this morning. The Chief Justice was in his usual health, though exhausted by his recent severe labors, until Saturday night, when on returning from Senator Hearst's where with his daughter he attended a reception, he complained of a chill, this feeling passed off during the night, but he remained in bed throughout Saturday and until it was time for him to go to court Monday morning, suffering from malaria and a vague indisposition. He did not read the opinion in the telephone case, but sat through its reading and then returned to his home. He was awake Monday night, and on Tuesday morning symptoms of acute bronchitis appeared accompanied by insomnia and great restlessness. His condition Tuesday was not alarming, but on Wednesday night pneumonia showed itself. During Thursday night he was comfortable and no particular alarm was felt, but at six o'clock this morning a failure of the heart action was observed. His daughter and son were with him when he died. While in Washington for California about a week ago, and accompanied by his wife and daughter, arrangements for the funeral will be buried at Topeka, Kan. The supreme court and both houses of congress adjourned as a mark of respect.

Cleveland Shocked.

WASHINGTON, March 23.—President Cleveland, when informed of the death of Chief Justice Waite, was very much shocked, although he was aware that Judge Waite had been in bad health for some time. Quite an intimacy had sprung up between the two officials. Since the president's term began, the latter has often been heard to express himself in the highest terms of praise of the chief justice's character and ability.

Remains Viewed.

NEW YORK, March 23.—Early this morning large numbers of people visited the city hall to view the casket containing the remains of General Raiz, the Venezuelan patriot, now lying in state there. This evening the body will be taken to the twelfth regiment armory, to-morrow it will be taken on board the United States war steamer Venezuela, which will convey it to Venezuela.

HANGING POSTPONED

To Give the Supreme Court Time to Review the Case.

SAN ANDREAS, Cal., March 23.—The execution of Geo. W. Cox, sentenced to be hanged to-day for the murder of his son-in-law, has been postponed, pending action by the supreme court.

Shortage in Willamette.

WILLAMETTE, Conn., March 23.—A shortage of \$150,000 has been found in the accounts of the Willamette savings institution, owing to a secret transaction by the cashier H. F. Royce, without the knowledge or consent of the directors.

DAMAGE BY HIGH WATER.

The Cold Snap shrinks the Water so Danger is Over.

CANAGUAH, N. Y., March 23.—A cold rain has materially reduced the rush of water to the Mohawk river and may prevent any more immediate danger. Trains are running very irregularly on the Central road west. The short bridge over Schoharie creek will not be fully repaired for several weeks, and only one train on this division is running. The wooden arches of the immense aqueduct canal at Fort Hunter have been carried away.

ERIE EXPRESS PURCHASED.

Wells, Fargo & Co. Capture the Prize

CHICAGO, March 23.—John J. Valentine, vice president and general manager of Wells, Fargo & Co., passed through here last night for San Francisco, having completed the purchase of the Erie Express and its entire plant, which was consummated in New York last week.

Passenger Trains Collide.

PITTSBURG, March 23.—Two passenger trains on the Pittsburg &

Lake Erie railroad collided forty miles west of Pittsburg this morning and were badly wrecked. One man was instantly killed and nine others seriously injured.

ESCAPED PRISONER.

Mistaken for a California Lion by a Hunter.

VISALIA, Cal., March 23.—Sheriff Parker returned this morning with the body of the man shot by Gus Alderson, who mistook him for a California lion. He was identified as Frank Dolinger, one of the jail breakers Arnold, who was his companion, and who was left in charge of the body, escaped.

OREGON WAGON ROAD GRANTS

Senate Passes Dolph's Bill Providing in Certain Cases for Forfeiture.

WASHINGTON, March 22.—Senator Dolph's bill providing in certain cases forfeiture of wagon road grants in the state of Oregon, passed the senate to-day. The same bill passed the senate in the Forty ninth congress, but was ignored by the house. The bill of Dolph directs the attorney general to bring suit in the U. S. circuit court for the district of Oregon against all persons or corporations claiming to own or having an interest in the military wagon road from Eugene City to the eastern boundary of the state; and also in the military wagon road from Albany, Oregon, to the eastern boundary of the state; and also the military wagon road from The Dalles to Fort Boise, on the Snake river, and determine the question of seasonable and proper completion of the road in accordance with the terms of the granting acts. To determine also the legal effects of the several certificates of the governor of the state of Oregon on the completion of said roads, and the right of resumption of such granted lands by the United States, and to obtain judgments which the court is authorized to render, declaring forfeited to the United States all of such lands as are continuous with the part of said roads which were not constructed in accordance with the requirements of the granting acts, and setting aside patents which have been issued for any such lands, saving and preserving the rights of all bona fide purchasers of such grants, or any portion of said grants, for valuable considerations, if any such there be.

CHINAMAN MURDERED.

He is Literally Backed to Pieces for His Money.

CHEYENNE, March 13.—At Rock Springs, Sweetwater county, the mutilated remains of a Chinaman were found yesterday in a hut in the Mongolian quarters. His throat was cut from ear to ear, and was literally beaten to a jelly. A large butcher knife was sunk to the hilt in his abdomen and shreds of flesh, teeth and pools of blood covered the floor. The dead Chinaman lived alone, and was known to have about \$600, and was undoubtedly killed for his money. Four Chinamen who were suspected of the crime have been arrested.

CALIFORNIANS PROTEST.

Against the Proposed Forfeiture of the Wagon Road Grants.

WASHINGTON, March 23.—The Pacific Coast members of Congress to-day received the following dispatch from San Francisco signed by a number of prominent citizens of that city: "We are interested in the matter of the proposed forfeiture of the Oregon wagon road grants. The report of the investigating commissioners sent by Sparks to Oregon, and which has been sent to Congress, is grossly false and unjust. We have vested rights to the amount of \$2,000,000 in these grants. We beg that you will have the subject matter referred to the Judiciary Committee of both Houses and give us ample opportunity of being heard."

AGAIN BEARD FROM.

The Sharon Case will Probably be Taken to Washington.

WASHINGTON, March 23.—Frank Newlands, ex-Senator Sharon's son-in-law, is here. It is said that the scene of the legal struggle between Mrs. Sarah Althea Terry and Sharon's estate may soon be transferred to this city. Sharon owned considerable real estate in this city, which has been sold in this city since the divorce litigation was begun. Sharon, however, guaranteed a title to the purchasers. ESCAPED PRISONERS CAPTURED.

For Lions and Fired on.

Visalia, Cal., March 22.—Yesterday Anderson, John Essex and one Dickinson were out fishing on Dry creek, and observing some object crawling along behind the rocks they thought it was a lion, and Anderson fired. What was supposed to be another animal close behind the object fired at was seen to move, and Anderson fired again. A man then held up his hands and cried "I surrender." Going to the place, they found a boy who answered the description of John Arnold and a man thought to be Frank Bolinger, both of the prisoners who escaped jail Friday night. Bolinger was shot in the head and died in a few minutes.

Superintendent Did Not Find Out.

Philadelphia News.

"Several years ago," said a railroad man, "when I was running on the Memphis & Charleston road, we had a superintendent who had the slightest practical knowledge of railroading. One day he telegraphed to Huntsville, Alabama, for an engine. The engineer was about to comply with the order when the discovery was made that the 'spider,' a vital part of the machinery, was broken. The engineer telegraphed to the superintendent: "Can't take out engine; spider broken." "The superintendent telegraphed back: "What is a spider?" Work on the Jetty.

Work goes ahead at the government works on the jetty at the mouth of the river. The driving piles on the extension of the jetty seaward began Friday. Six barges are now used in hauling rock from the quarry near Vancouver—the four government barges and two of the O. R. & N. company's barges. The government barges hold 22 tons each; the O. R. & N. barges 600 tons each. If rock is going to be brought so far, eight barges are needed to properly expedite the work. A railroad is what is really needed, and the saving of hauling charges would pay for the railroad before the work is completed.—News.
