GENERAL NEWS.

The Annual Race Between the Oxford and Cambridge Crews.

PHILADELPHIA THEATRE BURNED.

Funeral of the Dead Chief Justice—His Widow Leaves for the East—To Suppress Emigration.

The Herald's Special Dispatches. LONDON, March 24.—The annual race between the boat crews of Oxford and Cambridge universities took place this morning over the usual course on the Thames, from Putney to Martlake, a distance of four miles and two furlongs. The weather was dull. Cambridge won the toss for position, and took the Surrey side. When Hamme Smith bridge was reached Cambridge was leading by three lengths, and at Barnes' bridge they had put five lengths between themselves and their opponents. Cambridge crossed the winning line five lengths ahead of Oxford.

A Big Blaze.

PHILADELPHIA, March 24.—Central theatre, on Walnut street above Eighth, was totally destroyed by fire this morning. The rear wall of the building fell on the theatre Comique, immediately in the rear of the Central theatre, completely demolishing that structure. Koulson's hotel, adjoining the Central theatre on the west, was flooded by water, as were also several small stores, saloons and small restaurants.

Funeral of Justice Waite.

WASHINGTON, March 24.—A telegram has been received from Mrs. Waite acquiescing in the suggestion that the funeral services of the late chief justice be held in the hall of the house of representatives next Wednesday, and that the body be privately interred at Toledo next day. Mrs. Waite left Los Angeles for the East at 10 o'clock last night.

To Suppress Emigration.

PESTH, March 24.—The Hungarian authorities have issued an order prohibiting the railway officials from issuing tickets to emigrants in order to stop the excessive emigrations. It appears that the agents have been issuing fictitious checks to emigrants, and by this means have enabled them to evade the act forbidding the emigration of paupers.

A Raid on Gould's Stocks.

NEW YORK, March 24.—Jay Gould and family arrived at midnight. The raid on Gould's stocks still continues. The Missouri Pacific was driven down to 43 1/2 per cent., the Western Union 3/4 per cent., and the Union Pacific 1/2 per cent. before 11 o'clock to-day.

NEWS FROM THE STATE CAPITAL.

The Mystery Surrounding the Fatal Leap From the Salem Bridge Deepens—Marian County Republicans.

Colburn, who was so seriously injured in the railway accident on Thursday last, is lying in a most critical condition at Good Samaritan hospital. This morning Drs. Wheeler and Strong performed an operation of trepanning upon him and they found a huge clot of blood on his brain. He is partially paralyzed and there is no hope of his recovery.

FROM THE STATE CAPITAL.

Republican Primaries Held in Marion County—The Bridge Suicide.

SALEM, March 24.—Republican primaries were held throughout the county to-day. A large amount of interest was manifested in them, and in every one of the Salem precincts two and even three sets of nominees for delegates were voted upon. Returns so far as heard from indicate the nomination of Croisan for sheriff.

THE MYSTERY DEEPENS.

Two young men to-day confessed that the bottle in which was found the note about the suicide was put in the river by them on February 26th, long before the suicide was committed. Geo. Collins is therefore a fictitious person. Meanwhile the mystery about the suicide is as deep as ever.

STATE UNIVERSITY.

A special meeting of the board of regents of the above college was held in Portland recently, there were in attendance Hon. M. P. Deady, President, and Hon. L. J. McArthur, Hon. S. Hamilton, Hon. C. C. Beckman, Hon. R. Scott, Hon. R. S. Bean and Hon. T. G. Hendricks; absent, Hon. H. Failing and Hon. A. Bush. The primary object of the meeting was to consider it a advisability of erecting an observatory on the university campus at Eugene City. Plans previously prepared at the instance of the executive committee were submitted and finally adopted, and the committee was instructed to arrange for awarding the contract for the construction of the building. The proposed edifice will be built of cement and stone at a cost of from \$2000 to \$2500, and contain two rooms, one a transit room 12x24 and the other a recitation room 15x15. It has been decided to locate the observatory a short distance towards the southeast from Villard hall. The expense resulting from the erection of the new building will be met by drawing upon the improvement fund.

FROM ALL POINTS.

Over one hundred white men are said to be hiding in the famous Dismal Swamp of Virginia, once the refuge of many runaway slaves.

By the late statistics it is shown that negro property owned in Georgia, South Carolina and Louisiana pay taxes on property valued at forty-eight million dollars.

It is not generally known that camels, both wild and tame, are found in Texas, yet such is the fact. The first of these animals were brought to the State by the Government in 1852 to test their usefulness in crossing the American desert.

The State of New York is about to embark in the enterprise of keeping deer. Last year the legislature voted \$5,000 for the establishment of a State deer park in the Catskill Mountains, and recently the forest commission has taken the matter in hand.

For years one of the features of the Niagara falls has been a huge mound of ice formed by the freezing spray that falls upon a large rock at the foot of the American falls. It is proposed to convert this mound into a toboggan slide.

New York City is having a drinking saloon which will surpass in elegance anything of the kind in the country. The floor is inlaid with silver dollars, which are cemented in the marble floor in holes bored in alternate slabs—heads and tails up alternately. The handles of the beer-pumps are mounted with silver dollars. The place is named "The Silver Dollar" and the sign bears a huge counterfeit of the obverse and reverse of that much coined coin.

Four Chinese journals are published in San Francisco. These appear weekly, and have a circulation of twenty-five hundred copies. According to these Chinese a good printer can print four hundred sheets a day. Five days' work are required to get an edition of one thousand copies. The journals are printed with black ink on single sheets of white paper, except on the Chinese new year, when the printing is done with red ink or upon red paper.
