**GENERAL NEWS.**

**Arrangements for the Funeral of**  
Late Chief Justice Waite.

**DISASTROUS MISSOURI FLOODS.**

**Much Property Destroyed and Many Lives**  
Lost—The Panama Canal—Severe  
Snow Storm.

The Herald's Special Dispatches.

WASHINGTON, March 26.—At a  
meeting of the bar this morning it  
was decided that the members of  
the supreme court should meet at  
the court chamber at 11:30 o'clock  
Wednesday and proceed in a body  
to the house of representatives to  
attend the funeral services of the  
late Chief Justice Waite. The at-  
torney-general, Senators Edmunds,  
and Vest, Congressmen Culberson,  
Taylor and Messrs. Shullabarger  
and Ashton, of the district court,  
were appointed a committee to  
prepare resolutions commemorative  
of the death of the chief justice.  
The house adopted a resolution  
that the funeral services of the late  
chief justice be held in the hall of  
the house at noon Wednesday,  
March 28. The senate passed a  
bill appropriating \$5000 for the  
funeral expenses. The house  
passed the same bill later in the  
day.

**Damaging Snow Storm.**

CHICAGO, March 26.—Dispatches  
from various points in the north-  
west report the prevalence yester-  
day of a severe storm. Great dam-  
age to fruit and wheat is feared.

**Visible Grain Supply.**

NEW YORK, March 26.—Follow-  
ing is the visible supply of grain  
up to March 24: Wheat, 35,437,  
000 bushels; corn, 9,245,000; oats,  
4,081,000; rye, 355,000; barley,  
2,011,000.

**THE MISSOURI FLOODS.**

**Great Loss of Property and Life by**  
the Disastrous Overflow.

YANKTON, March 26.—The situa-  
tion on the upper Missouri river is  
identical with that of the spring of  
1881, when disastrous floods oc-  
curred, destroying life and prop-  
erty of great value. The snow lies  
all along the valley and a series of  
gorges have formed between here  
and Bismarck, while the head-  
waters of the river are broken up  
and flooding the bottoms. Intense  
anxiety is felt for the inhabitants  
throughout the valley.

**The Panama Canal.**

PARIS, March 26.—M. DeLesseps  
writes to the financial correspond-  
ents of the Panama Canal Com-  
pany that 108,226 new obligations  
have been subscribed for placing  
50,000,000 francs in the hands of  
the company. He regards this as  
satisfactory, but authorizes the  
correspondents to continue to receive  
subscriptions. He hoped that the  
government will now authorize a  
lottery.

**Wilson Acquitted.**

PARIS, March 26.—The court of  
appeals has reversed the decision  
of the lower court, in the case of  
M. Wilson, charged with complicity  
in the decoration scandal, and  
acquitted Wilson of the charges  
against him. Other persons tried  
with him on similar charges were  
also acquitted. The judgment of  
the court severely condemns the  
acts imputed to Wilson and others,  
but declares that the existing laws  
do not apply to the offense charged  
against them.

**FATAL ACCIDENT.**

**A Little Girl Dies from the Effect of**  
Barns.

ATROPA, March 24.—The little  
6-year-old daughter of Geo. Will  
farmer living one mile south of A-  
trope met with a painful as well as  
a serious accident Friday afternoon.  
Accompanied by neighboring chil-  
dren, the little girl went out in the  
field where the farm hands were  
burning up old rubbish, such as dry  
grass, etc. All of a sudden her dress  
caught fire, and before proper assist-  
ance could be given her body was burn-  
ed badly; in fact, her whole body  
was total mass of blisters and her  
sufferings naturally intense. Dr. M.  
Giey was summoned, who did every-  
thing in his power to save the little  
one, but that was not possible, and  
at about 7 o'clock Saturday morn-  
ing she died, leaving behind her a  
loving father and mother, one sister  
and two brothers. The funeral took  
place at 2 o'clock to-day.

**BASEBALL MATTERS.**

**American Nines to Play in Foreign**  
Countries.

CHICAGO, March 25.—President  
Spalding of the Chicago Baseball  
Club, announced this evening that  
he had perfected arrangements for a  
trip throughout Australia, New Zea-  
land and the Sandwich Islands. He  
will take two nines of the best play-  
ers in America across the Pacific  
ocean, leaving San Francisco about  
the 1st of October, and playing the  
first game in Australia about Christ-  
mas. Captain Anson will be one of  
the players, but the others have not  
yet been named.

The venture will cost \$35,000.  
Spalding's agent is now in New  
South Wales making dates for an ex-  
hibition.

**THE CROWN PRINCE.**

**He is to Become Emperor with**  
Government Affairs.

BERLIN, March 25.—The decree  
which was issued yesterday authoriz-  
ing the Crown Prince to transact  
official business, expresses the wish  
of the Emperor that he become con-  
sultant with affairs of state by im-  
mediate participation in them. It en-  
trusts to the Crown Prince the pre-  
paration and discharge of such busi-  
ness as may be assigned to him by  
the Emperor, and empowers him to  
affix his signature to documents as  
the representative of the Emperor  
without special authority on each oc-  
casion.

**THE O. R. & N. LEASE.**

**The Oregon Delegation in Consulta-**  
tion with New York Directors.

NEW YORK, March 25.—There is  
trouble in Northern Pacific and Ore-  
gon Railway & Navigation Company  
circle over the proposed lease of the  
latter. It seems that the local board  
of the Oregon company have refused  
to ratify the lease, because they con-  
sider it inimical to the interests of  
their corporation and to the State.  
A delegation has been here to con-  
sult with the New York directors of  
the two corporations.

**HEAVY SUIIT.**

**Proceedings Instituted in New Mex-**  
ico to Recover \$3,000,000.

ALBUQUERQUE, N. M., March 25—  
Papers have just been filed here of  
one of the largest and most impor-  
tant suits ever instituted in New Mex-  
ico. G. W. Harrison of Corvallis,  
of this country, married the widow  
of Jose L. Perra, and now gues the  
administrator and heirs of the estate  
a counting and distribution of prop-  
erty. Perra was one of the wealth-  
iest men in the Territory. The wo-  
man was his second wife. He some  
time before his death transferred to  
his heirs and other parties a large  
amount of property without her sig-  
nature. Suit is now being brought  
to secure the wife's dower. The sum  
involved is estimated at \$3,000,000.

**An Editor on Drummers.**

At the game supper given at  
Macon, Ga., the other night, to the  
Travelers' Protective Association,  
F. H. Richardson, of the Telegraph,  
eloquently apostrophized the  
assembled guests:

"What would Georgia be with-  
out her drummers? She would be  
scorped, corralled, and crushed in  
the mad battle for commercial sup-  
remacy. What would Macon be  
without her drummers? She would  
signate on the hills of her beauty  
and starve in the valley of her  
plenty. The drummer is the  
courier of progress. The drum-  
mer carries the thought and cus-  
toms of the city into the provinces.  
He sows the seeds of promise in  
waste places. He makes the dreary  
hours to blossom with song and  
jest. He is the swift and shining  
shuttle which weaves the wool and  
warp of our wealth. Wherever the  
pioneer blazes the match of civiliza-  
tion the echo of his ax is the  
footfall of the drummer. Wherever  
men gather in the mart his voice is  
heard. Wherever a weak and de-  
fenceless woman is in distress, his  
big heart and his strong arm are  
ready to serve her. Wherever a  
vicious tongue asperses the fame of  
his city or his state, no quicker  
than he to resent the insult.

"There is in our busy times no  
more interesting, no more roman-  
tic figure. He is destined to hold  
in literature a place as unique and  
as honorable as he holds in com-  
merce. Gay as the troubadour,  
gallant as the laureled hero of the  
tourney, loyal to duty, at once  
shrewd and chivalrous gentle, and  
brave, undaunted by difficulty de-  
dicated of discomfort, I dub him the  
knight errant of civilization.

**Old Bill Gaines' Joke.**

When old Bill Gaines, an itinerant  
peddler, was driving across the  
country from Tecumseh to Deerfield,  
a few days ago, he met an exper-  
ience which has turned his naturally  
joyous disposition to the bitterness  
of gall. He left his team to rest near  
Halloway and walked into the vil-  
lage to get some "chawin'" found  
the clerk in the big general store all  
alone, and with him entered into a  
conspiracy to adorn the tail of an  
ownerless yellow dog with an oyster  
can partly filled with stingle nails.  
The dog proved to be a good runner,  
and Bill and the clerk laughed them-  
selves nearly sick to see him skee-  
daddle several times around the store  
and then streak it off up the road.  
It was a very joyful occasion, and  
they had not yet recovered any great  
measure of dignity when Bill's little  
son came dashing up. "Pop—pop,"  
he cried between breaths, "some  
damn—fool tied a can to a dog's  
tail—'n it scared the horses 'n  
they run away 'n smashed the wagon  
'n everythin' 'n one of 'em's layin'  
in the ditch clean dead."

**FACTS ABOUT 1888.**

**The Important Events to Occur**  
During the Year.

It is leap year. February has  
twenty-nine days. Washington's  
Memorial Day also falls on Wed-  
nesday. The 17th of June (anniver-  
sary of the battle of Junken Hill)  
is Sunday, which means a holiday  
Monday. The Fourth of July is  
Wednesday. Thanksgiving will be  
appointed on the 29th of November  
if the old custom is followed.  
Christmas will fall on Tuesday.

Lent begins early, as Ash Wed-  
nesday falls on Feb. 15. The first  
day of April will be Easter Sun-  
day. Trinity Sunday falls on May  
27.

There will be a total eclipse of  
the moon visible at Boston on Jan.  
28. The eclipse begins at 4:30  
o'clock in the afternoon, is total at  
6:20 o'clock and ends at 8:10  
o'clock.

A second total eclipse of the  
moon will occur on the night of  
July 22 and 23. The eclipse will  
begin at 10:55 o'clock, total at 12:45  
o'clock and ends at 3:03 o'clock.

There are three partial eclipses  
of the sun to take place—the first  
on Feb. 11, the second on July 8  
and the third on Aug. 7. If a per-  
son wishes to witness these eclipses,  
for the first two he must go to the  
Indian or South Pacific Ocean, and  
to the Arctic Ocean to see the third,  
which would mean considerable  
travel. The morning stars will  
be: Venus until July 11, Mars until  
April 11, Jupiter until May 22 and  
from Dec. 7 to close of year, Saturn  
from Aug. 1.

The evening stars will be Saturn  
from Jan. 23 to Aug. 1, Venus from  
July 11, Mars from May 22 to Dec. 8,  
Jupiter from May 22 to Dec. 8.

If a person is anxious to obtain a  
view of Mercury the best time for  
him to succeed is in the early  
morning before the sun is up, viz.,  
March 30, July 29, Nov. 17, or just  
after the sun has set on Feb. 17,  
June 12 and Oct. 8 in the West.

The Presidential election will  
take place on Tuesday, Nov. 6.

**The Deadly Cigarette.**

Among the recent sudden deaths  
in this city is that of a young man  
of much promise, Mr. Russell H.  
Knevals, a son of the late partner  
of ex-President Arthur, a victim, it  
is the autopsy indicated, of cigarette-  
smoking. He was a young man of  
fine physique, with the appearance  
of vigorous health. It was shown  
at the inquest that he had been in  
the habit of smoking about three  
packages, or sixty cigarettes, daily;  
that this had greatly impaired the  
action of the heart, and had finally  
culminated in consequent conges-  
tion of the brain, with attendant  
coma, resulting in death. His  
death was a shock and a great  
grief to a large circle of sorrowing  
friends.

A well-known physician, Dr.  
Sayre, is reported, in a newspaper  
interview, as describing the ciga-  
rette as simply a paper cylinder  
filled with tobacco; that the  
nicotine cannot percolate through  
the paper and is all drawn through  
the tube into the smoker's mouth,  
while with the cigar much of the  
nicotine has a chance to evaporate  
through the porous wrapper, that  
it is the nicotine which poisons.  
It is also reported as saying that  
he had many patients, "any num-  
ber of them," suffering from over  
indulgence in cigarettes.

Cigarette-smoking is an evil of  
large and rapidly increasing pro-  
portions. The young man, and
