Wants to Advertise Albany. Mr. L. Samuels, publisher of the West Shore, is in the city in the interests of that well known publication. He desires the citizens of Albany to join with him in advertising this as well as other portions of Oregon. He agrees to give each month one page in the West Shore descriptive of Albany and Linn county, and to send east of the Rockies each month 5000 copies to be distributed in different sections, by a man he has employed in St. Paul, the people of Albany to pay for the same \$100 per month. Albany should have a board of trade to consider this as a similar proposition.

THE RAILROAD COMMISSION.

Charges of Discrimination on the O. R. & N. and O. & C.

Commissioner Stator having arrived from Peoria, a session of the railroad commission was held at the capitol. The commissioners found quite an amount of routine business to transact, and answered a number of letters. Among these was one to the O. R. & N. company, in regard to the complaint made by Russell & Co., of Portland, that they overcharged a water tank they had shipped from Portland to Union. The company had insisted upon rating the shipment as an oil tank, the rates for which are double. The commission wrote to the company regarding the complaint of the shippers, and an answer was received giving the reasons for such charge, and declining to allow any rebate. The answer of the commission, dispatched yesterday, protests that the railroad's reasons for making such double charge are not sufficient.

Some time since a complaint was received from a shipper at Canby, on the line of Oregon & California, charging that that company was discriminating against Canby and in favor of New Era, in certain freight charges, and the complainant asked that the commission interfere to prevent such discrimination. The commission has been investigating the circumstances of the case and has come to the conclusion that any interference on their part would not be justified. Under Deady's interpretation of the interstate commerce law, a railroad company is allowed to make reductions of freight charges in favor of a town that is a competing point. New Era is on the Willamette river, and the railroad company is here brought into competition with steamboats; therefore, to meet their rates, reduction had to be made. This the commission considers the company was warranted in doing; and therefore its action will not be questioned by it.

The commission left for Oswego, on the line of the narrow gauge, near which place the railroad accident occurred about two weeks since. The disaster will be investigated, and the blame if any will be affixed where it belongs.

Our Famous Product.

Oregon's big red apples have always been one of her strong suits, and when it was announced a few days since that a lot of apples had been imported here from California the news caused a thrill of shame and amazement to pass down the spinal column of all Oregon orchardists. To set matters and destroy the unfavorable impression created by this unheard-of piece of business, an orchardist on the east side yesterday brought to town fifty four boxes of fine, handsome red cheek pippins as any one could wish to see, in perfect condition, and he sold them for \$2.50 a box, and carried home \$132.50 in his pantaloons pocket. Oregon is ahead on the apple question and is going to keep there.—Oregonian.

Captain Powell's Successor.

A late Washington telegram to the Chicago Evening Journal states that Senator Farwell and Congressman Mason and Lawler are protesting against the transfer of Major Handbury, U. S. A., now in charge of the engineering work at Chicago, to Oregon. General Benet was acting as secretary of war and could not definitely answer the congressmen's requests. A renewed effort will be made on the return of Secretary Endicott. The telegram says: "There is no disposition on the part of these gentlemen to reflect upon Captain Marshall, of Milwaukee, who has been ordered to Chicago to take Handbury's place, but it is felt that the familiarity of the last mentioned officer with the work ought to cause him to be retained."

Severely Kicked by a Horse.

Mr. Abe Hackleman yesterday while harnessing the spirited trotting horse he is accustomed to drive, was severely kicked in the face. The horse was newly shod, and the bones of the nose were broken by the blow and a deep gash cut in the cheek. Dr. Maston was called and rendered medical assistance, by administering restoratives and sewing up the wounds. Mr. Hackleman remained insensible for about three hours, but last evening was resting easy, with good prospects of speedy recovery.

A Deserving Enterprise.

The tile factory building of Anthony Propst and A. Austin, situated three miles east of this city, which was blown down during the recent wind storm, has been rebuilt. These gentlemen have put in a twelve horse engine, and propose to engage in the manufacture of brick and tiling for draining purposes, which is an undertaking deserving of success.

Presbytery of Oregon.

The presbytery of Oregon will hold its annual meeting in the First Presbyterian church of this city next week. The opening sermon will be preached by the retiring moderator, Rev. E. J. Thompson, D. D., of Corvallis, on Tuesday evening at 7:30 o'clock. On Wednesday and Thursday evenings popular meetings will be held which will be of interest to the public. The music for these popular meetings will be under the direction of Prof. W. H. Lee. The Women's Presbyterian Missionary Society will hold its annual meeting in the lecture room of the church on Wednesday and Thursday, beginning at 9:30 a. m. The public is cordially invited to these meetings.

THE COUNTY COURT.

Proceedings of the April Term—Bridge Matters—Claims Allowed.

In the matter of the petition of Jeff Morris and thirteen others for the removal of the supervisors of road district No. 45, continued. The matter of the application of Jos. A. Jones and others for an alteration of the county road. The report of the viewers was read and the road established and ordered opened, and bills for viewing and surveying were allowed in full, amounting to \$14.00.

The bridge matter at Stayton was continued until next term. Wm. Turner was sent to G. Morris's to be kept as one of the county poor.

Farmer bids for the construction of a bridge over Beaver slough was rejected and advertisement ordered again.

The petition of Israel Carlton for a bridge was continued. Witness fees at the circuit court and before the grand jury was allowed in full.

The application of E. A. Evans and others for an alteration of the county road. Wm. Cochean, J. W. Washburne and Silas Powell were appointed viewers, and E. T. Fisher surveyor, to meet on the 24th of April.

In the matter of the relief of Mrs. Elizabeth Roberts, it was ordered that \$20 be placed in the hands of Dr. G. F. Crawford for two months.

Mrs. Caroline King was allowed \$8 for contract a minor.

The contract for building a bridge over the Power's slough was let to H. Stone for the sum of four hundred and eighty dollars.

The boundary of road district No. 20 and 27 was changed.

Fifteen dollars was appropriated for the relief of Lydia Kicks under the charge of D. S. Smith.

Five dollars was allowed for the aid of Jane Larrin in the hands of J. R. South.

Toll rates over the Willamette Valley & Cascade Wagon Road were fixed as follows:

Four horse wagon, four cents per mile; two horse wagon, three cents per mile; two horse hack or buggy, two cents per mile; one horse or man, one cent per mile; loose horses, one-fourth of a cent per mile; loose cattle, one-sixth of a cent per mile; sheep and hogs, three cents each per trip.

The said toll shall be collected upon the following portion of said toll road, and not otherwise: Commencing at a point called Deer Creek, about one and one-half miles this side of what is known as Lower Soda, in Linn county, Oregon, and running to the eastern boundary of Linn county. The said three cents per head for sheep or hogs is all that shall be collected from any one driving hogs or sheep from Linn to Crook, or from Crook to Linn counties.
