He Writes a Letter From the National Capital.

HE MINGLES WITH SOCIETY.
And Writes up the American Congress, the White House, and Boarding Houses of the District of Columbia.

Congressmen and their wives are daily landing at the great national Castle Garden and looking wildly around for the place where they are told they will get their mileage.

On every hand all is hurry and excitement. Bills are being introduced, acquaintances renewed, and punch-bowls are beginning to wear a preoccupied air.

I have been mingling with society ever since I came here, and that is one reason I have written very little for publication and did not send what I did write.

Yesterday afternoon my money gave out at 3:30, and since that my mind has been clearer and society has made fewer demands on me. At first I thought I would obtain employment at the Treasury Department as exchange editor in the greenback room. Then I remembered that I would get very faint before I could go through a competitive examination, and in the meantime I might lose social caste by wearing my person on the outside of my clothes.

So I have resolved to write you a chatty letter about Washington, assuring you that I am well, and asking you to kindly consider the enclosed tabulated bill of expenses, as I need the money to buy Christmas presents and get home with.

Poker is one of the curses of national legislation. I have several times heard prominent foreigners say, in their own language—thinking, no doubt, that I could not understand them—that the members of the American Congress did not betray any emotion on their countenances.

One foreigner from Liverpool, who thought I could not understand his language, said that one of the Congressmen had a way of looking as though they did not know very much. When he afterward played poker with those same men he saw that the look was acquired. One man told me that his account book had been as good as \$50,000 to him, whether he stood pat or drew to an ostensible flush, while really holding four bullets.

So far I have not been over to the Capitol, preferring to have Congress kind of percolate into my room, two or three at a time; but unless you can honor the enclosed way-bill, I shall be forced to go over to the House to-morrow and write something for the paper. Since I have been writing this I have been led to inquire whether it would be advisable for me to remain here through the entire session or not. It will be unusually long, lasting, perhaps, clear into July, and I find that the stenographers, as a general thing, get a pretty accurate and spicy account of the proceedings, much more so than I can, and as you will see by the enclosed statement, it is going to cost more to keep me here than I figured on.

My idea was that board and lodging would be the main items of expense, but I struck a low-priced place where, by clobbering together with some plain gentlemen from a distance who have been waiting here three years for political recognition, and who do not feel like surrounding themselves with a hotel, we got a plain room with six beds in it. The room overlooks the District of Columbia, and the first man in has the choice of beds, with the privilege of inviting friends to a limited number. We luncheon plainly in the lower part of the building in a standing position without restraint or ingenuities. So board is not the principal item of expense, though of course I do not wish to put up at a place where I will see a disgrace to the paper.

I wish that you would, when you send my check, write to me frankly whether you think I had better remain here during the entire session or not. I like the place first rate, but my duties keep me up nights till late hour, and I cannot sleep during the day, because my room-mates annoy me by doing their washing and ironing over an oil-stove.

I knew by what several friends have said to me that Congress would like to have me stay all winter, but I want to do what is best for the paper.

I saw Mr. Cleveland briefly last evening at home, but he was surrounded by a crowd of fawning sycophants, so I did not get a chance to speak to him as I would like to, and don't know as he would have advanced the amount to me anyway. He is very firm and stubborn, I judged, and would yield very little indeed, especially to yours truly.

GENERAL NEWS.
A Murderer Hanged by a Mob at St. Helena, California.

JAY GOULD MEETS A REBUFF.
He Is Politely Informed That He Cannot Own the Earth Nor All Its Railroads—News from the Old World.

The Herald's Special Dispatches.
ST. HELENA (Cal.), May 5.—John Wright, who shot and killed Budd Vann in this town two weeks ago, was taken from jail early this morning by a mob of masked men, and hanged to a bridge at the head of Main street. Wright had been confined in the county jail at Napa since the shooting, but was brought here yesterday for preliminary examination. No one suspected an attempt at lynching would be made. At one o'clock this morning Justice Elgin, who had the jail in his keeping, was called to his door, surrounded by a mob and forced to give up the keys. The crowd then took the prisoner from the jail, and in ten minutes his body was hanging from the bridge. No arrests have been made, but the sheriff is deplored by all law-abiding citizens. The shooting of young Vann occurred near a house of ill fame. Vann and some companions were standing near by when some one threw a rock at the window. Wright, who was a brother of an inmate of the house, immediately fired a pistol, striking Vann.

A HALT CALLED.
Jay Gould Politely Informed That He Cannot Own the Earth.
New York, May 5.—Jay Gould and other officers of the Missouri Pacific and Missouri Kansas and Texas railway companies were served yesterday with an order to show cause why they should not be made to halt in their endeavor to get absolute control of the International and Great Northern railway and sever it from its owners. The order was obtained from Judge Barrett by the counsel for Wm. Landon Bull and Wm. Martinson, representing a majority of the stockholders, who propose to oust the Gould board at the annual election, May 16. Judge Barrett also granted a temporary injunction restricting Gould and his associates from any way monkeying with the stock or securities of the Missouri, Kansas and Texas or International and Great Northern, or in any way changing the status of either company, unless after the annual election, and they are all ordered to show cause in addition why their recent actions should not be declared void. It was only last Tuesday or Wednesday that Landon Bull and Martinson learned that Gould and his associates had by clever manipulation secured control of about all the stock and bonds of the International and Great Northern without payment, and that the directors of the Missouri, Kansas and Texas had hurriedly agreed to cancel the lease of the International to their road. They at once took measures to frustrate the scheme with the result mentioned.

The Papal Rescript.
DUBLIN, May 5.—At the request of the Catholic members of parliament the lord mayor of Dublin convened a meeting to-day for the purpose of discussing the pope's rescript. Resolutions were adopted traversing the statements by which the pope justified his rescript, assuring his holiness of unaltered attachment to him and his spiritual pac, but firmly and respectfully, but emphatically refusing to recognize his right to intervene in Celtic politics. Meetings will be held throughout West Clare to-morrow to protest against the papal rescript, on the ground that the pope is ignorant of the sufferings of the people of Clare.

Ports Opened.
LIMA, May 5.—The government has declared the Peruvian ports open to Chilean traffic, with the exception of the ports between Valparaiso and Antofagasta, in which zone some cases of cholera are still reported.

Cholera scarce.
MADRID, May 5.—An epidemic has broken out here. The disease is cholera, attributed to the extreme heat and impure milk.

Blaine in Good Health.
NEW YORK, May 5.—Mrs. Carnegie has received a letter from Mrs. James G. Blaine, accepting an invitation to join the Carnegies coaching party through the Scotch highlands about the sixth of June. Mr. Blaine's friends assert it as evidence of his improved health that he takes such a trip.

Prohibition Committee Call.
ALBANY, May 1, 1888.
