New York Republicans Want James G. Blaine for President.

**ABOUT PRESIDENTIAL CANDIDATES**

An Interesting Interview with a Conkling Man—Notes and Comments on Matters before Congress

Special Correspondence.

WASHINGTON, May 1.—"Blaine and Depew will be the ticket nominated by the Chicago convention, and they will carry New York by over 25,000 majority." The speaker was a New York republican who for many years has been closely connected with the late Roscoe Conkling in political affairs, and who refused to vote for Blaine in 1884. In reply to my questions he said: "Mr. Conkling and his friends—myself included—made a mistake in refusing to support Mr. Blaine. We saw it when too late to change the result, but we propose to make amends this year by insisting upon the nomination of Mr. Blaine. Mr. Conkling was thoroughly in sympathy with this movement and had he lived would have stumped the state for Blaine. Mr. Blaine was defeated by our defection in the State of New York. He stood the punishment like a man, and now we intend to see that he is rewarded for his long service and fidelity to the principles of the republican party, and in order to make assurance doubly sure we propose to put Chauncey Depew, New York's brainiest and most popular son, on the ticket with him. Blaine and Depew make a combination that will be invincible in New York."

Will Mr. Depew accept the second place on the ticket? I asked. "Yes, with Blaine first. He thinks Blaine the greatest living American, and would make almost any personal sacrifice to help to make him President."

This programme is to be carried out what is to become of the boom of all the other "favorite sons" of the various States? "When they are returned, as they will be at the proper time, that this ticket is the unanimous choice of the united republican party of the State of New York, and that its nomination will take that State out of the doubtful column and restore it to its oldtime position at the head of the republican column, they will all acquiesce and the nomination will be made by acclamation. Then will follow the most enthusiastic campaign of the age."

Gray of Indiana seems to be in the lead for the democratic nomination for the vice-presidency. His name, it is thought will console the ex-rebels for not getting one of their number nominated.

Representative Browne of Indiana, who is an authority on politics in his State thinks the republicans will carry it this fall. His reasons are the lack of harmony among the democrats; the disaffection, through disappointment at not getting offices; the immense array of ward and precinct workers and the bitter feeling between the McDonald and Gray factions of the democratic party.

Senator Paddeck's bill, providing for the erection of a public building in every town at which the gross postal revenues have been \$3,000 a year for the last three years, has been favorably reported by the Senate committee on post-offices and is very likely to be passed by the Senate at an early day.

The Senate committee on agriculture favorably reported the bill, which was passed by the Senate at the last congress, but not by the house, providing that the commissioner of agriculture shall be a member of the cabinet.

His statement fixes the explosion as the result of a design. He claims that a noted blockade runner and mail carrier named Robert Lowden, better known during the war as Charles Haley, was the author of the terrible disaster. Streeter claims that Lowden told him after the escape of the war, that while the Sultan lay at Memphis he smuggled aboard a large lump of coal, in which was concealed a torpedo. This he deposited on the mid-side in front of the boiler, for the express purpose of causing the destruction of the boat. What has become of Lowden is unknown.
