### AT CHICAGO

### The Delegates Begin Their Great Battle of Ballots.

NO NOMINATION YET MADE.

How the Vote Stands—Col. Ingersoll Speaks for Gresham—The Situation Reviewed.

Special to the Herald.

CHICAGO, June 23.—The convention has reached a stage in which all interest in its proceedings terminate. The decks have been cleared for action, and the battle is about to begin. What the first ballot will disclose is already known. The absorbing interest is to know what the 3rd, 4th or 5th ballots will show. The convention hall is full of rumors, stories and wild guesses. Sherman loomed up last night because of the great demonstrations which the presentation of the Ohio senator provoked. There was a feeling that Sherman would win to-day or not at all. Rumors are afloat of a movement in Pennsylvania to change from Sherman to Harrison, but there are so many stories afloat that nobody seems sure of the ground he stands on and everybody is prepared for unexpected developments.

### A DARK HORSE.

Attention is called to the fact that McKinley, in having secured eight votes on the third ballot, stands in precisely the same position as that occupied by Garfield in '80. As an earnest follower of Blaine, and the man best qualified after Blaine to make a strong protective campaign, he is occupying much more attention than the size of his vote warrants, and should California now swing to him, it would be very significant as showing the direction in which Blaine's friends are tending, and it is believed that it might result in his nomination.

### IT LOOKS LIKE BLAINE.

CHICAGO, 19 A. M.—The Tribune says there is a scheme on foot among Blaine's friends to nominate him after giving Harrison a chance, as a hint to beat Sherman. It says New York may turn to Gresham, if Depew is not taken up by other states.

### MORE PRESS COMMENTS.

The News says: "Michigan, Ohio and Indiana have formed a combination to prevent a stampede to Blaine."

The Inter-Ocean says: "New York is retiring from Sherman and Gresham, and Harrison's stock is advancing."

The Times says: "The contest is narrowing down to Blaine, Sherman and Harrison."

At 11:30 the roll call was ordered, and when California cast 16 votes for Blaine there was great cheering.

A motion of Miller the convention adjourned until 7 p. m.

### EVENING SESSION.

Chicago, 7:31.—The convention was called to order, and the entrance of Depew was greeted with applause.

James of Wisconsin, said that state would go to Harrison.

A motion was then made to adjourn until 9 a. m. to-morrow.

Depew took the platform and said he could here as a delegate, neither expecting, nor desiring to appear in any other capacity. After his arrival New York presented his name. For stated reasons, he says, his vocation and association will create a question which may endanger the prospects of the party; therefore he withdraws.

Depew's announcement was greeted with unanimous cheers.

Hastings, of Pennsylvania, took the platform and moved to adjourn at 10 a. m.

North Carolina, Missouri and Maryland seconded the motion and great confusion.

Roll was called on a motion of adjournment, and the convention adjourned until 9 a. m. to-morrow.

8 p. m.—Col. Bob Ingersoll took the platform and said he favored the nomination of Gresham [multitudinous demonstration in the audience]. As Ingersoll sat down the band struck up to drown the noise.

The California delegation raised a big banner, having the inscription "Blaine and Protection" [great applause and confusion].

8:30 p. m.—Chas. Pope, of St. Louis, is reciting "Sheridan's Ride."

### THE SITUATION REVIEWED.

It is reported on pretty good authority that New York will swing a portion of its votes for Harrison.

The situation at adjournment this evening as viewed by your correspondent is that the race is narrowed down between Blaine, Harrison and Gresham, with chances standing in about the order of the three named.

It is pretty definitely settled that if the convention fails to unite upon any other candidate, and nominates Blaine, that he will accept. The selection for the second place is so overshadowed by the interest in the nomination for president that little is being done among the secondary candidates, and the first nomination will aid in determining the secret.

### THE CHIEF POINTS OF DOCTRINE OF THE GREAT REPUBLICAN PARTY.

The platform opens with an eloquent tribute to the first great leaders of the republican party, Abraham Lincoln, and the more recent leaders recently passed from earth, Grant, Garfield, Arthur, Logan and Conkling. The name of Sheridan is also recalled with greetings and prayers for his recovery.

Fraternal congratulations are sent to Brazil upon the emancipation of slavery in that realm; and sympathy with the Irish on the home rule question is expressed.

Unwavering devotion to the constitution and the just liberty of states, and to the personal liberty of every citizen, native or foreign, black or white, rich or poor, is reaffirmed.

Effective legislation to secure the freedom and purity of the ballot is demanded, and the present democratic majority in congress is arraigned as guilty of suppressing the ballot by a criminal manipulation of the constitution and laws.

The platform favors uncompromisingly the American system of protection and protests against its destruction, as proposed by the president and his party. It denounces the Mills bill as destructive to business, labor and the general interests of the country. It favors reduction of revenue by a repeal of the tobacco tax, and the tax upon spirits used in the arts, and to the personal liberty of every citizen, native or foreign, black or white, rich or poor, is reaffirmed.

Effective legislation to secure the freedom and purity of the ballot is demanded, and the present democratic majority in congress is arraigned as guilty of suppressing the ballot by a criminal manipulation of the constitution and laws.

The platform favors uncompromisingly the American system of protection and protests against its destruction, as proposed by the president and his party. It denounces the Mills bill as destructive to business, labor and the general interests of the country. It favors reduction of revenue by a repeal of the tobacco tax, and the tax upon spirits used in the arts, and to the personal liberty of every citizen, native or foreign, black or white, rich or poor, is reaffirmed.

It declares opposition to combinations of capital organized into, reaffirms the policy of securing the public domain to homestead settlers and American citizens established by the party in 1862, and advocates the restoration of unearned railroad grants to the people.

The democratic party is arraigned for keeping territories entitled to become states out of the Union for partisan purposes, and the republican party is pledged to use all legitimate endeavor to secure to these territories the rights and privileges of statehood.

Reduction of letter postage is demanded and the free school system of the nation is endorsed.

Appropriations are demanded for the early building of our navy, the construction of our coast fortification for the payment of just pensions to soldiers, for the improvement of our channels and harbors to the benefit of internal, coastwise and foreign commerce, and for the payment of

national public debt.

The foreign policy of the administration is charged with inefficiency and cowardice, especially in regard to the fisheries question. It is declared that pension legislation should be so enlarged as to make it impossible for any man who wore the federal uniform to become an inmate of an almshouse or dependent upon private charity, and that the numerous votes of pension bills is a public scandal.

The platform concludes by inviting the comparison of patriotic men of all parties, and especially of all working men, with the free trade policy and censurable acts of the present administration.

### SPECIAL NEWS.

### A Murderer Hung from the Old World.

LOUISVILLE, June 22.—William Patterson was hanged here this morning for the murder of Jennie Paimant, a servant girl. Patterson protested his innocence on the scaffold. He strangled slowly to death. Four minutes after the drop fell he said "Curse them," and then "Lord save me." His struggles were fruitless.

### FOREIGN NEWS.

### DIVORCE BILL.

LONDON, June 22.—Mrs. Bonicaull, wife of the well known playwright, has obtained a divorce. Mrs. Bonicaull was also awarded costs.

### ANTI-SOCIALIST LAW.

BERLIN, June 22.—Bundestag to-day agreed to a renewal of the anti-socialist law.

### JOHN DILLON IN PRISON.

DUBLIN, June 22.—John Dillon, who was yesterday taken from the Dumbank jail, has been sent to the infirmary connected with the jail.

### NORTHWESTERN MATTERS.

WASHINGTON, June 21.—Senator Dolph from the committee on commerce reported to the senate to-day, with recommendations that they pass Senator Mitchell's bill providing for the purchase of ground and the construction of a wharf for the use of the lighthouse board at Astoria Oregon, with an amendment increasing the appropriation from \$10,000 to \$15,000, and the bill of Senator Mitchell appropriating \$8000 for the construction of a lighthouse at the mouth of the Umpqua river.

Senator Dolph has been notified by the second assistant postmaster-general that an order has been issued to increase the mail service to seven times a week between Heppner and Arlington, Oregon, on route 44,199, to take effect July 1 next.

The river and harbor bill will probably be taken up in the senate on Monday next, and will be passed before the end of the week. The consideration of this bill has been delayed by the absence of members of the senate occasioned by their attendance at the two conventions.

Representative Hermann, in the session of the house last night called up and had passed his bill providing for the construction of a bridge across the Columbia river between The Dalles, in Oregon and the Washington territory shore. He also secured the passage of a bill providing for the construction of a bridge across the Columbia river between Washington territory and Oregon at LaCamas. These bills have both passed the senate and will now be sent to the president for his approval.

During the consideration of the sundry civil appropriation bill in the house to-day, Representative Hermann had incorporated an amendment providing for a resurvey of certain townships in Southern Oregon, on the Umpqua, above Canyonville. The boundaries of these townships overlap and have caused great confusion, in the titles of settlers within them. Although many attempts have been made through petitions of citizens interested and through recommendations of the surveyor general of Oregon, it has been found impossible to obtain an adjustment of the boundaries, the department always holding that in such cases, and where the title has passed from the government to purchasers, the only relief was through special legislation by congress. The amendment offered by Mr. Hermann to-day accomplishes this purpose.

Representative Hermann presented to-day a complaint of the citizens of Newburg, Yamhill county, Oregon, against the recently appointed postmaster at that office, who threatens to remove the post-office beyond the limits of the town, and they vigorously protest against such action.

Secretary Vias has reversed the decision of the commissioner of the general land office in the case of the Northern Pacific Railroad Company vs. Edward R. Leaning and James M. Emery, on appeal by the former. The commissioner's decision held that eighty acres of land in the North Yakima, Washington territory, land district was excepted from the grant to this company. The secretary to-day reversed this reading.
