STATE DISPATCHES.

School Fund Apportionment Made—It Is Unusually Large.—Portland News.

SPECIAL TO THE HERALD. SALEM, July 27.—The school fund apportionment to the various counties of the state has just been made by State Treasurer Webb. It is \$1.25 for every person of school age in the state, 25 cents per capita larger than any distribution ever heretofore made.

In 1886 the total census of school children in the state was \$2,854, and the amount of school fund per capita disbursed was 90 cents. In 1887 the census had swelled to 87,217, and the sum appropriated was one dollar each. Now in 1888 the census is 86,374. The reduction is due to a new law which requires school clerks to certify on oath to the number of scholars in their districts. Appended are the amounts apportioned to the various counties, the number of persons of school age in each district being obtained by dividing the sums opposite each by 14; Baker, \$2206.25; Benton, \$3980; Clackamas, \$6157.50; Clatsop, \$2427.50; Columbia, \$1460; Coos, \$3252.50; Crook, \$1630; Curry, \$773.75; Douglas, \$5075; Gilliam, \$1825; Grant, \$2812.50; Jackson, \$446.25; Josephine, \$1558.75; Klamath, \$90; Lake, \$886.25; Lane, \$5436.25; Linn, \$7016.25; Malheur, \$985; Marion, \$8443.75; Morrow, \$2200; Multnomah, \$15,468.75; Polk, \$3187.50; Tillamook, \$928.75; Umatilla, \$558.25; Union, \$4168.75; Wallowa, \$1732.50; Wasco, \$4258.75; Washington, \$4785; Yamhill, \$4343.75; total, \$108,217.50.

EXPRESS ROBBERS ON TRIAL. PORTLAND, July 27.—This afternoon Anderson and King, the young men charged with robbing the Pacific Express of \$10,000, between this city and Astoria, had a preliminary examination before Justice Tuttle. King made a statement giving details of the robbery, and Anderson waived examination. Both men were held under \$10,000 bonds and were remanded to jail in default of bail. The money has been recovered, having been found where the robbers buried it.

THE RETURNING TEACHERS. Superintendent E. B. McElroy and D. V. S. R. R. who have returned from San Francisco, state that on about August 6th 200 teachers will return over the O. & C. These will either come through on a special train or in parties of forty or fifty. If they come in a body due notice will be given, in order to allow some kind of a reception to be tendered them at the depot. It is not known how long they will stop at Albany, but this as other details will be arranged and made public by Superintendent McElroy.

McVay Caught. Lewis McVay, the man who stabbed his brother, was caught near Junction City Wednesday. Sheriff Mackay received a telegram from there, and procured a warrant and went after him, accompanied by Wayman St. Clair. They brought him back Wednesday. Yesterday he waived examination and was bound over in the sum of \$250, which bond he is rustling to procure.—Benton Leader.

THE OIL CAN EXPLODED. The following item about a lady well known in Lebanon, where she recently resided and has many friends, is from the Home Press, Centerville, Umatilla county: "Wednesday Mrs. Donaca was in the act of starting a fire in her kitchen stove with kerosene, when the vessel containing the oil exploded. Fortunately for the lady the can did not contain much, otherwise she would have been seriously burned, as it was a close call. People cannot be too careful in the use of kerosene."

Mr. Hill is a brother of J. F. Hill, formerly principal of the Albany public schools.

That Opium Smuggler. Concerning the reported appearance of an opium smuggling vessel at Yaquina the Newport News says: In the last issue of the News appeared an item concerning a strange craft, which had lately come into the bay, and which was supposed by many to be a smuggler. This opinion is still entertained by a considerable number while others scout at the idea. The owner of the craft who gives his name as Duocan O'Donald, returned from up the bay a few days ago and called at the News office and stoutly denied being connected in any way with smuggling. In answer to questions he gave the incidents of his trip as follows. His boat which is a sloop 21 feet in length was purchased in the Columbia river, where he fitted her up and laid in a stock of provisions with the intention of going to Alaska. He then had a partner, but owing to the unusual rough weather they waited for five weeks and made several ineffectual attempts before he could get over the bar. In the meantime his partner thinking it too risky, decided to go on so long a trip. After his partner left O'Donald changed his opinion about going to Alaska and decided to sail for Gray's Harbor and prospect for coal. After finally getting clear of the Columbia river, he sailed north, but was unable to enter Gray's Harbor, and again changed his course for Nehalem river expecting to prospect for coal on that stream, but when the mouth of the river was reached he was also unable to enter there, and so continued his course southward and finally brought up at this place. He is still here and is quite anxious to sell his boat, which is indeed a fine staunch little craft and is offered for \$200. He says he is a miner by profession and owns a claim in Shasta county, Cal., where he now wishes to go for the purpose of doing assessment work.

The Santiam Mines.

More interest than ever before is being manifested in the Santiam mines, and their richness and value is beginning to be acknowledged. President John G. Wright of the Salem Capital Mining company, has returned from the scene of the late strike in the Santiam mines. Mr. Wright says the newly discovered vein is nine feet in thickness, and contains quartz whose prominent constituents are gold, silver, lead and iron pyrites. He brought back with him fifty or sixty pounds of ore, which will be sent to Portland to be assayed. The new vein is situated on the south wall of the lead, about 100 feet from the main tunnel. The workmen began on a crosscut from the tunnel along the lead. A meeting of stockholders of the mine will be held two weeks hence, and measures will then be taken for development of the mine.

Agricultural College Scholarships. Many applications are being made for scholarships in the Agricultural College. The law provides one free scholarship for each county, and for each senatorial and representative district as many as there are senators and representatives in the district. The senators and representatives nominate the students and the county superintendent registers their names, and the county court selects by lot the requisite number from those found qualified. The applicants must be residents of the county for which they are selected. In districts composed of more than one county, the senator or representative appoints.
