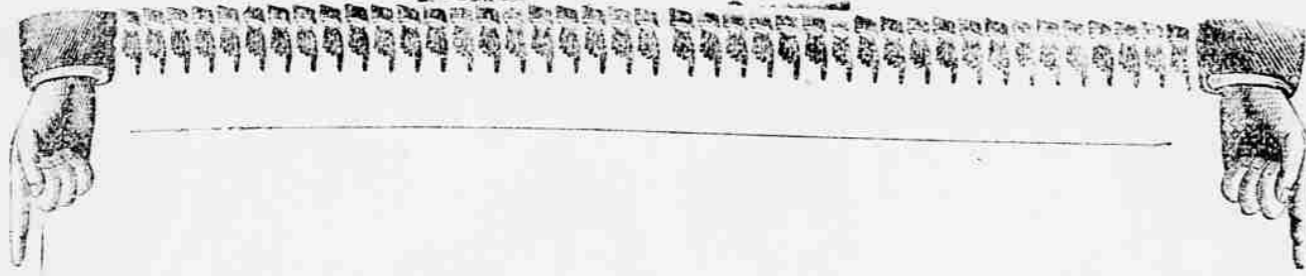

### FOREIGN NEWS

**A Sensation in a London Court Room.**

**ONE THOUSAND PEOPLE DROWNED**

**A Coasting Steamer With Her Crew and Nine Hundred Passengers Swallowed Up in a Cyclone.**

LONDON, Nov. 16.—Proceedings in the Larnell commission today were made interesting by the appearance on the witness stand of Lady Mountmorris, whose husband was murdered at Clonbar, county Galway, in 1880. Lady Mountmorris testified that friendly feelings existed between her husband and his tenants on the Eberhall estate at Clonbar until the land league began holding meetings there. In July, 1880, her husband obtained a writ of ejectment against the tenants. In the following September, while witness was in Scotland, he was shot. She went to Ireland to attend the funeral. She heard men refuse to assist to put the coffin in the hearse. Witness left Eberhall in October. While on her way to the steamer people laughed and hooted at her, and stones were thrown at her eight-year-old son. Her husband received threatening letters only after league meetings had been held. Sir Charles Russell, counsel for Parnell, was proceeding in the cross-examination of Lady Mountmorris as to exact dates of the league meetings added to when the witness faintly and would have fallen to the floor had not a court officer caught her. Sir Charles thereupon intimated that he would not proceed with the cross-examination.

**EATEN BY HOGS.**

**The Fate of Two School Directors in Nebraska.**

OMAHA, November 16.—On Friday last two farmers, Liram Rotter and William Ashley, living in Custer county, called on a neighbor named Hoist-in to see him about some furniture which had disappeared from the schoolhouse in that district. Ashley and Rotter were Directors. They had failed to return on Friday night, and after waiting until Sunday their neighbors became suspicious and instituted a search for them. Yesterday afternoon they saw some hogs eating some object in a hay stack in Hoist-in's field, and going to the spot, found the dead bodies of the two Directors. Rotter's face had been badly eaten by the hogs. Hoist-in cannot be found, and it is believed that he took the team which the men had and left the country.

### THE NEXT HOUSE

**It Will Be Republican by a Small Majority.**

WASHINGTON, November 16.—There is likely to be trouble at the organization of the next House of Representatives. It is going to be comfortably close, and the Democrats are to-day claiming a majority. The Republicans are alarmed and are taking measures to secure certificates for the candidates of that party who claim an election. The Democrats have telegraphed to every district where there is a doubt, and where the difference is small, to have the votes recounted and all the doubtful ones thrown out, which in other words is a hint to use fraud if possible.

The result of the conference between Chairman Quay, Senator Mahone and General Butler at Chamberlain's yesterday is a movement in the courts to secure certificates of election for the Republican candidates for Congress in the State of Virginia, who, the Republicans claim, have been counted out. General Butler will have charge of the legal proceedings, with local attorneys to assist him, and will apply to the United States District Judge in Virginia, who is a Republican, to grant a mandamus requiring the Governor of that State to give certificates to the Republicans. This will bring the ballots into court and result in recounting them. In one of the Maryland districts similar proceedings will be taken by the Republicans who hope to gain two or three members by these means.

### GENERAL NEWS.

**Settlers Want Relief from Unjust Land Rulings.**

**A SON-IN-LAW'S AWFUL CRIME.**

Violating the Inter-State Commerce Law Fatal Quarrel Over a Land Purchase—Other News.

CHAMBERLAIN, (Pa.), Nov. 16.—In February, 1885, President Arthur issued a proclamation relating to the Crow Creek Winnebago reservation being open for settling and a large number of people flocked to the lands. Soon after President Cleveland's inauguration he withdrew the lands from the market and ordered all the settlers off. Many left, but a large number are still living on the land and are circulating a petition, asking that the lands be again thrown open to settlement and that they be allowed to perfect titles.

**AN AWFUL CRIME.**

**A Profligate Merchant Kills His Aged Father-in-Law.**

WALLINGFORD, (Conn.), Nov. 16.—Solon G. Jenkins, formerly a prosperous merchant, but who has gone to the dogs through drink, last night shot and killed his father-in-law, Stephen Anthony, aged 60 years. He threatened all of the family with death. He was locked up. Angry citizens threaten to lynch him.

**THE FREIGHT WAR.**

**The Inter-State Commission Will Take a Hand in It.**

NEW YORK, Nov. 16.—The Herald says: The inter-state commerce commissioners will probably take a hand in the west bound freight rate war and prosecute the roads which have been recently cutting rates in violation of the law. The Pennsylvania company is believed to be the chief offender.

**A WONDERFUL DISCOVERY.**

**A Remarkable Story Concerning a California Myth.**

A gentleman bearing the name of Zimmerman has discovered a well in California which petrifies dogs, cats, babies and fowls in four days. A California paper vouches for the truth of the discovery, and says:

"Preparations are already being made to petrify human bodies, and the knowledge of the fact has cast a gloom over the usually brilliant spirits of the local undertakers, who tried to cast discredit on it.
