AFTER THE TRUSTS.

The decision of Judge Barrett of the Supreme court of New York, on the case of the "sugar trust" that was taken up to that court, and in which the Judge decides that the North River Sugar Refining Company had forfeited its charter by joining the "sugar trust," is the sharpest criticism upon the trust business that has yet been made, and will probably lead to some practical results in shaping legislation and controlling the nefarious business.

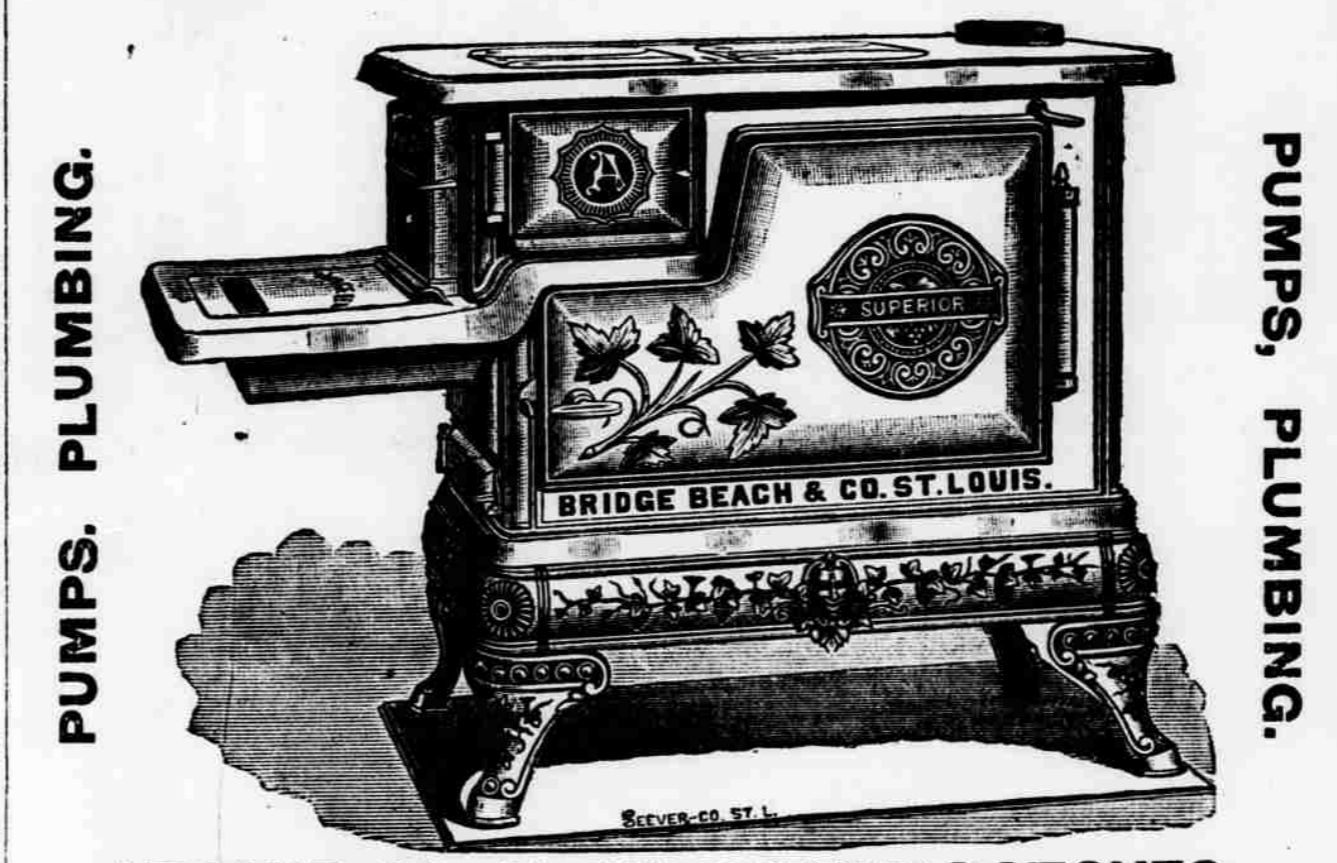
