PISTOLS DRAWN. A. Bold. Bad Man Who Claimed Another Man Winked at His Wife. Yesterday afternoon an altercation occurred between George Cline and Charles Chapman, which nearly resulted in a lively shooting affair. Chapman claimed that Cline had winked at his wife, and wanted to whip him. He followed him about and attempted to assault him. When Cline drew a revolver, Chapman who drew a revolver, had been following Cline and threatened to shoot him, but no shots were fired. Marshal Hoffman gave Chapman notice to leave town within one day. He refused to go and was subsequently arrested on a charge of vagrancy. He fought desperately and had to be placed in irons and gagged, and was finally hauled off to the county jail on a dray. Chapman was intoxicated, being too drunk to undergo examination. It is likely he will be re-arrested on a charge of resisting an officer. Chapman is a gambler and hails from Portland.

How to Make or Renew a Lawn.

There is nothing that tends to add to the beauty of a handsome dwelling, or to give an air of neatness to a less pretentious one, than a beautiful lawn, and scarcely anything that so much outside enjoyment is obtained from the use of it. In making a new lawn see that the land is perfectly drained, either naturally or artificially, then that the ground by carefully graded, sufficient sub-soil always being removed so that at least six inches of good top-soil will overlay the whole; then thoroughly harrow until all stones or roots are removed and the ground is perfectly smoothed and in condition to receive the seed. In small plots, digging, trenching and raking must take the place of the foregoing directions, which are intended for large areas only. Then sow the Cleveland's Emerald Lawn Grass Seed at the rate of at least one quart of seed to a space of 15x20, say 300 square feet, using more seed if so inclined, for the heavier the sowing the better the lawn and quicker the results. If sown any time during April or May a good lawn may be expected in about three months from date of sowing. Always remember that the seed should be "well firmed" or beaten in, either by the back of a spade or garden roller at time of sowing. As soon as the grass is from six to eight inches in height you may run your lawn mower over it, and if continued at intervals of about ten days, your lawn will be in complete order. The above lawn grass seed can be obtained of Wallace, Thompson & Co.

Case of Killing a Cow.

Sometime last September the freight train on the Southern Pacific at Harrisburg ran over a cow at Harrisburg, belonging to J. L. Fuller, injuring it so that it was ordered killed by the section boss. Instead of killing the cow the section boss gave her away to Mr. Frank Pierce, who removed her into the country, and cured her. On that ground and on the claim that the railroads are not responsible for stock killed on public crossing the railroad refused to pay for her, and Mr. Fuller brought suit to recover. The case was tried on Thursday at Harrisburg in Justice Douglas' court, the railroad attorney A. R. Peay of Portland, calling for a jury. Mr. Fuller's case was argued by Hon. J. K. Weatherford, and the result of the trial was a verdict in favor of Mr. Fuller. As the attorney for the railroad called for the jury the case cannot be appealed on their motion.

The Valley Filling Up.

The Oregon Pacific boats, says the Oregonian, are doing a large amount of spring trade on the Upper Willamette. In talking with one of the officials of the company it was learned that there was a decided increase in the demand for general merchandise up the valley over the same period last year. This evidently shows a healthy state of affairs, and a filling up of the country with immigrants.

JOSEF HEINE.

First Appearance in Albany of This Wonderful Blind Violinist.

Seldom is it that any community enjoys the privilege of listening to the genius of melody made familiar by the works of the great masters, under as favorable conditions as will t e music lovers of Albany on Wednesday night next. Josef Heine, whose fame is world wide, who has enjoyed the rare distinction of pouring his torrents of music before princes and potentates of the old world and has received the enraptured plaudits of crowded houses wherever he has appeared, will give his first concert in this city on that night. That the lovers of good music from the "king of musicians" will turn out in full force and show their appreciation of this marvelous genius goes without saying. The Portland papers were unanimous in their praise of the artists, and the following is from the Victoria (B. C.), Colonist: "Seldom in the history of this city has so rich a musical treat been enjoyed by British Columbians as that presented in the Victoria last evening of the great violinist Heine, and his talented wife and daughter. So much has been said of these great artists by the press of every land, that all who attended last evening's concert came expecting a treat. Not only were they fully satisfied with hearing exquisite music exquisitely played, but every sense was enthralled by the mystic melodies of the violin, expressing every feeling of the human heart, with a power greater far than that of words. The violin in the hands of Heine seemed to laugh aloud in very gladness, then murmur in soft plaintive melody, then sob, then weep, rise in the wild, shrill shriek of defiance or the sharp cry of despair, or sink in the gasping groan of death. The instrument seemed itself a thing of life—a part of the blind musician himself, who living in his own sweet realm of sound, has little, if aught, in common with the busy, bustling world. The opening numbers of the programme last evening was Gaubert's "Cheerfulness," sung as a duet by Mrs. and Miss Heine, whose voices blended harmoniously to make their interpretation of the numbers as acceptable as it well could be. Mrs. Heine's next heard in Mendelssohn's Grand Rondo in B minor, a selection which displayed to advantage her brilliancy as a pianiste. Roff's "Cavatina" was chosen by Mr. Heine as his first solo, followed by an original Mazurka, which completely captivated his critical audience. They refused to be satisfied until the blind musician responded with the "Chicken March."

The barnyard imitations in the march were the cause of hearty laughter, and for exact fidelity to nature, as well as musical beauty, could not be surpassed. This was followed by Heine's solo on a tin whistle, in which a medley of popular airs was introduced, with original and very difficult variations. The audience refused to be satisfied until again and yet again they recalled. The old ballad, "Coming Thro' the Rye," by Miss Heine, sung with unusual feeling and beauty, brought the first part of the delightful programme to a close.

Part second was opened by Heine with an original composition; the first part a cradle song, the second a rondo from Concerto in D. In response to an encore he gave an "Elegy," a composition so exquisite in its sadness and pathos that many eyes in the audience were dim with tears. The violin duet, "Nearer, My God, to Thee," by M. and Miss Heine was another grandly beautiful number, while the imitation of the sardian bagpipes, given as an encore, was as enjoyable as it was unique. Heine's burlesque on Italian opera and piano improvisation on three notes whistled by a gentleman in the audience, were both good, and the song, "Home, Sweet Home," by Miss Heine, with violin accompaniment, brought to a close one of the grandest concerts ever given in Victoria.

COAST NOTES.

Salem and Eugene are to have ice works.

The ladies of Jefferson have organized a reading club which for the present meets once in two weeks. The only saloon in Silverton has been closed by the city council refusing to grant a license. A good many Oregonians will participate in the inaugural festivities at Washington next month. Lake county has established the reputation of being the coldest every night in the year, but not damaging to growing grain. Hop raising is an industry which is growing in importance in this state. Many new yards are being planted in the Willamette Valley. The smallpox has invaded Walla Walla. Two cases have appeared there. Every precaution is being taken to prevent its spread. Everything indicates a tremendous rush of immigration to Washington and Oregon during the spring and summer. In consequence the real estate business is expected to boom in all parts of the northwest coast. A mysterious murder was committed in Astoria Wednesday. The victim was Neil Livingston. A woman named Mrs. Ingelston was also wounded in the head, perhaps seriously. The whole affair is under a cloud and will remain so until legally investigated. Hon. W. Lair Hill has located at Seattle. His old home is in Oregon, but he has recently resided in Oakland, California, and the East Portland Vindicator remarks that when Washington becomes a state, if the people don't make him one of their first senators, they will overlook the best talent on the coast. R. C. Michaels, of Brownsville, on Sunday last departed for Weston, Oregon, at which place he assumes the duties of Principal of the State Normal school. Last Sunday afternoon the citizens of Lebanon were startled by the firebell, but before the firemen could get to the engine the "fire" had been put out. It was in the roof of the St. Charles hotel, and might have resulted very seriously if it had not been seen and promptly put out by the porter. The Bank of Lebanon has purchased of McNeil & Urban one of their improved burglar proof safes at a cost of \$1250.
