Adverse Report on the Silk Culture Bill.

BARBED WIRE PATENTS ILLEGAL.

The Myers-McAuliffe Fight—The Sheriff Interferes and It is a Very Tame Boxing Match.

WASHINGTON, Feb. 13.—The committee on agriculture to-day decided to report adversely the bill introduced by Thompson, of California, for the development and encouragement of silk culture in the United States. The bill proposed the creation of silk culture in the department of agriculture and establish experimental silk culture stations throughout the United States.

AN IMPORTANT DISCOVERY.

The American Barbed Wire Patents Found to Be Illegal.

St. Louis, Feb. 13.—An important discovery has been made here that the control of the barbed wire patents are not vested in any American firm or corporation, because a device of barbed wire was patented in France by Louis Janin on April 19, 1865. Under the United States law this invalidates the United States patent, and it is claimed may render the patentees liable for past royalties collected.

THE MYERS-McAULIFFE FIGHT.

The Sheriff Interferes and It is a Tame Affair.

CHICAGO, Feb. 13.—A special to the Chicago Times says that it was reported from North Judson at 6:20 A. M. that Mike McDonald, a well known Chicagoan, was just chosen referee for the Myers-McAuliffe fight. The fight was then expected to begin in a few minutes, but the sheriff unexpectedly appeared and affairs are once more unsettled.

THE FIGHT TAKES PLACE.

NORTH JUDSON, Feb. 13.—A wrangle over McAuliffe's having plastered his hands under his gloves occurred. Finally he was allowed to put them on. At 6:40 two marshals jumped on the platform and informed those present that the fight could not go on. After a long wrangle with the referee and sheriff, it was agreed to allow a boxing match and time was called at 6:58 A. M. The fight was a tame affair. Sixty-four rounds were fought and the fight declared a draw. Myers was very cautious. Neither man appeared anxious to force a fight.

SALEM NEWS.

SALEM, Feb. 13.—Articles of incorporation were filed to-day in the secretary of state's office by the Joseph water works company, E. J. Forsythe, Will Wurzelweyer, F. D. McCully, W. A. Leslie, S. N. McCaw, incorporators. The object is the construction of a system of water works in Joseph, Wallowa county. Capital stock, \$4000.

Surveying Public Lands.

The Oregonian says: Numerous petitions have been forwarded to the general land office asking for surveys for public lands in this state, but although the work has in many cases been ordered advertised no one could be found to undertake it for the remuneration provided for by law. Lately provision for augmented rates for work in places where surveying is very difficult has been made, and now Surveyor General Taylor has been directed to have the survey of T. 35. S. R. W. completed, the work by the approval of the secretary of the interior to be paid for at the increased rates. This township is six miles north of Ellenburg, Curry county, and is the first land to be surveyed under the new regulations.
