#### TEMPERANCE NOTES

Contributed by W. C. T. U.

Joseph Cook in a recent speech on National Prohibition said "that the fiercest foes of prohibition is the organized liquor traffic, because it can concentrate its power in one commonwealth or another according to the exigencies of the moment." He further states "prohibition sentiment must therefore be political and national, but that the great reform must finally be brought about by the power of Christianity. He characterizes the system of high license as an "atrocious fraud, since it robs Peter to pay Paul—and does not after all pay Paul."

According to the statement of "special artists," a very few Senators or members, figure very conspicuously in moral reforms, and when it comes to the temperance question, the Senators who are counted upon are the very few who are openly and avowedly total abstainers. New England leads the van with Senators Bair and Frye ar in arm.

The Legislature appropriated \$250,000 a year for a Refuge Home for women. The home is to be located in Portland and takes the place of the Industrial Home which was established by the W. C. T. U. The new home is to be under the supervision of the State Union, and will be managed by a board made up from the local Unions. Such an institution is greatly needed in the state, and particularly in Portland, and will doubtless be the means of saving many a soul.

A similar home has been established by the W. C. T. U. of our new sister state Washington, and is nearly ready for its formal opening. Already it has two inmates.

This is a difficult enterprise to manage successfully. That it can be done has been demonstrated by the women of Massachusetts, where a Refuge home was established a few years ago, and is now a good management and patient industry made self sustaining.

Miss Henrietta G. Moore one of the National organizers of the W. C. T. U. began work in California the 15th of February. Miss Moore has made a very successful tour of Washington Territory organizing a number of unions. She is an educated and accomplished body and is greatly admired wherever she goes. It is probable that Oregon may engage her when her work in California is finished.

The W. C. T. U. of the first district of Iowa, has filed articles of incorporation with the avowed intention of destroying by all legal means the traffic in intoxicating liquors. The various temperance organizations and municipal authorities of Iowa are taking an active interest in enforcing the prohibitory law and Governor Larrabee is showing a disposition to give them the support of the state government.

D. L. Moody announces that on the 4th day of April he will begin holding in Chicago, a convention of Christian workers. The meetings will continue from thirty to sixty days, and are intended to instruct those who are in the master's service.
