THE WATKINS DAMAGE SUIT.

Grounds on Which He Wants Damages of \$10,528 for Injuries Received.

As has been stated in the columns of the HERALD, the damage suit brought by W. H. Watkins against the Southern Pacific railroad company for an accident which occurred at Lebanon, has been transferred from the state circuit court in this city to the United States circuit court in Portland.

In his complaint Watkins alleges that on the 8th of December of last year he undertook to board the company's train at Lebanon at 5 o'clock in the evening, when at that time of the year it was very dark. At the depot the only means of reaching the train was by treading a narrow plank, which was built two or three feet from the ground.

Owing to a sudden turn in this walk, describing a right angle, the plaintiff, in the darkness, walked off the boards and fell into a ditch, breaking two ribs and otherwise injuring him. It is alleged that the company had supplied no lights by which to illuminate the walk, and that the plaintiff's injuries were the outcome of pure carelessness on the part of defendant.

In consequence of his getting hurt, plaintiff had to pay a doctor bill of \$155, a hospital bill of \$73, and lost two months' time while he could have drawn \$5 per day, or in all \$300. Wherefore he prays for judgment against the defendant for \$10,528 and costs and disbursements.

A 100 yard foot race was run in this city yesterday between John Gregory and Harry Langdon, both Eastern sprinters. The race was won by the latter. It is said some \$2000 was won on the race by Hale Backensto, of this city, the principal loser being a Portland admirer of Gregory. The latter claims a record of 9 3/4, and Langdon 10 seconds. The track in the race yesterday was wet and no time was kept.

Death of Nathan Bond.

Nathan Bond, a well known pioneer of Linn county, died at his home near Knox Butte on Wednesday evening after a protracted illness, at the advanced age of 70 years. He was born in Tennessee and came to Oregon in 1833. He leaves a wife who is very ill, and several children who are well known in Linn county.

Knights of Pallas Supper.

A special meeting of Laurel Lodge No. 7, K. of P., was held last evening, it being the occasion of a visit of Grand Master Hon. W. T. Hume. After the session of the lodge with work in the third degree, an elegant supper was served at the City Restaurant, which was enjoyed by the members and their friends.

The Penitentiary Quarantined.

Since a case of smallpox was developed at the asylum for insane, says the Salem Journal, Superintendent Downing of the penitentiary, has quarantined that institution against visitors. Even while there may be no immediate danger of the disease making itself known there, still it is best to take precautionary measures.

The Medical Board.

The state association of physicians have recommended the appointment of Drs. Cusick, of Salem, Lee of Dallas, and Dolan, of The Dalles, as the board of examiners. Governor Penney has not yet appointed this board, which was created by the Pope bill.

Sudden Death.

Information was received yesterday from Lebanon that Mrs. R. C. McCutley, well known in that place, died suddenly of apoplexy yesterday morning. She leaves a husband and children and a wide circle of friends to mourn her sudden death.

TERRIFIC HAIL STORM.

One of the Severe Ever Experienced in Oregon—Window Lights Broken.

Farmers living in the vicinity of Shedd state that the hail storm which passed over that section Wednesday was one of the most severe ever experienced in Oregon. The storm was heard roaring as it approached for several minutes before the hail began falling. It passed from the southwest to the northeast and extended over a width of about 15 miles.

Hail stones fell fully two inches in diameter, and to some of them long icicles were attached, while others resembled flat sheets of ice. Many window lights were broken and peach trees were stripped of their blossoms. It is thought, however, that the most of the fruit trees were not sufficiently advanced to receive material injury.

At Lebanon the storm was also severe, and the hail fell to the depth of several inches, breaking out window lights. Stock suffered considerably, but no material damage is reported.

A Fire Alarm.

Shortly before noon yesterday smoke was observed pouring from the city jail. A fire alarm quickly sounded, to which the fire department promptly responded. The door of the jail was broken in and the firemen rushed in to rescue two prisoners who were inside and were supposed to be suffocating. It was found that the two tramps had built a big fire in the stove and had piled up wood against the stove on the outside, which was in a fair way to envelop the jail in flames. The two men were curled up in a corner in a drunken stupor and when aroused exclaimed, "People, what is the excitement, can you give us a cigarette?" The fire was put out and the two tramps resumed their nap.

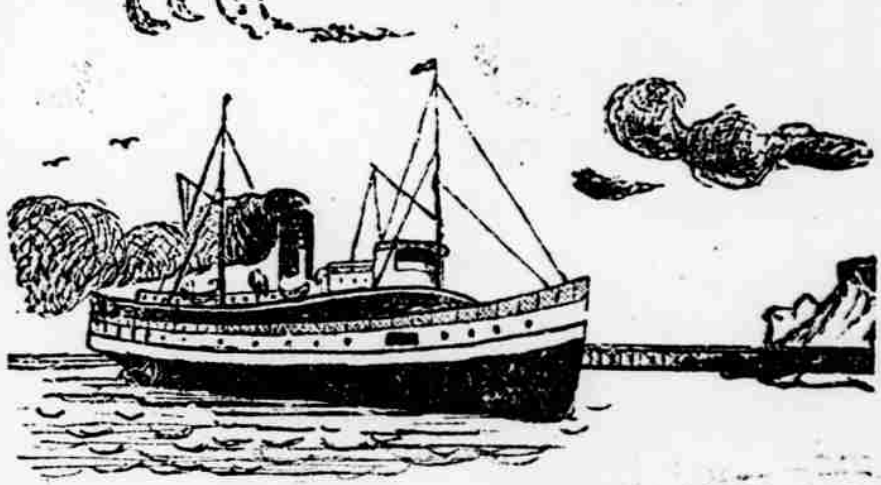

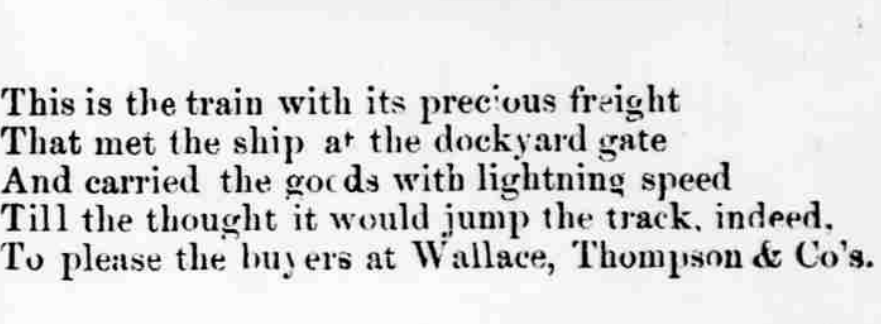
