AMIENT AMERICA.

Discoveries by an Explorer in Yucatan.

Dr. Le Plongeon, the Central American explorer, declares that he has indisputable evidence that the history of our country, North America, began 110 centuries ago, says a writer in the Utica Herald.

In the Mayas of Yucatan he finds all that remains of the early inhabitants, and evidence, including manuscripts, that the language is the oldest living tongue in the world.

The history of the Creation, the Deluge and other great epochs are before the reader of this ancient tongue. In many respects it is identical with the ancient Persian, and the Sanskrit roots frequently appear. The story of Atlantis is also found. The doctor's collection embraces seventy seven stereoscopic plates and twenty terra cotta models, illustrating houses, ruins, palaces, observatories and other archaeological remains of great interest.

Although the keystone arch is not found in these ruins, the buildings are several of them domed over. The frescoes show art superior to that of ancient Egypt. There are 300 casts of the inscriptions also in the collection and plans of the royal buildings at Chichen-Itza. One of the royal residences was found to contain 120 rooms. These collections, it is hoped, will find a permanent place in some of our museums.

GENERAL NEWS.

The Will of the Late Mrs. Ben Holladay.

A FIFTH STREET CAR RIOT.

The Oklahoma Territory Abate With Excitement—A Brave Woman Lighthouse Keeper.

PORTLAND, April 6.—The will of the late Mrs. Esther Holladay, widow of Ben Holladay, was filed for probate in the county court this afternoon. The document was signed by the deceased on the 20th of October, 1887, and witnessed by John H. Mitchell and James O'Meara. The text of the will is substantially as follows: "I desire that my body shall receive decent burial, and that my last resting place be marked by a stone suited to my station in life. I give and bequeath all my estate and effects unto my personal friend, General Rufus Ingalls, upon trust, or the benefit of my two dear beloved children, Benjamin Campbell Holladay and Linda Holladay, share and share alike. All monies or real estate accruing from the sale of any part of said estate shall be paid over to the guardian of my children. I hereby nominate my personal friend General Rufus Ingalls sole executor of my last will. I also appoint General Rufus Ingalls guardian of the persons and estates of my two children, with full power to manage and control their persons and estates until they attain the age of 21 years respectively. And in the event of general Ingalls' death, refusal or incapacity to act as such guardian, then it is my will that James Steele Esq., shall assume such responsibility." The will is a very ponderous document, but the above is the gist of it. The nomination of Gen. Ingalls as executor of the estate will most likely act on Joe Holladay as a red shawl shaken into his face. The two men have been at swords points for a long time, and the litigation over the Holladay estate is almost coincident with a contest.

"VIVE LA BOLLANGER."

A Shout Goes Up in Paris by His Sympathizers.

PARIS, April 6.—The correctional tribunal today acquitted Senator Naquet and Deputy Laguerre, Lascant and Turquet and Paul de Roullet Ledero, of the League of Patriots, and two other members of that organization of the charge of belonging to a secret society, but imposed a fine of 100 francs for belonging to a society not authorized by law. The crowd outside the court room received the announcement of the result with cries of "Vive la League," "Vive la Boulanger" and "Vive la Roullet."

BRAVE WOMAN.

She Keeps a Lighthouse and Has Saved Many Lives.

NEWPORT, April 6.—Mrs. Wilson, the widow of John Byher, whose maiden name was Ida Lewis, added another yesterday to a long list of lives saved by her. Her uncle, Henry Lewis, 70 years of age, while returning from fishing in a small skiff, fell overboard in the harbor near Lime Rock lighthouse, of which she is keeper. She saw the accident, put out in a boat and rescued him in an exhausted condition.

THE RIGHT ROSE MOVEMENT.

A Monster Demonstration to Be Held on July Fourth.

CHICAGO, April 6.—The work recently undertaken by the eight hour day advocates for a monster demonstration over the country on July 4th in support of the movement to inaugurate the eight hour system on May 1, 1890, is progressing favorably in Chicago. A movement is on foot for the purpose of obtaining for distribution on July 4th, the general opinion of the leading citizens of the United States on the subject.

STREET CAR RIOT.

The Strike in Rochester Results in a Fierce Fight.

ROCHESTER, N. Y.—The street car strike has resulted in a riot. While the factory employes were enjoying the noon hour a mob attacked some cars, smashed windows, and one or two shots were fired. Police finally dispersed the mob and arrested twenty-five persons.

THOUSANDS OF BOOMERS.

The Oklahoma Territory Abate With Excitement.

TOPKA, April 6.—The members of the state board of railroad assessors have just returned from a trip through Oklahoma, and report the army officers as saying that thousands of boomers are still coming in a rush, and that if the whole United States army were there it could not drive them out. The names are taken, but nine out of ten are fictitious. Capt. Woodson and Lieutenant Carson are in reception of telegrams daily to hire horses, have them saddled and bring them in on the arrival of the trains at Oklahoma City April 22d at noon. AT WASHINGTON.

The Policy of President Harrison Outlined.

SEVERAL APPOINTMENTS MADE.

Orville T. Porter, of Albany, to be U. S. Marshal of Alaska.—The Courtmartial of Major Amos.

WASHINGTON, April 6.—It has been stated that P. Mahoney, of San Francisco, has been recommended by the California delegation for the position of marshal of Alaska. This is an error, however. The name of Orville T. Porter, of Albany, Oregon, has been submitted to the president for the Alaskan marshalship. Mr. Porter has the endorsement of the entire Pacific coast delegation for the position.

Applications for appointments in the consular service will not be encouraged by the fact that the entire number of consuls to whom salaries are paid is only 118. Of these 22 are consuls-general whose salaries vary from \$3000 to \$6000 per annum. There are six classes of consuls exclusive of consuls general, the highest class receiving \$3500 per annum and the lowest \$1500. There are but seven in the highest class, of which six are in China and one in Peru. The \$3000 per annum class numbers 18; the \$2500 class, 26; and the \$2000, 51. The remainder are in the two classes that pay respectively \$1500 and \$1000 per annum. One who knows that the supply is about equal to one for every 100 applicants who are supported by various influences, will appreciate how slight the chances are for success.

ANOTHER APPOINTMENT.

WASHINGTON, April 6.—W. H. McGeris of Ohio, has been appointed superintendent of the Railway Mail service, and assigned to duty in the office of second assistant Postmaster General.

A COURT MARSHAL ORDERED.

WASHINGTON, April 6.—Acting upon recommendation of the secretary of War, the President has ordered a court-marshal, for trial of Major George A. Ames, retired, upon charges of conduct unbecoming an officer and gentleman.

PRESIDENT HARRISON'S POLICY.

CHICAGO, April 6.—A reliable Washington correspondent sends his paper a long story of what is believed to be the nearly official statement of the future policy of Harrison's administration. He declares that the internal policy will not be materially changed but that vigorous foreign policy will be pursued. First thing will be to make a strong navy. To this end appropriations for navy will be doubled. Ocean commerce will be encouraged. Cuba and Samoa will be absorbed as they are of more vital importance to the United States than to any one else. The Nicaragua canal will be taken under our protection and the general extremities of the nation will be looked after as the most necessary thing now to be considered for future welfare.

JELTED WASHINGTON.

A Virginia Girl ... Or Her Way & Golden Opportunity.

George Washington was once a rejected lover. The fact is testified to by his own hand in a letter given to the world a few years ago by General Fitzhugh Lee, General Lee, writing to the editor of a Virginia paper about the matter, said:

"At the request of many persons I send you and thus permit the publication of the inclosed letter. It is, as you see, from General Washington, written over 120 years ago, and is addressed to William Fastolov Sr., in Richmond, the brother of Miss Betsy, referred to so tenderly. I think it reveals an affair of court on the part of the 'Father of his Country' (for it is not said that he was the father of anything or anybody else) not heretofore known.
