GENERAL NEWS.

Loss of a Vessel Causes Great Excitement in New York.

NEARLY 700 SOILS ON BOARD.

Street Car Men on a Strike The Construction of a U. S. Cruiser at San Francisco—Foreign News.

The Herald's Special Dispatches.

New York, April 12.—The great excitement prevails in shipping circles over the loss of the Denmark. The Trinivilla is probably the largest carrying immigrant line that plies between this port and Europe. The Denmark had on board when she left Copenhagen for New York on the 20th of March 650 passengers, presumably all emigrants, including the vessel's captain, R. M. Kundersen, and crew which numbered 40 men. The office of the agents of the steamer Funck, Edge & Co., No. 22, South William street, has been thronged with people all morning anxiously inquiring for the latest news of the vessel.

Mr. Edge, of the firm, does not credit the report. He has cabled his London agents and has sought by wire further particulars from the Copenhagen branch of the firm.

Boulanger's Trial.

PARIS, April 12.—The senate met today for the trial of Boulanger, Count Dillon and Rochefort. Procureur General Quesnay De Beaupre read the statement of sending for grounds upon which the prosecution was based. The senate then went into secret session and the trial was formally begun.

AT THE CAPITAL.

Report on the Agricultural Experiment Station.

WASHINGTON, April 9.—Secretary Rusk has issued a pamphlet giving a history of the agricultural experiment stations which have been established under the recent law of Congress and are now conducting scientific and practical experiments in regard to soil tilling, manufactures, crops, stock feeding, dairying and horticulture in various States. All the States and one Territory, Dakota, now have agricultural experiment stations. The total number of stations now in operation is forty, and including branch stations nearly sixty. They employ more than 370 scientists and agriculturists, and will this year receive \$595,000 from the National Government and about \$125,000 from the State and other sources. The most cordial feeling is said to exist between the stations and the Department of Agriculture, which is charged by Congress with the duty of supervising and aiding the work of the stations.

It is understood that the new Sioux Commission will consist of William Warner of Missouri, Charles Foster of Ohio, John B. King of Nebraska, Major-General Crook and a Democrat member not yet decided upon from Pennsylvania.

Secretary Halford said this evening that the President had made no arrangements to leave Washington before the 19th of this month, when he goes to New York to attend the centennial celebration.

PENDLETON, Or., April 11.—At about 11:30 o'clock last night fire broke out in the East Oregonian building on Webb street. The fire department, because of inability to locate the precise spot where the fire was burning, turned water in at a guess, where the smoke was thickest, and the type and material were badly damaged.

The fire originated in a room in the basement to the rear of the composing room, which is occupied as a sleeping room. W. H. Mills, an employe of the office, who also has a room in the basement to the rear of the press room, was first to discover it. Before he could get out, being a cripple, he was almost suffocated.

The fire must have been burning for some time before it was discovered, as the room in which it originated is completely gutted. The publication of the paper will be continued without interruption.

There was insurance on the type and material. The presses were not injured.

The store room occupied by Mims Bros. & Co. as a musical instrument and sewing machine depot sustained considerable injury and the instruments and machines are damaged by water.

CALLED A HALL.

Action Against Montana Timber Land Trespassers Suspended.

WASHINGTON, April 11.—Secretary Noble, in a letter to the attorney general, has requested that the United States attorney for Montana be directed to suspend action, civil or criminal, against the Montana Company, formerly the Montana Improvement Company, and the Northern Pacific railroad, for timber trespass on the public lands in Montana until the same can be investigated with a view to a dismissal as recommended by the United States district attorney. The amount of lumber involved is over 40,000,000 feet, besides a large amount of cordwood and railroad ties. This action is taken, it is understood, upon information that it will be extremely difficult for the government at this late day to secure sufficient evidence to maintain these suits.

LIVED IN SLAVERY.

The Unfortunate Career of an Alabama Man.

Fifty miles from this city, in Lowndes county, there lives a white man whose life history reads like a chapter of genuine romance. His name is George Johnson, and he was a slave before the war. From force of circumstances he associated with negroes and married a negro woman. He was brought to this State by slave traders in his early childhood and sold to an old gentleman named Johnson, who lived on a splendid prairie plantation in Lowndes county, and owned several hundred slaves. Johnson remembers little or nothing about his early history before he fell into the hands of the slave traders. He was picked up in Virginia by the Carolinas, brought to Alabama and sold. He became a favorite with his master, who was very kind to him and gave him unusual privileges and advantages. After the war he married a full-blooded negro woman, and they have lived happily together and raised a family of children. Of course Johnson has never been recognized on grounds of social equality because of his unfortunate life and associations, but he is universally respected as an upright man and a useful citizen. He is sober and industrious and a man of good average intelligence. He owns a farm now and has a neat and comfortable home. His white skin and honest intelligent face attracted much attention among those who are not familiar with his life history. He has adapted himself to the surroundings and seems perfectly happy and contented.
