BIRD'S EYE VIEW OF ALBANY.

An Artist Now Here Engaged in This Work—Some Fine Views Forthcoming.

In a short time the DAILY HERALD will issue a supplement a fine bird's eye view of Albany and surrounding country, together with views of public buildings and residences. The Elliott Publishing Company, of San Francisco, is now arranging for publishing this work, which will be prepared and issued in the best manner possible, both as an advertising medium and as a work of art. Mr. B. W. Pierce, a well known artist of San Francisco, is now in the city and commenced yesterday upon the work sketching the bird's eye view. Mr. A. M. Freeman has been in the city for some time making the canvass for this purpose.

The size of the whole picture will be 19x24 inches, and will be the best view of Albany ever published. In addition to the supplement issued by the HERALD other copies will be distributed by the several live real estate firms of the city, making the first edition not less than 5000 copies. The central view will represent every street, block and house and a large extent of outlying country, showing orchards, roads, railroad lines, etc. Names of all the streets will appear on the view. Descriptive matter of Albany will be printed in connection with the view, and all the principal points and buildings will be indexed. To raise the full amount of money necessary for the success of this enterprise, the Elliott Publishing Company will make and sell margin views around the central view of the city; and every business man and owner of a fine building or private residence, should have his property represented and thereby assist in an enterprise that will certainly prove a benefit to the city.

Bridge Matters.

The county courts of Linn and Marion counties met at Jefferson Saturday and considered the matter of the petitions for bridges at that place and at Stayton. After discussing the matter thoroughly it was decided to consider the claims of Stayton first, as they did not think the two counties are able to build both bridges this year, and Stayton was the first point that formally petitioned for a bridge. A competent man will go to Stayton and look over the ground and make an estimate of the cost of a substantial bridge at that point. After his report has been heard, then the two counties may advertise for bids, if the estimated cost is not too high, and if a satisfactory contract can be made, the bridge may be built this year. The representatives of both counties recognized the need of a bridge at Jefferson, and will no doubt move definitely in the matter next year.

The Woolen Mills.

J. M. Moyer and J. P. Galbraith, of the Brownsville woolen mills, are in the city. They state that as soon as the plans for the new woolen mills buildings are finished contracts will be advertised for and the work of the woolen mills commenced. The new machinery already received, a portion of the Brownsville plant and a large amount of new machinery yet to be received will constitute the plant.

Peculiar Horse Disease.

R. E. Darsey, of Newsum creek, informs us he has lost sixteen head of horses during the past winter from a peculiar disease, which has been hitherto unknown in this section. The horses are afflicted with a swelling about the eyes, then the limbs become stiff and in a few days they generally die. Very few of the horses afflicted with the disease recover, and medicine appears to have little or no effect upon them. The disease seems to be confined to the immediate vicinity of Newsum creek, and it is not thought to be contagious.—Ochoco Review.

The Washington Street Grade.

In the injunction suit pending against the city concerning the grading of Washington street a motion was made and argued yesterday in Judge Boise's court in Salem, asking that an order be made to allow the city to give bonds for damages and continue the work of grading Washington and the intersecting portion of Second street. Affidavits were presented and the motion was argued at length. The court overruled the motion which leaves the case in statu quo, to be tried at the June term of court.

A PRISONER'S ESCAPE.

John Erkes Escapes Jail and in Escaping Falls 25 Feet from the O. P. Trestle.

Yesterday morning when the Oregon Pacific train passed over the bridge across the Willamette at this city a man was found lying beneath the trestle on the opposite side of the river. He was found to be alive and was picked up and brought to this city, being taken to the Russ House.

He was at once recognized as John Erkes, who has been confined in jail to await trial for assaulting J. H. Haney with an upholsterer's needle. Sheriff Smallmon supposed that he was safe in his cell and was surprised to find that he had escaped from jail Sunday evening, and on attempting to cross the Willamette on the Oregon Pacific railroad bridge, fell from the trestle work on the opposite side. He had fallen a distance of 25 feet and had evidently lain all night in the rain. Dr. J. P. Wallace and Dr. G. W. Maston were called and examined him, when it was found that no bones were broken, but he was in a sad plight, and his chances for recovery are small.

Sheriff Smallmon states that since his incarceration Erkes has appeared to be somewhat deranged in mind. He thinks that either as he was locking the cells Sunday night or replenishing the fire the prisoner stepped into the hall in the darkness without being missed and afterwards escaped. Erkes is a Swede; is an upholsterer by trade and came here from San Francisco, having stopped a few days at Ashland. He was conveyed back to the jail where all was done that could be to make him comfortable, but his condition is such that it is doubtful if he recovers.

ESTATE DISPATCHES.

Suit Over Canham Water Power—Accident in a Saw Mill at Salem.

PORTLAND, April 22.—In United States district court to day the suit of the Salem Capital Flouring Mills Co. against the stayton Water Ditch and Canal Co. was taken up for final hearing. The suit was brought by the Salem company to compel the Stayton company, represented by Mr. Silas Jones, to vacate a certain ditch which was dug away back in the 60's to convey water from the Santiam river to Salem, a distance of over twenty miles. The ditch was originally built by Drury Stayton, a pioneer, and transferred to the Salem company. Afterwards the same ditch was deepened, widened and extended, but not until it had diverted from the ownership of the Salem company. The water power derived from this ditch is very valuable, as at the little village of Stayton there is a half mile of power front which is said to be superior to any in the entire county. If the Salem company can secure entire control of the ditch and own the present owners, they can then hold the manufacturers of the little town of Stayton at their mercy and exact whatever tribute they desire. The suit will doubtless be decided in a short time, as the final arguments were being made this afternoon.

So serious is the case that Dr. Patterson advised the removal of Mrs. Miller to her father's home, and they all left for Eugene on last evening's train, accompanied by Col. Alley, brother-in-law of the afflicted lady. Mrs. Miller's husband is confined to his bed with fever, and therefore unable to go with his wife. Mrs. Miller is a daughter of Jos. Gray of Eugene.

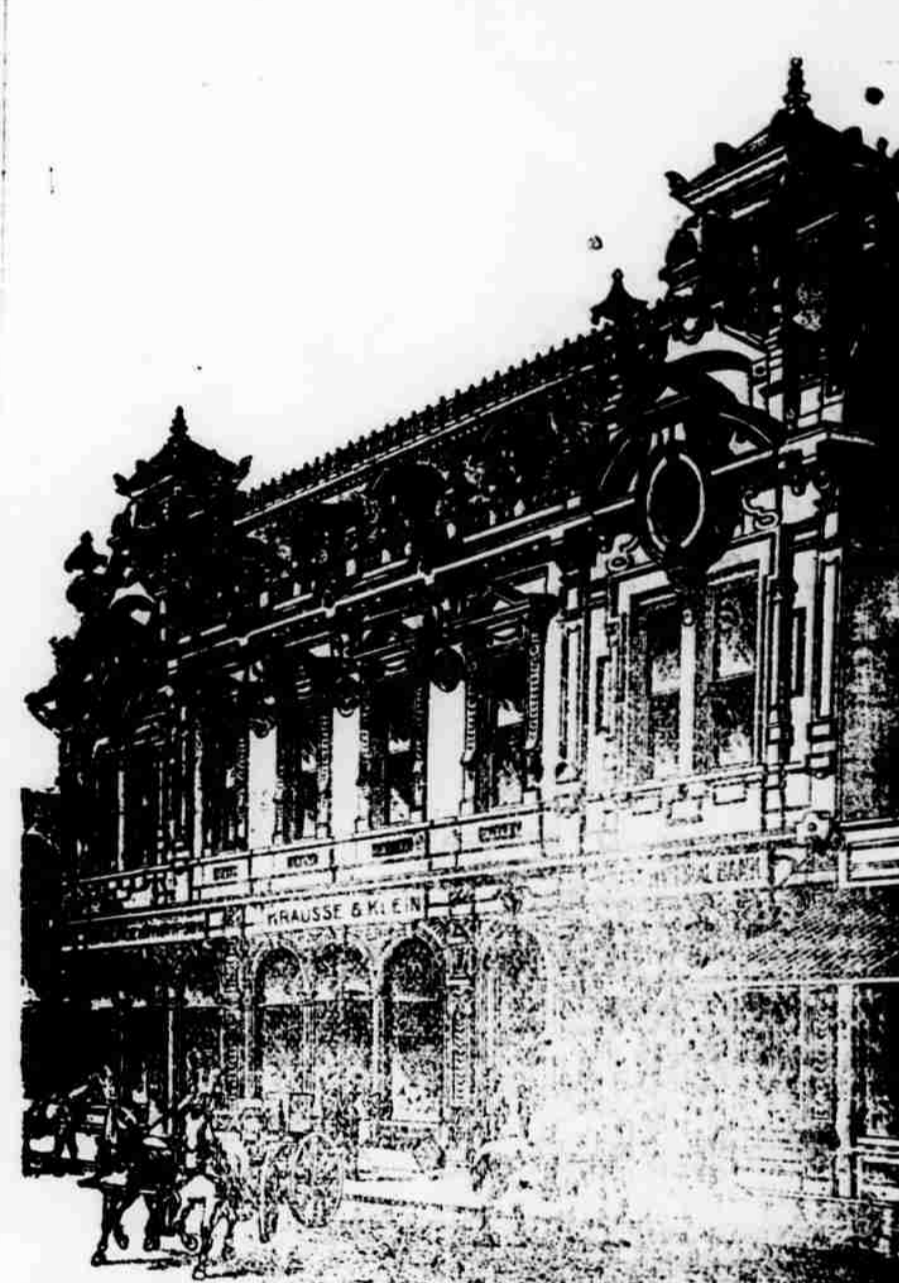

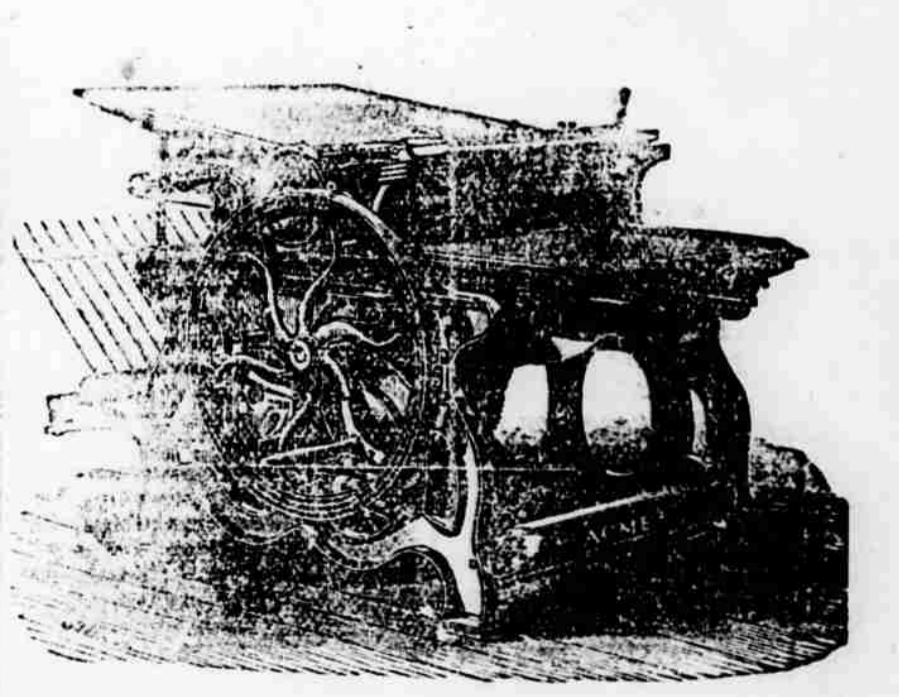
