every question even when President Cleveland fired off his blank cartridge just before the last election. Americans who stopped to think over the matter saw at once that the money value of all the property involved in the dispute would not pay the expenses of a single week of war, and they were unable to see that there was any studied purpose on the part of either England or Canada to insult or dishonor the United States; consequently there did not seem to be any sufficient reason for war, for wars come either on account of money questions or because a nation's honor has been assailed and reparation refused.

To do nothing is clearly the best policy of both nations at the present time. The agreement with Canada is ample to prevent any serious friction or trouble on the Atlantic side, and the proclamation puts every one on his guard in Behring sea, so there is no real necessity for action at the present time. A little later, when all hard feelings shall have subsided and public attention is turned to something else, it will be wise and proper to go into a convention of arbitration upon the disputed points and to have them settled once and forever. We shall sacrifice nothing of our national dignity or self-respect by consenting to such a convention, and it may set an example which other nations may follow, and which will save millions of lives which might otherwise be sacrificed in war.

An uncommon event last week was the severe thunder, rain and hail storm in Jackson county on the night of the 9th. A cloud burst occurred which did considerable damage in sections of the country between Grants Pass and Ashland. Through Wagner creek valley the most damage occurred. About Talent grain was flattened and ruined and many orchards had their fruit injured. It is estimated that the "cloud burst" caused a loss of nearly \$20,000.
