The old gentleman is about sixty years of age and was returning home from a two months visit among friends in Missouri and Kansas. At the Portland west side depot while purchasing a ticket for Corvallis he was accosted by a fine looking young man with the customary "How-do-do," and asked if his name was Mr. Bogue from near Corvallis. "Yes sir," was the reply. The confidence culprit informed the old gentleman that he resided there also and mentioned the names a few of our citizens which were familiar to Mr. Bogue.
