Made \$20,000.

An example of the rapid advance in the price of Albany real estate was shown in the sale of a piece of First street property yesterday.

Last January J. J. Graham bought of Cherry & Parks 200 feet front on First street, in the block where their foundry stands, paying for it \$2,500. Yesterday he sold to J. V. Pipe 66 feet of the same on the east side of the block for \$9,000. He has left 134 feet, for which he has been offered \$17,500, and for which he would not take less than \$20,000. This on a \$250 investment in less than a year is making money very rapidly. Mr. Graham will now erect a brick building upon his corner and Mr. Pipe will probably do the same.

State Agricultural Board.

The annual meeting of the state agricultural board at Salem Wednesday arranged a speed programme for the next year and premium lists for the fair of 1891.

The officers elected for the ensuing year were as follows: President, D. H. Looney; vice-president, William Galloway; secretary, J. T. Gregg; treasurer, A. Bush; chief marshal, John Q. Wilson; superintendent of the pavilion, E. M. Waite.

The Gymnasium.

It is said that all the money appropriated by the regents of the State University at their meeting last June for the purpose of erecting and fitting up a gymnasium hall in connection with the University has been expended on the building and nothing is left with which to furnish the rooms. No more can be obtained until the regents meet again, which will probably not be until next June.

EVERY STATEMENT TRUE.

For Enterprise Albany Leads all Competitors—Some Facts of Interest

Alluding to the advertisement which has been inserted in the Daily Oregonian by the citizens of Albany, the Salem Statesman makes the following editorial comment: "An Albany real estate firm advertises in the Oregonian that the Albany & Astoria railroad is now in course of construction; that Albany has a street railway system; the most complete electric light works in the state, its dynamos furnishing more lights than all the other cities of the valley combined; that the largest and best woolen mills in the state are being built; and that she gets her water supply direct from the Cascade mountains. Not one of these statements is true. The Salem electric light works are sufficient to supply a half dozen such towns as Albany."

The above clipping being shown to the writer of the advertisement he was asked his opinion of it and his answer was as follows: "I am ready," said he, "to back up every assertion made in the advertisement as being true."

For many years Salem claimed the honor of being the leading city of the Willamette Valley; that was years ago, and times have changed since then. Albany now holds that honored position and I am not surprised to see the envious feeling exhibited by Salem's leading paper. Let us see if every assertion made in the above article is false, as is claimed by the Statesman.

"First, that the Albany & Astoria railroad is in course of construction. Well, isn't it? The first step in the building of any railroad is the surveying of the route over which the road is to be constructed. That has been done, as last fall over \$6000 was paid for surveying the road between here and Tillamook, and the same surveyors are now running a line from Astoria to join the former. And more than \$13,000 worth of material, or a sufficient amount for 1000 graders, has been purchased and shipped to Albany ready for work next spring. Isn't that putting it fair to say that the road is in course of construction? I know it rubs a little close to say Albany have two direct communications to the sea, but it will have them nevertheless."

"The second assertion is that Albany has no street railway system. That needs but little consideration. Last fall several gentlemen met and considered the practicability of building a street railway, and the result was that in less than four hours after starting out to solicit stock the necessary amount, \$16,000, was raised, and over one mile of road has been built, over which the best made cars in the state, manufactured in Albany, are making regular trips, and the stock commands a premium."

The third proposition is that the largest and best woolen mills in the state are being built. I am no woolen mill man and hence must take the word of those who are. Mr. Lawler, the foreman of the finishing department, says that he has worked in ten of the leading mills of the United States, and that the machinery employed in here is the latest improved, and finest he has ever seen. There is no use getting angry just because the Salem mills, made of wood, will only make a good storage room for the wool to be used in our splendid brick structures."

"The fourth proposition is that she does not get her water supply direct from the Cascade mountains into and all over Albany, furnishing to inhabitants the purest water to use, and giving Albany its unequalled water power, which will eventually make it the leading manufacturing center of the Pacific coast."

"The fifth and last is that the electric dynamos are furnishing more light than all the other Willamette Valley cities combined. This last assertion does seem a little strong, but figures never lie, and here is my proof, so simple that any school child can understand it."

"Salem has two 30 arc light dynamos of 2000 candle power each, or equal to 120,000 candles, and one 200 light Heisler dynamo of 30 candle power, equal to 9000 candles, or a total of 129,000 candles. Engene City has one 300 light dynamo of 20 candle power, equal to 9000 candles, and one 160 light dynamo of 20 candle power, equal to 4800 candles, or a total of 13,800 candles. Corvallis has one 500 light dynamo of 16 candle power, equal to 8000 candles. These three cities combined then have a grand total of 140,800 candles."

"Against this Albany has two 30 arc light dynamos of 2000 candle power. These dynamos are, however, being run to their greatest capacity and are furnishing 37 lights each, or 148,000 candles, and one Heisler 165 light dynamo of 30 candle power, equal to 4950 candles, or a grand total of 152,950 candles. Thus it will be seen that Albany's candle-light by electricity is equal to Salem, Corvallis and Engene combined and has 12,150 lights to spare. Albany and Salem are also, I understand, putting in a third dynamo for which, in Albany, the electrician has one month's wiring ahead."

"I think that any conservative, fair-minded reader will admit that I have fully proven every assertion which was claimed to be false, and will await the pleasure of any other writer who may attempt to dispute any part of the advertisement, which only partly shows the rapid prosperity of this beautiful city."

A Subsidy For the \$50,000 Paper Mill Raised—The People Jubilant.

LEBANON, Nov. 21.—The subscription of \$5000 to secure the \$50,000 paper mill was raised this afternoon. This secures one of the leading industries of our growing town. The citizens are jubilant over the result, and a rousing meeting was held this evening at Union hall to ratify the grand enterprise, at which many of the leading citizens made addresses. Great credit is due the committee for energy in procuring the subsidy required.

The Oregonian Advertisement.

Considerable feeling has been exhibited in this city during the past few days over the location of the quarter-page advertisement placed by the citizens of Albany in the Oregonian. It was so connected with an advertisement of Curran & Monteith as to give the latter firm the benefit of the whole business, and did an injustice to the citizens who paid for the quarter-page. Mr. E. G. Jones, of the Oregonian, came up last evening to adjust the trouble. The matter was discussed at a citizens' meeting last night, and conclusions were reached which will no doubt result in a settlement of the difficulty. The citizens of Albany simply objected to having their advertisement swallowed up by the real estate ad, which was backed on to it and raised a vigorous "kick." Mr. Jones assured the citizens that the Oregonian desired to treat Albany fairly, and it agreed that the two advertisements should not again appear together.
