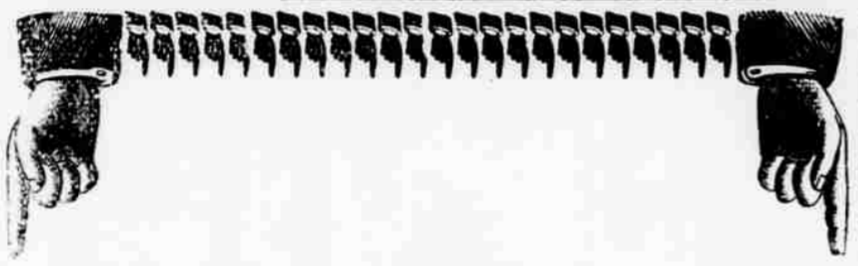

BURNED TO DEATH.

An Insane Asylum Burned Down in Idaho.

SEVERAL INMATES PERISH.

The Situation Unchanged in the Mactaza Legislature—The Crisis Trial—Eastern News Items

BLACKFOOT, Idaho, Nov. 25.—The territorial asylum was burned this morning. Fifty-two of the inmates were saved. Two women and two men are known to have perished, and four are yet missing, supposed to have been burned. The building was partially destroyed, the contents totally destroyed. Loss, \$300,000.

THE CRONIN TRIAL.

The Great Case Still Dragging Its Weary Length.

CHICAGO, Nov. 25.—When the Cronin case was called this morning, Milkman Werth, who had testified for the defense and was recalled by the defense and went over his testimony again. He also testified as to the conversation with the policeman a day or so after the body was discovered. The witness told the officer that he had seen a horse with a white face stop in front of the Carlson cottage and a tall man get out and go into the cottage. He admitted that he told the officer that he did not know what day he saw the horse and buggy drive up. J. W. Fralick was employed by Defendant Kunze from April 26 until June 29, the day of his arrest. He said Kunze worked as usual May 4. The testimony of several witnesses was then taken to contradict the evidence given by Carlson to the effect that at a certain time on March 19 he heard Burke tell Sullivan that he had rented the cottage. The testimony was to the effect that Sullivan was several miles from Lake View at the time mentioned.

IN MONTANA

The Dead Lock in the Legislature Remains Unbroken.

HELENA, Mont., Nov. 25.—There was no change this morning. The Senate met at 8 o'clock, but only eight were present. A recess was taken until 2 o'clock. The democratic lower house met with 28 present. Representative Hunter, of Deer Lodge county, was sworn in. All the officers took the oath of office. The republican lower house meets this afternoon.

A DISGRACE TO THE NAVY.

Judge Thurman's Daughter Cruelly Neglected by Her Husband.

SAN DIEGO, Nov. 24.—It appears that the subject of Judge Thurman's daughter in commencing divorce proceedings in San Diego against her husband, Lieutenant W. S. Cowles, was to avoid notoriety. Mrs. Cowles claims to entertain no animosity against her husband, and although much more serious charges could have been made, she only named that of neglect in the complaint, hoping to do him no injury in the government service. Lieutenant Cowles was summoned to San Diego but did not appear, and admitted all the charges set forth in the complaint. Mrs. Cowles stated on the witness stand that six weeks after marriage she went to Long Beach with Lieutenant Cowles from Washington and remained there several weeks, when the lieutenant left suddenly. Two days later she was about to return to Washington and was informed she couldn't go till her hotel bill and that of her husband's was paid. She was compelled to wait till she could write to her mother and get the money with which to settle the bill. She afterwards made a trip around the world with the lieutenant, who was stationed some time at Shanghai, China. During that time she was neglected in the most humiliating manner. She also stated on the witness stand that Cowles had not contributed one cent to her support since their wedding day. He has not lived with her for six years and she has seen him but once or twice in that time. The lieutenant's own sister was a witness for Mrs. Cowles in the case.

THE NEW NAVY.

What Has Been Accomplished in a Year.

THE U. S. NAVY OF TO-DAY.

An Estimate of Expenses for the Next Twelve Months—Satisfactory Progress in New Vessels.

WASHINGTON, Nov. 24.—Theodore Wilson, chief of the Bureau of Construction and Repairs, has submitted to the Secretary of the Treasury a voluminous report on the operations conducted under the supervision of the bureau during the year ended June 30, 1889, and his estimate for the coming fiscal year ending June 30, 1890.

The latter includes salaries in the bureau, \$21,520; the preservation and completion of vessels on the stocks, the purchase of materials and stores of all kinds, labor in the navy yards, etc., \$1,000,000; clerks, etc., in the navy yards, \$12,972; the improvement of the plant at the New York navy yard, \$25,000; Norfolk navy yard, \$50,000; Mare Island yard, San Francisco, \$75,000; on account of hulls and outfits of new ships heretofore authorized by Congress, \$4,000,000; improvement of the plant at the Portsmouth navy yard, \$150,000; at the Boston yard, \$150,000; at League Island, Philadelphia, \$250,000; construction of two tugs, \$86,000; construction of one freight boat, \$450,000.

During the year 1888-89 the following expenditures were made: Repairs on vessels at the navy yards, \$373,364; construction and repairs, \$779,943; labor at navy yards and stations and material, \$140,905; civil establishments, \$19,925; steel cruisers, \$45,284; repairs of vessels, \$120,164; increase of the navy, \$748,000.

The Commodore presents a lengthy argument in favor of increasing the efficiency of the navy yards as indicated in the estimates, saying this great nation should not close any navy yard. The report says after eight or nine years there will be no wooden vessels remaining in active. A deficiency appropriation will be necessary in order that the work of construction and repair may be carried on during the remainder of the present fiscal year without interruption.

The single-turreted monitors are said to be now in a worse than useless state, and the report recommends that something be done with them. To put them into commission for efficient service in harbor and coast defense will cost, it is estimated, \$4,100,000. There are thirteen of these monitors. Commodore Wilson calls attention to the difficulty of obtaining satisfactory bids for the construction of vessels when the cost is limited by the acts authorizing them to be built, and recommends that in the future the bureau be not crippled by such legislation.

With the completion of the vessels now building and appropriated for, the United States will possess ten armored vessels, thirteen single-turreted monitors, twenty-one steel cruisers or gunboats, two dynamite cruisers, a practice cruiser for cadets, an armored ram, one first-class torpedo boat and seven iron steamers. The work of rebuilding the navy is progressing very satisfactorily, and the results accomplished during the past six months are a sufficient guaranty of the purpose of the department to advance work with the utmost rapidity, and of its energy and success in the performance of the task.
