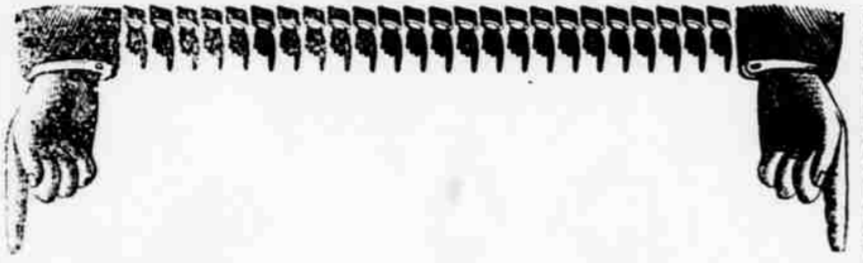

OTTAWA (Ontario), Nov. 28.—The Journal, which supports the government of Sir John Macdonald, says: It looks as though there will be a Canadian Mormon immigration into the Canadian Northwest unless checked by hostile legislation. The colony near McLeod has prospered. It has been visited by delegates sent from Salt Lake City to report and arrange for the emigration to the British territory, and there is little doubt the result will be a rapid growth of the Mormon settlement within the prairie territories of the Dominion. Unless the threatened mischief is nipped in the bud Canada is destined at no very distant period to witness within her borders a repetition of the horrors the United States has had to contend with in Utah. The press and the public men of Canada may as well make up their minds before the next session of Parliament upon what terms the Mormon immigration into this country will be allowed, if at all. The Dominion Government has detectives about the Mormon colony near Lee's creek investigating the marital relations of the few suspected persons, and is keeping in close surveillance a number of the recent arrivals.

NATIONAL CAPITAL TOPICS.

Irrigation Will Be One of the Great Questions of the Year.

WASHINGTON, Nov. 28.—Representative Hansbrough is of the opinion that it makes little difference which side of the speakership contest the new state delegation takes, they will be accorded a due share of attention by the republic majority anyway. The new states, he claims, must be recognized, and while the five votes stand together on all other questions, the fact that they did not vote in caucus for whoever may be the coming man will not affect them. Mr. Hansbrough is not a Reed man, and his opinions are shared by other members of the Western delegation.

Representative Wilson, of Washington, is rather inclined to get on the band wagon, and thinks if he could name a winner and stick to him, it would be better for his section. The members think the new congressmen will be recognized, even if they don't vote for the winner. The new members have had several meetings to consider the subject of irrigation. All the states want irrigation. The Dakotas want ardent irrigation; Montana, Washington and Idaho looking for irrigation by the pipe system from high mountain streams. The members say they want money for carrying on the work and their conferences have been with a view of seeing how best they could be obtained. Insurance members are sure to be in with them and that state wants the artesian system tried. The subject of irrigation will be one of great importance before the coming season.

PLEADING FOR THE CHINESE.

The Argument of British Columbia Fishermen.

OTTAWA (Ont.), Nov. 28.—A deputation of British Columbia fishermen arrived here to-day. They will ask for the removal of the tax on Chinese. They represent that Chinese labor is essential to the salmon-packing industry; that without it the industry would collapse. The visitors will also ask the Government to remove the duty of 33 per cent on mining machinery.

FAMOUS CASE ENDED.

Millions at Stake—Great Rejoicing at Denver and Elsewhere.

DENVER, Nov. 28.—The famous Durant-Bonnybel case, which has been on trial in the United States circuit court for the past sixteen days, came to an end at six o'clock to-night, the jury giving to Bonnybel a verdict for the second time. The case is famous among mining men throughout the country, for a reason that millions of money depended on the verdict. Reports come from Aspen that the city is wild over the verdict, and in Denver wine is flowing like water at all of the hotels at the expense of the Bonnybel owners.

IN MEMORIAM.

Died, at South Brownville, Nov. 25th, 1889. Amelia L., aged 42 years, 11 months and 13 days, wife of John Brown. Mrs. John Brown, nee Miss Amelia L. Spaulding, was born Dec. 12, 1846, and was the youngest daughter of Amelia and Rev. H. H. Spaulding, pioneer missionaries to this coast, made memorable by the Whitman massacre of the earlier days of Oregon. For nearly twenty years Mrs. Brown has been a confirmed invalid, and although confined to bed for this period, has borne her afflictions with christian fortitude and resignation. By previous request of the deceased, Dr. I. W. Starr has been in constant attendance, and done all that lay in his power to alleviate pain and suffering. The funeral services were conducted by Rev. Carpus Sperry, at the North Brownville Baptist Church, on Tuesday Nov. 26, from which place an immense concourse of sympathizing friends accompanied the remains to their last resting place.

TELEGRAPHIC NEWS.

Jacob S. Haldeman, ex-minister to Sweden, is dead, aged 66 years.

Andrew Banks, of Baltimore, an ex-member of the legislature, has failed. Liabilities \$450,000; assets, \$100,000.
The protracted rains and present floods have disheartened the Virginia farmers. Corn is rotting in the fields.
The suspension of Arthur & Ketchum has been announced at the New York stock exchange. They have been members since 1867.
Wednesday morning the Sonora railroad depot at Hermosillo, Arizona, caught fire from a switch engine and was entirely destroyed. It was erected in 1882 at a cost of nearly \$30,000. Tickets and baggage were saved with difficulty.
