## OVER THE WIRES.

### The Trial of Gibbs, the Colored Murderer, Will Begin Tuesday

#### CANADIANS WANT NO CHINESE

Dom Pedro Arrives in Lisbon, and Will Issue a Manifesto to the Brazilian People—Jeff Davis' Remains.

PORTLAND, Dec. 7.—The trial of H. E. Gibbs, indicted for murder in the first degree, for shooting James McDevitt, who subsequently died from his wounds, comes up in the original case on Tuesday next, unless his counsel can show good cause for continuing.

OPPOSED TO CHINESE.

Canadians are After the Scalps of Mongolian Laborers.

OTTAWA, Dec. 7.—The following telegram has been received by Premier McDonald:

"In behalf of the Breadwinners and electors of this city, I earnestly protest against any modification of the Chinese restriction act. The measure is a necessary protection against the dangerous invasion of the worst form of debased Mongolian heathenism, which tends only to degrade labor and impoverish the country."

#### JEFF DAVIS' REMAINS.

They Lie in State at New Orleans in Great Pomp.

NEW ORLEANS, Dec. 7.—The remains of Jefferson Davis are lying in state in the council chamber of the city hall. The coffin rests upon a catafalque devoid of all ornamentation. The casket has a silver plate, upon which is the simple inscription, "Jefferson Davis at rest," with the date of his death. The badges of the confederate associations, flags of the Washington artillery, which were carried through the war, and a bunch of feathers and a piece of crape on Spanish daggers, fastened together with purple ribbon are the only ornaments. The darkened room is dimly lit up by a cluster of electric lights, their brilliancy dimmed by sable drapery. Soldiers in uniform stand guard, stacks of arms and cannons fill the corners of the chamber, and all around the wall are rows of plants and shrubbery. Since early this morning people have been pouring in to obtain a last look at the dead. All classes are represented in the procession by the hour. A number of colored people were noticed in the crowd. Marked mourning is general, and every place of prominence in the city has put on black.

A noteworthy event this morning was a telegram sent by Mayor Shakespeare to Secretary of War Proctor, officially notifying him of the death of Ex-Secretary Davis, and the date of the funeral.

#### DOM PEDRO.

He Arrives at Lisbon and Will Issue a Manifesto to Brazilians.

LISBON, Dec. 7.—The steamer Alagias, with ex-emperor Dom Pedro, of Brazil, and party on board, and flying the old Brazilian flag arrived in Tagues this morning. She anchored off Belem, a suburb of Lisbon, opposite Lazarus, but was not compelled to undergo quarantine. The party came ashore immediately. They landed at the naval arsenal. Before the party left the steamer she was boarded by King Carlos, who extended a warm welcome to the ex-emperor. Dom Pedro is in excellent spirits, and appears not to have suffered by the recent events in Brazil. It is said he intends to issue a manifesto to the Brazilian people. Dom Pedro declines to discuss the recent events in Brazil. Count Deu intends to go to Spain on a visit to the Duke De Montpensier. Dom Pedro will probably remain in Lisbon a few days and then proceed to Paris.

#### NEWS FROM THE ORIENT.

### Chinese Troops Defeated—Missionsaries Molested—Steamer Lost.

SAN FRANCISCO, Dec. 7.—By the arrival of the new steamer China, advices are received from Hong Kong to November 13, and from Yokohama to November 22. Chinese troops have suffered a rather severe defeat from savages in South Formosa, three or four hundred of them being killed. In Kentucky a mob attacked the China land and Methodist Episcopal missions at Nauk and destroyed both chapels and an opium refuge, and stoned the officials who attempted to interfere. The missionaries and ladies took refuge in Yamen.

The German steamer Duburg, which left Singapore for Hong Kong on October 25, has not since been heard of, and it is feared she may have encountered the recent typhoon and foundered. If so, the disaster is an appalling one, for she had on board 400 passengers.

#### EFFECTS OF THE CONGRESS.

### An American Firm Secures a Large Contract From Cuba.

NEW YORK, Dec. 7.—The Pan-American congress has already made its influence felt, such to the disadvantage of the capitalists. An American firm captured a \$2,500,000 contract from the city of Havana, Cuba, to supply the city with a perfect system of water works, and many English firms competed.

Senor F. Nargones, an official of the Cuban government, arrived in New York today with the documents, awarding the contract to Temple, Smith & Co. This is the largest contract ever secured by any American firm in Cuba.

The entertainment of the Pan-American congress in New York city under the auspices of the Spanish American Commercial Union, which begins December 16, will be a most elaborate affair, closing on the night of the 20th with a banquet. The expense of the dinner will be \$35 per plate.

#### INDIANS' VICES.

### Two Red Men From the Siletz Asaulted a Little Girl.

PORTLAND, Dec. 7.—Wm. Baker and John Frazee, the two Indians who were recently indicted for committing a criminal assault upon an Indian girl named Winnie Thompson, who lives at the Siletz reservation, were arraigned before Judge Deady this morning and entered pleas of not guilty. They are both hard-looking characters. Baker has holes punched in both ears, and formerly wore goose quills in them. District Attorney McQuill stated to the court that, in view of the gravity of the charge, he was disposed to give the accused plenty of time to prepare their cases. Neither of them has yet secured counsel. The court set the trial for Friday, December 27.

The victim of the two brutes is only 9 years old, and tells a story which cannot be doubted. She lived at the same house with Baker and Frazee, and a few weeks ago complained of being unwell. An examination disclosed the fact that she was suffering from a loathsome disease, which she confessed was communicated to her by the prisoners. It is known that they were affected by the same trouble.

The punishment in such a case is death.

Baker is possessed of considerable means, his property consisting of horses and cattle. He has engaged Hon. John E. Caplan to defend him, but as he could not pay the sum of \$250, being the fee demanded by the attorney, he did not secure his services and will have to look elsewhere for legal talent. There is said to be a great deal of feeling about Siletz against these men, though the accused have a number of friends who are endeavoring to force the little girl to change her testimony and have the charge withdrawn. Deputy Marshal Roberts, who arrested the men, says there is no doubt in the locality where they lived as to their guilt.

#### TEMPERANCE NOTES.

### After Buried Treasure.

#### An Old Sailor Claims to Know the Location of \$250,000.

GILLESBY, Dec. 7.—An old sailor, Pete Jennings, who has been working on Miller's Bloomfield ranch, claims to have been a passenger many years since with an old pirate, who on his death bed, divulged the secret hiding-place of a quarter-million of treasure in Spanish doubloons, the place being Wall island, in the Pacific ocean, three degrees south of the equator, off the South American coast.

A company was organized during the late war to look for this treasure, but failed to start on account of government interference. Jennings has now succeeded in interesting capitalists from the East sojourning here, and, believing his story, they, with him, yesterday started for San Francisco to make the necessary preparations for the discovery and recovery of the gold.

#### TEMPERANCE NOTES.

Distributed by the W. C. T. U.

EVANSTON, Ill., Nov. 26, 1889.

To the Editor: The history of the partisan papers of the country has so industriously circulated misleading statements concerning the recent convention of the national W. C. T. U. held in Chicago, that I earnestly ask you as a friend of the truth, to publish the following facts in the matter: One would think from these sensational reports that this convention had done nothing from beginning to end but discuss the vice-president's bar-room, abuse Mrs. Foster, berate the republicans and pass third party resolutions.

On the contrary, the vice-president's bar-room would doubtless have received very little attention had not the partisan papers taken Miss Willard to task so unjustly for accusing the vice-president on the authority of an unreliable newspaper, although as is well known, the so-called accusation had already been for days before the public through the associated press dispatches, while Miss Willard in her address simply expressed a desire that, in sorrow, not in anger, a protest should be sent to the vice-president for permitting a bar in his new hotel.

In respect to the second charge it may be said that Mrs. Foster was given the floor whenever she asked it, and granted extension of time again and again and was heard with entire respect on the part of delegates and members. The patience and courtesy with which she was treated were subjects of remark by many spectators.

The third charge is entirely unfounded. No party prohibitionists were more cordially received by the convention than were the Hon. Henry W. Blair, republican senator from New Hampshire, and Major Pickler, republican congressman-elect from South Dakota.

A resolution was passed rejecting that the republican party in South Dakota has declared for prohibition, and many of the leading women plainly stated before the convention that the national W. C. T. U. will endorse any and all parties that will stand for our principle.

As to the last point, very little has yet been published concerning the great number of other subjects engaging the attention of this meeting. Many reporters sat listless and idle or went away during the hours devoted to prayer and Bible service, or to reports of department work and addresses on topics not sensational, but were all attentive whenever politics or Iowa was mentioned. All of Friday morning was devoted to a consecration service.

Every morning session began with a Bible reading from nine to ten o'clock. A deep religious spirit pervaded the entire assembly. Each day at noon all other things were laid aside while one united noontide prayer went up to the Father of all.

So far as the convention itself was concerned the reports of department work were of the greatest interest and importance and received the closest attention. Permit me in closing to mention a few points, merely, from these reports, to give an idea of what the W. C. T. U. is doing anyhow; besides discussing political questions: More than \$1100 have been spent in work among foreigners, nearly 100 different kinds of tracts in fourteen different languages having been published; a capital stock of \$542,000 has been secured for the temperance temple; 200,000 children have been gathered into Loyal Temperance Legions.

The legislatures of twenty-seven states and the national congress have made the science of temperance a required study in all school under their control; the gain of pledged Sunday school scholars in ten states alone is more than 40,000; the Woman's Temperance Publication Association has sent out more than 125,000,000 pages of temperance and religious literature. These items do not summarize but simply suggest the vast work already accomplished by the Woman's Christian Union under the inspiration of this motto: No sectarianism in religion, no sectionalism in politics, no sex in citizenship; but each and all of us for God and home and native land.

#### COAST NOTES.

Oregon is shipping flour and lumber to China.

Mrs. Seneca Smith was killed in a runaway accident at Portland Friday.

A census is being taken in Tacoma. It is expected that the returns will show a population of 20,000.

The first steambark to navigate the Willamette above Corvallis this season of '89-'90, was the Modoc, on Tuesday, December 3rd.

Col. James K. Kelley, of Portland, has sold to A. W. Berry 160 acres at Astoria for \$100,000. The deed goes to Washington City for Mrs. Kelly's signature and acknowledgment.

Two runaway Indian boys from the Chemawa school were captured in Corvallis on Tuesday by Scraftford, the deputy marshal. An employe of that institution came up and took charge of them Wednesday.

A Polk county man received a "shivaree" because he married within a month after his first wife's death. He told the serenaders that he didn't think it showed good taste to come banging around a man's house so soon after a funeral.

The city council in Tacoma is in a quandary. The banks refuse to take the warrants of the municipality, unless at a heavy discount. The city is sound financially and as the warrants bear 10 per cent interest the council cannot understand the action of the banks.

William B. Ladue, of Salem, has received the appointment as cadet to the West Point from Oregon. As alternate, in case Ladue does not accept, Congressman Hermann has named Herold B. Fiske, of Salem and Hayward H. Riddell, of The Dalles. Both of these are of the capital city originally.

Friday morning as the Hoag was steaming into Milwaukee, the cry of fire was heard and flames were seen issuing from the dry house connected with the furniture factory. The Hoag made a quick landing, turning the stream from her line of hose to the burning building, and soon had the flames under control. The damage to the building was only \$200, but had not the Hoag happened along at just that time the entire factory and over 16,000 feet of ash lumber would have been destroyed.

In the damage suit brought by the farmers of Polk county against the railroad company for loss sustained by fire in the grain fields, started, the plaintiffs allege, by sparks from locomotives, it is probable that but one case will be tried. The first one was called at Dalles Tuesday and concluded Friday, it being the suit of Alex. Holmes, who claimed to have been damaged to the extent of \$100. The court awarded him \$160. It is now thought his case will be made a test, letting the others be governed by the decision in the one case. In all there are sixteen suits, claiming, in the aggregate, damages in the sum of about \$200,000.
