**Jem Smith Whipped—His Contemptible Unfairness.**

**SIXTEEN MINERS ENTOMBED.**  
Disembodied Bodies of the Victims of a Wreck Washed Ashore—Fatal Train Wreck—Eastern News.

**The Herald's Special Dispatch.**  
**BRUSSELS, Dec. 23.**—The fight between Jem Smith, of England, and Frank Slavin, the Australian champion was fought this morning in private grounds three miles from Bruges. There was much squabbling from the outset, and owing to the outrageous conduct of Smith's party at the conclusion of the fourteenth round, the referee declared the fight a draw and refused to remain on the ground. Smith's party evidently saw that their man was beaten and broke into the ring and interfered with the progress of the fight.  
Slavin forced the fighting at the start, hitting Smith several times on the chest and on the head. The first to the fifth round was marked by hard fighting.  
Sixth—Slavin lands a terrific blow on one of Smith's eyes.  
Seventh—Smith fought Slavin to the rope when one of Smith's friends kicked Slavin, who, however, remained silent.  
Eighth—Slavin again knocked Smith down.  
Ninth—The mob surrounding the ring struck Slavin several times.  
Eleventh—Slavin again knocked his opponent down.  
Thirteenth—Slavin protested against the treatment he was receiving and appealed to the referee for fair play. His appeal was greeted with derision by Smith's friends, who shouted "police" and bolted from the grounds. Slavin remained in the ring, and Smith, who had left when his friends ran away, returned. The referee then said it was impossible to receive fair treatment for Slavin, and declared the fight a draw.  
Slavin was full of fight to the finish.

**LONDON, Dec. 23.**—The report received here of the Smith-Slavin prize fight in Belgium says that Slavin showed all through the fight that he was the better man. A number of rowdies at the ring-side, armed with knuckles, dusters and sticks, tried to reach Slavin over the ropes and the Australian was struck several times. At the end of the thirteenth round Smith left the ring. Slavin remained and claimed the fight, but the referee would not award it to him. After a short time Smith returned to the ring. During the next round there was a great uproar all around the ring. At the close of the round Smith was very sick, but Slavin was perfectly well. It lasted 22 minutes.

It was reported at one time that Slavin had been killed, but the report proved to be false.

**IN WASHINGTON.**  
**Silcott Left Behind \$8300—State Boundary Suit.**

**WASHINGTON, Dec. 23.**—There was delivered to the United States treasury this morning a large package with the following inscription: "Contents of the cash compartments of the safe of the sergeant-at-arms of the house of representatives, seal of delivery to the treasury of the United States government. Such resolution of house adopted December 21."  
It is signed by Sergeant-at-arms Leedom, Congressman Adams, of the Silcott committee, Assistant Treasurer Whelpley and two expert accountants. The package contains upwards of \$8300 in notes, checks and other securities, representing the money left by absconding cashier Silcott.  
The supreme court to-day granted the senate of Virginia leave to file a complaint against the state of Tennessee in the matter of the disputed boundary line between the two states. Subpoenas were directed to be issued against the governor and attorney-general of Tennessee.

The ways and means committee was engaged to-day in the consideration of the McKinley administration.  
The customs bill committee reports to complete the preparation of a bill before the hearings on the tariff begin.

This created a big sensation when it first leaked out, but was quickly quelled, when Mr. Reed's attention was called to it, by the following statement from the gentleman: "I have never overdrawn my account, in fact have never drawn a cent until it was due. After I was elected speaker there was due me \$1,934. I handed in my certificate that the money might be got for me from the treasury in the form of a draft on New York. Mr. Reed has been called a lazy man, and perhaps he is, but if so it's a great pity that a lazy man hasn't been elected speaker of the House before this, for in this matter of appointing the committees he is ahead of all his recent predecessors.

A joint resolution has already been introduced in the Senate providing for a Congressional recess from next Thursday to January 6, and there is not the slightest doubt about its passing both Houses. The recess will not however be spent in idleness. The important committees will be in session almost every day getting business in shape. Mr. McKinley, chairman of the new ways and means committee, proposes to go to work at once upon the tariff bill which is to work at once upon the tariff bill which it is to be passed at this session. It is probable that what was known as the Senate tariff bill at the last session of Congress will be used as the basis of the new bill. Trusts too are to be looked after by the same committee. What makes the thing look worse for all concerned, is that no serious effort has been made to trace Silcott and try to bring him back. The fact that Leedom and Silcott have been the boon companions of a lot of fast Congressmen makes many people believe that Leedom and quite a number of members and ex-members of the house would be very sorry indeed to see Silcott under arrest, for fear that their turn might come next.
