run with no rules. Whether the new

question. But a glance at the changes
will show that the new rules are
much better calculated to advance
legislation than the system which ob-
tained in the last Congress and that
those who are disposed to be ob-
structionists simply for the purpose of
obstruction are disarmed of many of
their favorite weapons. If not what
the minority choose, this will give it
a fair show for recognition, while re-
stricting its powers of mischief, and
will bring order out of chaos.

The blackened shell of the lately
handsome home of Secretary Tracy,
standing in the sunshine that floods
Farragut square with the memory of
the melancholy tragedy about it, is a
sad remnant of one of the happiest
homes in the city. Mrs. Tracy was
the latest of the cabinet ladies to
make the acquaintance of the Wash-
ington people. With her generous
and sympathetic nature soon became
interested in everything and almost
every person connected with social
life here. She took up her duties
with so much warmth of heart and
real pleasure in it all that her
enthusiastic enjoyment won for her
love and admiration. Past sixty in
years there was that youthfulness of
the heart characterizing her that is
never touched by time. Mrs. Tracy's
social gifts were of the rarest order
and the mourning that is felt for her
in hundreds of hearts is that of
personal loss by each individual who
knew her.

Mrs. Mary Tracy had inherited her
mother's sunny nature that time
would have developed into the attrac-
tive qualities that made Mrs. Tracy
so remarkable a woman whatever
position in life she was called upon to
grace. They were two of nature's
gentlewomen, pure of heart, noble in
intention, kindly and gracious and
tenderly loyal in all their relations
and obligations.

Washington is unquestionably the
convention city of the republic. Such
important gatherings were convened
Wednesday as the National Board of
Trade, the National Shipping League,
the National Guard Association, the
National Association of Post Office
Clerks, and the National Colored
People's Convention. As a culmina-
tion of its achievements as the meet-
ing place of the People, Washington
has a great convention hall, and the
national celebration at the capital of
the discovery of America by Colum-
bus.

Mr. Foster Higgins, when he stated
in the American shipping league
Wednesday that the present condition
of the merchant marines of the
country is a standing menace to
American prosperity, was emphatic-
ally right. If the carrying trade of
Great Britain were suddenly with-
drawn, as in the case of war it might
be, there would be a financial panic
here. This question of the American
ship for the American cargo is one of
the higher economies, and no matter
what the point of view of the citizen
on the tariff question may be we
should all be favorable to a restora-
tion as soon as possible of the national
merchant marine.

At a meeting of the House com-
mittee on the civil service yesterday,
the line of inquiry to be followed into
the charges that have been preferred
against the commission was decided
upon. The committee will first in-
vestigate the charges affecting the
commission as at present organized;

THE XCVTH AMENDMENT.

To Sacrifice Representatives in Con-
gress for the Repeal.

JACKSON, Miss., Feb. 16.—The
West memorial, now pending in the
House of Representatives of this
State, is attracting more attention
than any other public question before
the Legislature, and the following
letter will be read with interest.
Judge Wiley P. Harris advocated the
adoption of the XIIIth and XIVth
Amendments of the Federal Constitu-
tion by the Southern States before the
XVth Amendment was thought of,
and in the letter which follows he ap-
proves the same course to-day. His
opinion is entitled to great weight.
For a third of a century he has been
consulted by Senators and Governors,
and has been regarded as the first
constitutional lawyer in Mississippi.
He was asked for his opinion by mem-
bers of the Legislature, and replied as
follows:

To your joint letter of February
6, on the subject of the memorial to
Congress, reported to the House of
Representatives by the Committee on
Federal Relations, my reply is that I
take the memorial to be in effect an
address to our sister States, through
Congress in favor of amending the
Constitution of the United States so
as to allow the States, as each may
determine for herself, to deal with
the question of suffrage, as they may
see fit, subject only to the rule of ap-
portionment fixed by the XIVth
Amendment. The restriction imposed
by the XVth Amendment of the
liberty of the States in this respect is
felt to be a grievance by us, as in
view of the preponderance of the
negro population in the State, a
preponderance annually increasing by
the influx of the negroes from other
States, it is a transfer of political
power so that race, and we think we
ought to be free to deal with the dan-
ger involved in it. The practical
view of the demonstration measured
by the chance of favorable action by
Congress appears, I confess, to be
slight; but I perceive in the memorial
an avowal which, in the constantly
recurring agitation of the subject in
the country, I think should be made
as soon as authorized by a body
representing the people of the State,
of our willingness to suffer a reduction
of our representation in the lower
House of Congress and of our votes in
the Electoral College for the sake of
tranquility at home. Such an
avowal will serve to refute the charge
and dispel the belief that we prefer to
suppress the negro vote by indirect
means, and at the same time retain a

FROM AUSTRALIA.

A Chapters of Disasters on the Big
Island.

SAN FRANCISCO, Feb. 17.—The
steamer Zelanda arrived to-day,
bringing advices from Sydney to
January 22 and Auckland to Janu-
ary 26.

Fire in Sydney on Christmas
destroyed the sheds of the Tas-
manian Steam Navigation Compa-
ny's wharf, causing a loss of \$150,-
000.

The new year was remarkable in
Australia for many fatal accidents.
One of the most prominent was the
collapse of the old Volunteer Artil-
lery hotel in Sydney, in which two
people were buried in the ruins
and burned.

The condition of the unemployed
at Sydney is becoming serious.
One recent night 500 men and
women were counted asleep in parks
of the city, all without money or
homes.

Queen Island was visited by a
severe storm on January 5th, re-
sulting in serious floods, causing
several deaths and much loss of
property.

The Farnell Commission.

NEW YORK, Feb. 17.—A cable
from London says: The cabinet
was very doubtful as to what action
to take regarding the Farnell com-
mission. They agreed finally to
let Farnell and his colleagues take
the initiative. It was proposed to
expel the members of the commis-
sion who were found guilty of
criminal conspiracy, but it was not
favorably received and was aban-
doned. On the other hand it was
decided to assume the offensive,
and a vote of censure will be moved
when the expense account of the
commission is laid.

Closed Its Doors.

LANCASTER, Pa., Feb. 17.—The
Lincoln national bank has been
plundered by Cashier Bard and F.
W. Hull and has closed its doors
under orders of the bank examiner.
It is reported this morning that the
defalcation will amount to between
\$20,000 and \$40,000.
