WASHINGTON, Feb. 21.—Among the bills reported and placed on the calendar was one providing for sea coast defense and establishment of a gun factory for finishing and assembling heavy ordnance guns on the Pacific coast. Edmunds introduced a bill to increase the rank and pay of navy officers; referred. The senate then proceeded to the consideration of a house bill to provide for townsite entries on land in Oklahoma.

THE WORLD'S FAIR SITE.

WASHINGTON, Feb. 21.—Hooker, of Minnesota, proceeded to address the house on the world's fair bill. Mills, of Texas, made a speech objecting to the bill altogether as a thing with which the government should have nothing to do. He would vote for it as a site, and when that question was decided would vote against the bill altogether. Morse, of Massachusetts, announced that he would vote against the bill because he thought Washington the only site that could be selected as a compromise, and holding it in Washington would cost several millions of dollars, which could be better expended for some public buildings or postal telegraph.

THE PRIZE RING.

Kilrain is Used Up and Will Quit the Fighting Business.

SAN FRANCISCO, Feb. 21.—Joe McAuliffe, San Francisco's heavyweight, is annoyed at the telegraphic reports received here recently to the effect that Jim Corbett had declared in New Orleans that he had once defeated McAuliffe in a scientific contest. McAuliffe said last night: "I deny what Corbett says. He is trying to make capital at my expense. I intended to go East right away, but I will stay here till Corbett gets back and I'll see whether he can defeat me in scientific points in ten or any number of rounds."

NEW ORLEANS, Feb. 21.—Jake

Kilrain is about to retire temporarily from the ring. He has been on the down grade for some time and recognizes that it will be the best to accept the advice of Muldoon and others. The rheumatism or something else has been gradually getting the best of him. He can hardly close up his hands, his right shoulder is lame and his legs are very sore. It has been decided that he shall go to the Hot Springs as soon as possible and remain there five weeks.

NEWS FROM PORTLAND.

Death of a Wealthy Portlander—A Wrecked Furniture Factory.

EAST PORTLAND, Feb. 21.—Mr. Gustrie died at his residence in this city this morning at 7 o'clock. He was something more than 48 years of age, leaves a wife and one son, and an estate worth from \$80,000 to \$100,000. PORTLAND, Feb. 21.—Ira F. Powers' furniture factory now rests between the old pumping station and the Narrow Gauge railway track. The structure is sitting upon the ground as solidly as if it had a brick foundation under it, instead of having been carried and deposited there by the roaring floods which so recently swelled the waters of the Willamette. All the machinery and materials are taken out of the shop, and it will doubtless soon be torn down and hauled away. A prize fight occurred last night at Vancouver between a soldier and Frank Shay. Seven rounds were fought and the soldier gave up the fight. Skin tight gloves were used.

THE GERMAN ELECTIONS.

A Second Ballot Will be Necessary in Several Districts.

BERLIN, Feb. 21.—The returns from the elections thus far show the election of five conservatives, two imperialists, two liberals, fourteen socialists, one national liberal, two Poles and two Alsations. In 6 or 7 other districts a second ballot will be necessary. The socialist vote in Berlin shows an increase of 33,000, the liberal vote an increase of 8000 at the conservative vote a decrease of 25,000. Two socialists are elected in the city. In three districts second ballots will be necessary.

Free Schools the Bulwark of Liberty.

NEW YORK, Feb. 20.—The educational conference met this morning. Ex-President Sheldon proposed a resolution, declaring the association regarded the public school system as the chief source of civilization and the bulwark of civil and religious liberty; approved placing the American flag over all schoolhouses, and recommended study of the declaration of independence and other historical

American papers, and declared that

they could meet host e criticism and make the public schools allies of the home and become the sources of the highest moral instruction without any sectarian bias. H. S. Tarbell of Providence introduced a resolution approving the recommendation of the Indian commissioner in dealing with education of Indian children. The following officers were elected for the ensuing year: President, Andrew S. Draper of Albany; first vice president, J. A. B. Lovett, Huntsville, Ala.; second vice president, E. B. McElroy, Salem, Or.; secretary, L. W. Day, Cleveland, Ohio.

TOO FAMILIAR WITH WOMEN.

Did Bishop Dubs and Another Preacher Do Wrong?

CLEVELAND, Feb. 20.—At the trial of Bishop Dubs to-day several witnesses testified to Dubs' familiarity with women, but nothing criminal was alleged. Rev. Mr. Yost, when testifying, was asked if he and Bishop Dubs did not visit houses of ill-repute in Buffalo at the bishop's suggestion, but he refused to answer, although the question was repeated in several forms. The testimony then closed, and arguments were made by the two prosecuting witnesses and Bishop Bowman. Bishop Dubs denies the allegations made against his moral character, and says that at the general conference, which meets in September, 1891, he will prove his innocence. The jury reached a verdict in his case to-night, but it will not be made public until to-morrow. It is believed, however, that Dubs will be found guilty and deposed from office and expelled from the church.

MRS. TERRY.

Having Her Trial for Contempt in the U. S. District Court.

SAN FRANCISCO, Feb. 20.—The trial of Mrs. Sarah Althea Terry, on the charge of contempt in having resisted the United States Marshal in the circuit court in September 1888, when that officer had been ordered to remove her from the room, was commenced in the United States district court this morning, before Judge Ross, of the southern district of California. The defendant was present dressed in deep mourning.

SALARIES OF LAWMAKERS.

What the Statesmen of Various Countries Get for Their Services.

St. Louis Republic. Some curious statistics have just been published concerning the salaries given the members of parliament in the various nations. To begin with, in the United States of America the members of both branches of Congress receive the same amount of pay—namely, \$5000 per annum. In France it is the same—members of each house receiving the same—\$1 per day. In Belgium each member of the Chamber of Representatives gets \$17 a month. In Denmark the members of the Landsting each receive about 15 shillings a day. In Portugal the Peers and Commons are paid the same sum, which is about \$67 a year. In Sweden the members of the Diet receive \$66 for a session of four months, but they have to pay a fine of 12 shillings for every day's absence. In Switzerland the members in the National Council get 10 shillings per diem and the Council of State, the lower house, 6 shillings. In Norway the members of the Storthing receive 14 shillings per day during the session, which usually lasts about six weeks, but which has been extended to that many months. In Italy the Senators and Deputies are not paid at all, but they are allowed traveling expenses and certain other privileges. In Spain the members of the Cortes are also unpaid for their services, but enjoy many advantages and immunities. In Greece the Senators get £20 per month and the Deputies £10. In Germany both houses receive about 10 shillings per day. In Austria the pay is the same as in France, £1 a day.

England is the only country

where members of Parliament are not only unpaid, but have no rights or privileges whatever.

BEN BUTLER'S BIG SCHEME.

He is Going to Build a Railroad to the Holy Land.

NEW YORK, Feb. 20.—Benjamin Butler is the head of a land and railroad company just incorporated in Boston, to buy land and build a railroad through the Holy Land, in which express and passenger trains will be run. Senator Frye is also in the syndicate. The New England Company of Egypt is the paradoxical name of this proposed syndicate, the object of which is the purchase of houses and lots in Port Said and Alexandria and the building of a 200-mile modern trunk line from Port Said through to Damascus, in Arabia. Petros and Mansey, well known Yankees, are at the head of the enterprise, and besides Ben Butler are Frank Jones of New Hampshire, Gov. Goodall of the same state, Senator Frye of Maine, and Joseph G. Palmer of New Jersey, the latter being treasurer. The plan is to build a road through the mountain regions in Southern Palestine, running through the picturesque valley where flows the Bible-famed river, and thence on to Damascus. It is understood Butler and Jones promise that with their new railroad equipped with steel rails and 80-ton engines, vestibuled cars and Westinghouse air brakes, the American tourist of the near future will have all the modern improvements at his command. "Through Palestine by daylight" will attract globe trotters in everywhere. The first stop of importance in Palestine will be Hebron, after that Rome and then Bethlehem, after that Jerusalem, Jericho, Nazareth, Galilee and Damascus on the extreme east, and the trans-Palestine railroad will reach its terminus. The possible development of the enterprise is regarded as something immense if the permission of the local government can be secured to build the road. That this permission will be granted is confidently expected by the Yankee pioneers in the daring scheme.

LOOK OUT FOR SILCOTT.

The Ascending House Sergeant-at-Arms Cashier Out West.

WASHINGTON, Feb. 20.—A report has reached here to the effect that it is supposed that Silcott, the ascending cashier of the sergeant-at-arms of the national house of representatives, is somewhere in the state of Washington. The following is his description: Age, 51 years; height, 5 feet 7 inches; weight, 185 pounds; corpulent, with very heavy stooping shoulders and protruding stomach; ruddy complexion; short thick neck; pleasant face; blue eyes, gray hair and bald on top of head; has a scar extending from the eyebrow to the nose, which causes a squint or cast in one of his eyes; wore, when he left here, long chin whiskers and mustache, mixed with gray; wears a No. 7 shoe; feet pigeon-toed, and very offensive when exposed in an inveterate smoker and an occasional drinker, his favorite liquor being whisky; uses glasses in reading.

AROUND THE WORLD.

George Francis Train Will Make the Trip in Sixty Days.

BOSTON, Feb. 20.—George Francis Train is busy perfecting plans for his proposed trip around the world, which he expects to accomplish in sixty days, starting from Tacoma, Wash. He received a telegram to-night from R. F. Radebaugh, proprietor of the Tacoma Lodge, guaranteeing a special steamer and an escort of citizens from Tacoma to the steamer Abyssinia, which leaves Vancouver, B. C., March 16. Train will leave Boston March 9.
