WILD RUSH FOR LAND

Trouble Anticipated Over the Cherokee Strip.

TWO MEN BURNED TO DEATH.

Mrs. Olson and Son Found Guilty of Murder—Railroad Accident—Alaskan Lease—Unionist Riot.

THE HERALD'S Special Dispatches.
ARKANSAS CITY, Kansas, March 14.—The news of the bill extending the territorial government over the Cherokee strip, together with the Oklahoma territorial bill, was received here by the Cherokee boomers with great joy. This morning a rush for the strip was made by the one thousand or more families which had congregated between here and the Indian territory line. Intense excitement prevails among the boomers, and they are determined to stake claims regardless of the opposition of the military.

TROUBLE ANTICIPATED.
CANDWELL, Kan., March 14.—Eight hundred families of Cherokee boomers have decided to move into the strip Sunday. Captain Burbank, of the United States army, tried to dissuade them, but they told him they would go if they had to fight. Burbank has telegraphed for reinforcements.

THE OLESON LYNCHING.

The Wife and Son Found Guilty and Will Be Hung.

MINNEAPOLIS, March 14.—The trial of the first three persons charged with the Oleson lynching in Whitehall was concluded yesterday. The jury, after being out for a short while, returned a verdict of guilty of murder in the first degree against Mrs. Oleson, Hanson Oleson and Ole Stettis. The two first named were wife and son, respectively, of the man lynched. About thirty of the persons who took part in the outrage plead guilty to riot and were fined \$15 each. Charles Johnson, who pleaded guilty with the others convicted to-day, will be sentenced to prison for life.

RAILROAD ACCIDENT.

A Train Plunges Down an Embankment Into the River.

MANFIELD, Ohio, March 14.—A fast vestibule train on the Baltimore and Ohio ran into a landslide this morning. The engine was thrown into the river and fireman Thomas Boland killed. Engineer John M. McCoy and engineer John Hart seriously injured. The passengers were severely shaken up.

A NARROW ESCAPE.

Almost a Disaster on a New York Street Railway.

NEW YORK, March 14.—The passengers of the Union Hill horse car had a narrow escape at the Willow avenue crossing of the West Shore railroad last night. The car was crossing the track as a train came around the corner. The gates opened and let down the gates imprisoning the car on the track. For a moment it looked as though the car with its human freight would be dashed to pieces.

One passenger jumped through the window and several others jumped off sustaining painful injuries. The engineer of the train managed to stop within a few feet of the imprudenced car.

The Alaskan Lease.

WASHINGTON, March 14.—George R. Tingle, special treasury agent at Seal Islands under the last administration, has been appointed general manager of the North American Company, now lessee of Alaska for sealing privileges. The lease with the company will be executed by Secretary Windom this evening or to-morrow.

A Unionist Riot.

LIVERPOOL, March 14.—A number of unionists, armed with bayoneting pins, made a savage attack to-day upon non-unionists employed on the steamer Botania, loading for Boston. The police quelled the riot and made several arrests.

Burned to Death.

JOHNSTOWN, Pa., March 14.—A cabin six miles east of here, on the Pennsylvania railroad, used by laborers, burned last night. Two men were burned to death and several injured.

Dalles Garrison a Thieves' Nest.

THE DALLES, March 14.—Spongie, a boy of 16 years, was arrested two days ago for larceny of hay and grain in the suburbs of the city, being caught in the act of taking hay from Chambers' barn. He confessed the crime and implicated Hawthorne, who lives with his father and mother in one of the garrison buildings. Last evening Marshal Gibson and Deputy Sheriff Coles went to the house to arrest Hawthorne. When the officers opened the door he went through a trap-door to a cellar and escaped by the aid of a ladder. The young man distanced the officers and climbed a high wall which was perched there with a ladder in hand. His father beckoned him to come

down. He came down and ran away as fleet as a deer. The father saddled a horse and rode after him. The officers will get a posse to-night and capture the thief. A cache was found under the stable in which were stored hay and grain. The garrison is a nest of thieves, which the officers will break up. The house of young Hawthorne is a mile and a quarter from the city and easily accessible to the glens, mountains and timber.

A WORK OF ART.

An Equestrian Statue of General Lee.

RICHMOND, Va., March 14.—The monument to the memory of General Robert E. Lee which will be unveiled here on May 29th will stand sixty-one feet and two inches above the ground. Of this height the base and pedestal will take thirty-nine feet, and Mencie's equestrian statue of the horse and rider, in bronze, will make the remaining twenty-two feet and two inches.

The pedestal is a classical composition. The horse and rider will appear as if supported by four columns of polished granite. At the top of each column is a lion's head. The base is almost entirely plain. It has only slight ornaments at the corners and the size gradually decreases up to the point on which the pedestal rests.

The statue is designed to represent General Lee having reined in his horse and in the act of overlooking a battle field and receiving the greeting of his troops. The horse's head is down and turned slightly to the left; the left fore-foot is advanced and the left hind-foot thrown back. The figure of Lee is erect and bareheaded, the head being turned very slightly to the left. The right hand is well up on the thigh holding the General's hat. The monument stands on a site just at the western end of the city.

IN ANCIENT POMPEII.

What They Had for Dinner Eighteen Hundred Years Ago.

The citizens of ancient Pompeii knew what was good. They relished roast pig. A family in that aristocratic city, one of the F. F. P.'s, perhaps, were about to dine on the rich and succulent dish, on the very day that the restless Titan under Mount Vesuvius expectorated from his fiery lungs the red-hot ashes which entombed the Pompeians in their dwellings.

The pig was being cooked, and was probably nearly done at the time, when the volcanic storm burst in and spoiled it.

This is not a matter of conjecture, for a mass of indurated lava and ashes has been found in a steppan standing on a cooking stove of the kitchen of a disinterred house, and on opening the lump, a perfect mold of a sucking porker was discovered. A cast was taken of the hollow, and the result was a face-simile in plaster of the little animal, which had been crushed in scientific shape, and is supposed from the shape of the matrix, to have been just ready for the table.

The inquisitive antiquarians are continually poking their noses into little domestic secrets of the Pompeians of eighteen centuries ago, which the people of the excavated neighborhood would have hesitated to tell to one another.

STATE DISPATCHES.

Killed on the Portland and Vancouver Railroad.

A REMARKABLE CASE.

A Section Man Thrusts a Crowbar in Front of an Engine and Instant Death—Portland News.

PORTLAND, March 14.—Sylvester Goddard, the young man about 27 years of age employed as section hand on the Portland & Vancouver railroad was instantly killed at Rosedale this morning. The train from the Columbia river was approaching Rosedale station, between Woodland and East Portland, the engineer saw two men on the track, ahead but before the train came very near both stepped from the track and were entirely out of danger. When the train came to the men, one suddenly stepped to the track with a crowbar in his hand and commenced to lay something on the track. The engine struck the heavy iron bar hurling it with terrific force against the man's head, throwing him about 15 feet from the track. The train was instantly stopped and when the man was picked up he was dead, his neck having been broken. A telegram was sent to his father who lives at Cross, Benton Co., Arkansas, acquainting him with the death of his son, and asking what disposition should be made of the remains. It is evident that Goddard thrust his crowbar in front of the engine but what his object was cannot be surmised unless it was to wreck the train. His death was clearly the result of his own carelessness, and not the slightest blame could be attached to any one else.

FOUND A CORPSE.

This morning a party of laborers engaged in repairing and cleaning out the Greenwich dock found the corpse of a tramp wrapped up in blankets in the rear of the wharf. The coroner was notified and the remains conveyed to the morgue. An inquest will be held to-morrow. The body bears the appearance of having been dead three or four days. Nothing was found upon his person throwing the slightest light upon his identity. The men working about the wharf imagine the saw the tramp before his death and if they are not mistaken he has a family on Lewis river and a daughter residing in this city.

CRIMINAL MATTERS.

In the criminal court this morning District Attorney McGinn moved that A. J. Cody convicted of the crime of mayhem committed upon Joseph Morin be discharged from custody. The judgment of Judge Stearns had been reversed and Mr. McGinn stated in court that he had carefully perused the opinion of the supreme court and felt confident that every evidence upon the testimony elicited at the first trial would be treated similarly by the higher court.

The mandate from the supreme court was received reversing the judgment in the case of Frank Jarvis convicted of incest. The supreme court holds in the opinion of the unsupported testimony of Jarvis' daughter was not sufficient to justify conviction and the presumable result in the case will be that the district attorney will be compelled to request the discharge of the prisoner.
