ONE HUNDRED POLICEMAN PATROL THE CITY.—Supported Incendiarism. COLORADO CITY, March 21.—Excitement is running high to-day and the discovery of fire bugs will result in their execution without trial. Late last evening after the burning of Mayor Stockbridge's residence, the American hotel was burned, also the residence of R. J. Reece, the Grand Avenue variety store and the Crystal Palace variety store.

THE total loss is about \$200,000. Two suspicious characters have been charged with being the incendiaries. The city is patrolled to-night by 100 special policemen.
