## NEAGLE JUSTIFIED.

The United States Supreme Court Sustains the Lower Courts.

### JUDGE FAVORS THE STRIKERS

A Starch Factory Barred—Establishing Equitable Rates and Wages—Nashville Failure.

WASHINGTON, April 14.—The celebrated Neagle habeas corpus case, from California, was discussed by the supreme court and the judgment of the lower court affirmed. This finally disposes of all the proceedings against Neagle for the shooting of Terry in the railway station at Lathrop last August, to prevent him from killing Field.

The opinion was delivered by Justice Miller. After the case was argued Neagle was arrested at Stockton by a state officer and released on a writ of habeas corpus, based on the ground that Neagle, who was acting under orders, merely performed his duty as an officer of the United States. It was on an appeal from this order that the case was brought before the United States court. After reviewing all the facts bearing on the case the court rendered its decision that "a conviction was established of a retried purpose on the part of Terry and his wife, amounting to a conspiracy to kill Neagle, and we are quite sure Neagle merely as a brother or a friend, traveling with him, was aware of all the previous relations of Terry to Field, and his bitter animosity toward Field, and his expressed purpose to have revenge upon the latter. It is quite clear that Neagle would have been justified in what he did, in defense of Field's life and possibly of his own.

## THE DAY IN CONGRESS

Preparations for the Funeral of Ex-Speaker Randall.

### COMPROMISE ON WINDOM BILL

Consent for the Democrats—Pierce Fire in Madrid—Growth of the Pacific Northwest.

WASHINGTON, April 14.—An air of sadness pervaded the house when the speakers grave was called to order. The seat long occupied by the late S. J. Randall was draped in black and ornamented with a handsome floral design. In his grave the speaker made a touching allusion to the dead congressman. O'Neil of Pennsylvania delivered a brief eulogy and then offered a resolution of regret at Randall's death, and providing for a committee of nine members of the house to attend the funeral.

This afternoon the members of the house caucus of the silver committee agreed on Windom's bill as it emerged from the house committee on coinage, with the addition of a few provisions intended to meet the view of the silver men. It will provide for an unlimited purchase of bullion produced in the United States at market price, not to exceed one dollar for 371.25 grains. Secretary Windom said he would state his opposition to the bill to make the treasury notes issued in purchase of silver bullion to be incorporated in the bill a provision allowing the redemption in bullion or coin at the option of the purchaser. The committee finally reached the agreement above outlined, and will meet the senate committee to-morrow morning in joint conference. The senate committee this afternoon reached a conclusion.

Three propositions were agreed to: 1st. That secretary of the treasury should buy 4,000,000 ounces of silver bullion monthly and issue notes in payment for the same, the notes to be redeemable in bullion or lawful money. 2nd. That the national banks be allowed to issue notes to full par value of bonds deposited to secure their redemption, which would add 10 per cent to the volume of national bank currency. 3rd. That \$100,000,000 be retained in the treasury for redemption of the notes that may be put in circulation.

The house then adjourned.

IN THE SENATE.

Plumb introduced a bill for the redemption of certain funds in the treasury. It provides that money required to be deposited for exemption national debt circulation be carried into treasury and treated as funds available for the reduction of the public debt, and for the current expenses of the government, and that all funds held for payment of national debt and interest due and unpaid be similarly treated and hereafter no funds available above ten million dollars be retained in the treasury, this might be construed as permanently diminishing the fund one hundred million dollars now held for redemption of treasury notes, he said there was less than \$70,000,000. The bill was referred to the finance committee.

Quay, Allison, Dawes, Voorhes and Ensis were appointed as a committee to attend the Randall funeral.

The senate provided for a committee to attend the funeral and adjourned.

Butte, Montana, Democratic.

WASHINGTON, April 14.—Messrs. Magnus and Clark, contestants in the Montana senatorship, received messages from friends in Butte, saying the city had been carried by the democrats, making a clean sweep. Butte is in Silver Bow county where the famous precinct 34 is situated.

Secretary Windom said he would state his opposition to the bill to make the treasury notes issued in purchase of silver bullion to be incorporated in the bill a provision allowing the redemption in bullion or coin at the option of the purchaser. The committee finally reached the agreement above outlined, and will meet the senate committee to-morrow morning in joint conference. The senate committee this afternoon reached a conclusion.

Three propositions were agreed to: 1st. That secretary of the treasury should buy 4,000,000 ounces of silver bullion monthly and issue notes in payment for the same, the notes to be redeemable in bullion or lawful money. 2nd. That the national banks be allowed to issue notes to full par value of bonds deposited to secure their redemption, which would add 10 per cent to the volume of national bank currency. 3rd. That \$100,000,000 be retained in the treasury for redemption of the notes that may be put in circulation.

The house then adjourned.

IN THE SENATE.

Plumb introduced a bill for the redemption of certain funds in the treasury. It provides that money required to be deposited for exemption national debt circulation be carried into treasury and treated as funds available for the reduction of the public debt, and for the current expenses of the government, and that all funds held for payment of national debt and interest due and unpaid be similarly treated and hereafter no funds available above ten million dollars be retained in the treasury, this might be construed as permanently diminishing the fund one hundred million dollars now held for redemption of treasury notes, he said there was less than \$70,000,000. The bill was referred to the finance committee.

Quay, Allison, Dawes, Voorhes and Ensis were appointed as a committee to attend the Randall funeral.

The senate provided for a committee to attend the funeral and adjourned.

Butte, Montana, Democratic.

WASHINGTON, April 14.—Messrs. Magnus and Clark, contestants in the Montana senatorship, received messages from friends in Butte, saying the city had been carried by the democrats, making a clean sweep. Butte is in Silver Bow county where the famous precinct 34 is situated.

Destructive Fire in Madrid.

MADRID, April 14.—A fire broke out in the gas works this evening and is blazing fiercely. A large crowd was attracted to the scene and great consternation prevails. The consequences will probably be very disastrous.

Money on False Pretenses.

PORTLAND, April 14.—Thos. Jones, who was arrested here recently on a charge of attempting to commit a fraud and thereby to obtain \$500 from another Jones of California, was released from custody today.

Argument Commenced.

SAN FRANCISCO, April 14.—The argument of the counsel commenced today in the Blythe case, which has been on trial before Judge Coffey in the probate department of the superior court for the past nine months.

High License.

RIVERSIDE, Cal., April 14.—High license was carried here today.
