The Silver Question.
WASHINGTON, April 26.—The
republican senators caucus to con-
sider the silver bill was in session

THOMPSON'S NARROW ESCAPE

Accident to a Freight Train at The
Dalles—Steamship Eastern Oregon
Sold.

PORTLAND, April 26.—General
Alger and party including Mrs.

SOUTHERN PACIFIC INTEN-
TIONS WITH NARROW GAUGE.

Will Change East Side. But Leaves
West Side as It Is—Non-Com-
mittal on Other Matters.

PORTLAND, April 26.—C. P. Hun-
tington of the Southern Pacific Co.,
who arrived here last night, when
asked to-day what object his visit
was said: "Our company has, as
you know, large interests, I am
directly concerned in the narrow
gauge line which we have bought.
We will undoubtedly change the
east side to a standard gauge and
will probably end by running it to
Eugene. The line on this side of
the river, however, will be allowed
to remain on a narrow gauge, be-
cause it can come into Portland
easily on that gauge." Will you
give your narrow gauge system the
same treatment with the S. P.
properties? "I can't say, in fact I
don't know just yet exactly what
we will do." "How about your
Astoria and Coos bay railroad of
which so much has been said?"
"Again I must evade you for I am
not prepared to state regarding
these matters." Avoided no more to
enlighten the public regarding your
intentions in the Pacific and
steamship matter? "Not now.
I could give you no direct informa-
tion for the matter has not yet
come to any stage. Geo. Gould and
I are pretty good friends, and I
think amicable arrangements will
be reached."

customs for investigation and re-
turn to China.

has given out.
