once to them is satisfactory. With the rapid destruction of timber throughout the country the need of a good substitute for wooden ties has become increasingly apparent. The steel rails of the period are to be bolted to the steel ties in such a way that spreading of the rails will be eliminated, and thus one cause of the railway accidents will be eliminated. That is an important advantage of the application of the new idea. At the same time, the "life" of a steel tie is expected to be many times greater than that of one of wood. Probably the time is not remote when the use of steel ties will become general on railroads in the more densely settled portions of the country, where "little timber" is available for the purpose. The friends of forest preservation will have good reason to welcome their use.
