### THE STRIKERS.

Chief Arthur Refuses to Answer Powderly's Letter.

HOW THE SITUATION STANDS

Deaf Mutes Kill and Eat a Child—Sunol Tots a Mile in 2:10 3-4—Ericsson's Remains.

New York, August 23.—Powderly this morning was asked about Chief Arthur's statement that the latter could not answer the letter which had not been addressed to him personally, but which had been given to the newspapers. He said: "Arthur never answers my communications. I send him. When I went to Cleveland I wired him I was going to meet him. Although I scoured the town for him I could not find him. He never has shown a disposition to meet me. All I want Arthur to do is to declare which side he is on. Is he for the workmen or for corporations?"

Troy, N. Y., August 23.—Nearly all the yardmen employed by the Delaware & Hudson company at Grene Island struck this morning. The men refused to handle the New York Central road's freight at this point. The Delaware & Hudson company is in progress. At 1:30 P. M. the freight had not yet got through with its report. It will probably be 5 or 6 o'clock before the council adjourns.

At 10 o'clock to-night the supreme council adjourned as a body and the work of the executive session all night and adjourned to the representatives of the press: "We have sent the following message to Powderly in New York: "The supreme council has been in session all day but no decision has yet been reached. We are now awaiting important advice. The council fully realizes our position and your order, and you may be assured your interest will get due consideration. You will be promptly advised of further developments."

New York, August 23.—Powderly to night wrote a reply to the statement of Webb, as follows: "I see you have at last ventured to break the silence that sealed your lips in relation to the causes which led to the discharge of 50 or 60 of your men. Your alleged explanation is even less creditable to you than silence, and does not in any way excuse the stand you have taken. Your statement is eminently worthy of men who can see no cause for an investigation into the cause of their own incapacity, breach of duty and insubordination. All these men have a right to know whether they were fired for cause. You cannot assert with any degree of accuracy that any one of these men were discharged for cause. You must indicate to us the names of the men who were discharged, and the reasons therefor. You must depend on the statement made to you by your subordinates—your superintendents and foremen."

### Salmon.

They Are Crowding the California Canneries.

SAN FRANCISCO, August 23.—Salmon are at present a drug in the city canneries. Those in this city are almost entirely sold, and are being mostly a limited capacity and are at present unable to handle all the fish. Another cause is that the fishermen along the Sacramento river formed a union early in the season, which is at odds with all the factories on the river, and members of the union refuse to sell any fish to the canneries. The firm of A. Lusk & Co. have taken advantage of the existing state of affairs and yesterday commenced to buy salmon. Isadore Jacobs, president of the firm, said: "We are now consuming 30,000 pounds of fish daily, and will continue to do so till September 1, when the season will close for one month. We are paying 1 1/2 cents a pound for fish that at other times is worth 3 1/2 cents."

Arrival of the Cruiser Charleston at Seattle.

A GERMAN SEAMAN KILLED.

Serious Trouble Between Hayti and Santi Domingo—Chinese Are Not Wanted.

PORT TOWNSEND, August 23.—The cruiser Charleston left to-day for Seattle for the purpose of taking coal.

SEATTLE, August 23.—The U. S. flagship Charleston arrived in port this evening.

As the cruiser steamed into harbor all the wharves and boats in sight were filled with spectators.

A salute of forty-four guns was fired to welcome and she returned with twenty-one guns. As soon as she came to an anchorage, about a quarter of a mile off the wharves, a delegation from the chamber of commerce went out to extend to her officers and men the hospitalities of the city. They were received with great cordiality by Admiral Brown and Captain Remay and entertained on board the vessel for about an hour. To-night Admiral Brown came ashore for a very few minutes. He says that he is here to get a supply of about 400 tons of coal and to look about the region for a site for a naval dry dock and a station. He has no further orders from the department, but is expecting them by Monday or Tuesday. He scouted the rumor that the ship is going to Behring sea.

The Charleston will probably be here for at least a week.

### WAR AGAIN.

Serious Trouble Between Hayti and Santi Domingo.

CITY OF SANTO DOMINGO, August 23.—Information has reached this city that on the night of August 20 3000 Haytian troops stationed near the frontier of Domingo rebelled and invaded that territory. The Dominican government dispatched an armed force to drive out the intruders. These troops repulsed and killed twenty-three men and wounded a number of others. The Dominicans had but four soldiers injured.

### CANNIBALS AT WORK.

They Kill the Crew of a German Lander Vessel—Samoa Again.

MELBOURNE, August 23.—Advices received here from the New Hebrides Islands say that the natives of Anauy Island, and the crew of a German labor vessel, a French war ship afterwards shelled the villages on the island. Advices from Samoa say that the consuls at Apia have issued a proclamation in which they warn the natives against entering into any intrigues to replace King Matafa.

### A Protest.

OTTAWA, August 23.—A protest has been received by the government from New Westminster against the granting of permission to Captain Whitelaw, American, to hunt whales in the Gulf of Georgia. The cause of the protest arises from the fact that Captain Cooper, of New Westminster, is just furnishing a steam vessel which has been built expressly for whaling in the gulf, and as his backers and friends think the privilege should not be handed over to an American. It is said the government will refuse the application.

### The Chinese Must Go.

PANAMA, August 15.—The isthmus has for some time been overrun with Chinese immigrants, and at last the natives have taken it into their heads that the Chinese are more harmful than beneficial to the country and that the influx had better be stopped. With this object in view an anti-Chinese society has been established, and through the efforts of this society a memorial numerously signed has been forwarded to the national government asking for the enactment of anti-Chinese laws. During an anti demonstration Sunday several Chinese were pretty roughly handled.
