GRIZZLY FIGHTING A MAN.

Couldn't Stand the Expense of Congress—New Cruiser—Idaho Democrats—Ben Wilson for Governor.

GLOBE, A. T., August 26.—Upon a warrant issued from Gila county (Guadalupe) Globe, an Apache, is now in the Gila county Jail on the charge of the murder of Ed Baker, in Sierra Ancha, this county, on July 17th. This Apache's name was not given.

Others of his band were apprehended at Fort Apache yesterday and held, awaiting the arrival of the Gila county sheriff for their removal to Globe. Guadalupe is employed by the government as a secret service man. Two of his sons are also prisoners for the same offense, and also under duress; they are scouts. The circumstantial evidence is strong.

FIGHT WITH A GRIZZLY.

Two Farm Houses Burned by Incendiaries.

WALLA WALLA, August 26.—This afternoon F. M. Elin was brought to the city from the mountains badly wounded in an encounter with a grizzly. The bears were killing his sheep and he started to hunt them. He shot and crippled one of the bears. The bear grabbed him and would have killed him but for the interference of his dog attacking the bear. He dropped Elin, who grabbed his gun and killed the bear. Many deep cuts were made by the bear's claws, but they are not dangerous.

Monday afternoon the farm residence of W. F. Osborne was destroyed by a fire of incendiary origin. The family were away. Loss \$2500, with no insurance. The same day the residence of C. Sanders was burned, with the contents and furniture was \$4000; insurance, \$1200.

TRIAL RUN.

The New Cruiser San Francisco Makes Thirteen Knots.

SANTA BARBARA, Cal., Aug. 26.—The new cruiser San Francisco, which left San Francisco harbor yesterday afternoon, made her official trial run in Santa Barbara channel, arrived off here this morning, having made the run of nearly 300 miles in about twenty-two hours, at an average speed of fraction over thirteen knots per hour. She will make her trial run to-morrow.

MORE OF THE STRIKE

The Abduction of Little Annie Redmond.

NATURAL GAS FOUND IN TEXAS

He Swam Fifteen Miles—Irish Detention—Struck a Cow—Chicago Theatre Burned—Voting on the Tariff Bill.

M'VICKEE'S THEATRE

Was Burned in Chicago Last Night.

CHICAGO, August 26.—McVickie's theatre, the pride of an amusement district, was destroyed by fire this morning. The fire is thought to have been started by a small fire blazing in the entrance, between the lines of the dressing rooms, back of and under the stage. He started flames and continued on his rounds. About 3 o'clock he found another blaze under the auditorium, where no one ever goes except the watchman. The flames spread with great rapidity, and in spite of the efforts of the firemen the entire auditorium was gutted. The front of the building was occupied by offices and was saved by a fire wall. Shenandoah, under the management of A. J. Hayman, of San Francisco, was running at the theatre and to-night was to be its hundredth performance and sonnet night. All costumes and properties were destroyed. Hayman telegraphed for a duplicate set, now in New York, and secured the Auditorium building. The loss to the theatre is \$200,000; to the company, \$1,000. Four firemen were seriously hurt, one probably fatally, by the falling roof.

CALIFORNIA PRUNES.

A Car Load of Them Shipped to Chicago.

SAN FRANCISCO, August 26.—The first car load of California prunes was shipped to Chicago to-day from Santa Rosa. The shipment is earlier in the season than usual. The first car load of dried grapes of this season's crop was dispatched this afternoon by Porter Bros.

Wrestling Match.

SAN FRANCISCO, August 26.—E. Lewis and Angus McLeod wrestled to-night for \$50 a side. The conditions of the contest was that Lewis should throw McLeod three times in an hour. He won the first fall in 29 minutes; second in 4 minutes and 1 second and the third in 11 minutes, thus winning the match.

A Heavy Rain Storm.

WHEELING, W. Va., August 26.—The heaviest rain storm in the year began here this morning. Streams are badly swollen. Wheeling creek and Caldwell river, which flow through the city, are raging torrents. All the streets in the city are like rivers. At Uniontown many manufacturers were compelled to close down. Many bridges are swept away and the rain still continues.

Opened a Vein of Natural Gas.

NEW YORK, August 26.—A dispatch from Paris, Texas, says that Charles Gooding, who lives in Indian territory, thirty miles from this city, employed Michael Duhany to dig a well on his place. Last Saturday Duhany had reached a depth of sixty feet, when he came out for his dinner. On his return he had been lowered twenty feet when he screamed to his assistants to haul him out quick. A GIANTIC SCHEME.

The Trip from Chicago to London to be Made in Seven Days.

QUEBEC, August 26.—The most gigantic railway system ever projected in Canada, with the single exception of the Canadian Pacific is about to be started. The promoters are chiefly French and English capitalists. Sir Hector Langevin, minister of public works for the Dominion, and Sir Charles Tupper, high commissioner for Canada in London, are largely interested parties. The scheme is to build a railway eastward from Quebec, some 80 miles, to St. Charles Bay, on the Labrador coast, from which point large steamers are expected to make the voyage to Milford Haven, in Wales, in three and one-half days. By this route it is expected that passengers and perishable freight can be carried from Chicago to London in less than seven days.

The company calls itself the North Canadian Atlantic Railway and Steamship Company. The capital of the company is \$20,000,000 but it has authorized itself to bond its road for the purchase of steamships.

Provisional directors include Henry Isaacs, lord mayor of London; Robert N. Fowler, M. P.; Banker Thomas Woods, of Milford; Charles G. Mott, director of the Great Western railway; William K. Batch, banker, London, and Sir Douglas Fry, the eminent English engineer, who is also consulting engineer to the company. The head office of the company is in England, and the English directors have sent one of their number, Mr. Batch, to make preliminary arrangements. The company will have 5000 men at work by spring.

The Destitute of Ireland.

LONDON, August 26.—The Chronicle advocates the migration from the congested districts in Ireland to the waste lands which only require to be reclaimed and cultivated to afford subsistence for the surplus population. It exhorts the government to take immediate action and not wait until the people are enfeebled by hunger. All true patriots, whether home rulers or not, it says can join in this humane task.

Mine on Fire.

VICTORIA, B. C., August 26.—A message received from Nanaimo this afternoon said No. 3 shaft of the Wellington mine on fire and will have to be flooded. There were only two men in the mine at the time and they escaped. The fire is out of order and it is not known how the fire started as no cause has been ascertained. No further details were received.
