been a severe shrinkage during the past week. Corn has risen five-eighths of a cent, with exports much below last year's and oats are also a cent stronger. Lard has risen 30 cents per 100 lbs. and hogs, being very freely delivered at the west because of threatened scarcity of corn for feeding, are 25 cents lower. Cotton has declined nine-sixteenths for spot, and receipts for three weeks have been 19,500 bales, against 9,000 last year, while exports have been 30,000, against 29,500 bales. Coffee and sugar have been held steady, but oil is 6-1-4 cents lower.

It is a matter of regret that congressmen, in the discharge of their duties cannot eliminate the partisan bias, but mainly push the measures they advocate with an eye single to the partisan advantages. The Tribune goes after Senator Reagan, who is a strong advocate of the irrigation measures upon this phase of the question: "Senator Reagan would better look out how he dandles with that irrigation business. He must remember that for the last thirty-five years he has been construing the Federal Constitution through a reducing lens, at one time getting it so small and so remote that it was away out of his sight. He knows that this method of regarding it will keep the southwest dry and arid, and he knows that the southwest is hungry for an appropriation which will give it a system of irrigation. The senator is thus hard pressed between his principles and his interests. Now, if he would only conclude that the constitution had provided us with a National Government and not a sort of political free-love bargain, he could help Texas to water conscientiously."
