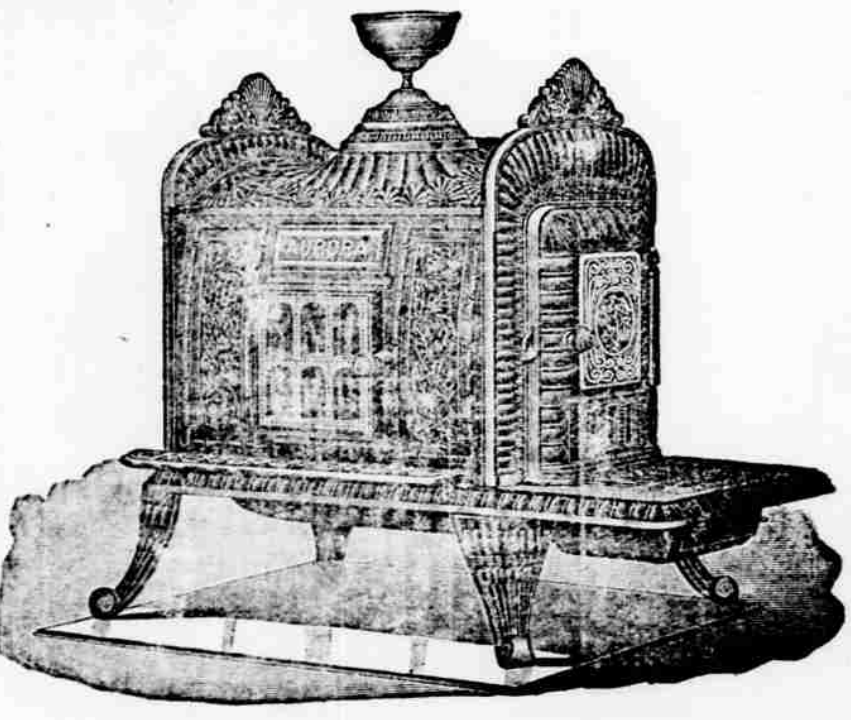

NEAR SHIPWRECKED.

Congressional Action on Numerous Measures.

GOV. FOREST NOMINATED

Army Reorganization at Toledo—Cable Road Accident—Porter Nominated in Ohio—Various Incidents.

SAN FRANCISCO, Sept. 17.—The British ship, Queen Victoria, from Tacoma, which was laden for Cork, put into port this morning in distress. She was caught in a hurricane which lasted three days. The cargo shifted and six hundred sacks of wheat were jettisoned and for thirty-six hours the starboard rail was under water. In talking about the affair Captain Holmes said: "We sailed from Tacoma on the 3rd of August last, with 44,800 sacks of wheat on board. Our destination was Cork, Ireland. We had fine weather up to latitude 18 north, longitude 127 west, about 300 miles off shore near Cape St. Lucas. Then for three days we had light, baffling winds, and on the 19th of August the barometer fell and it began to blow a hurricane. It lasted for forty-eight hours, during which the cargo shifted, and the vessel lay on her beam ends with her yards in the water. Ventilators were sove in the cabin doors torn away, the forward house washed overboard and to make matters worse, we had to jettison about six hundred bags of grain. On the 22nd of August I put about and made for San Francisco, to have the ship surveyed."

STATE FAIR.

A Very Successful Exhibit—Large Crowd.

SPECIAL TO THE HERALD. SALEM, Sept. 17.—The crowd at the fair ground to-day exceeded that of the same day of any previous year in the history of the fair. The pavilion presents a very neat appearance, having been cleaned and painted a snow white throughout. Every available inch of space is occupied with exhibitions and the cry is "more room."

THE EXHIBITS ARE ALL IN PLACE and tastefully arranged, and the various committees are now busily engaged in making the more of less worthy the blue and the red ribbons.

In the art department the most worthy of mention, per aps, is two large paintings by Miss Eiele, of Portland. One represents one of the Yukon glaciers, and the other "The Last of the Tribe," an Indian scene. They are valued at \$600 each.

One of the largest exhibits is from the Agricultural college at Corvallis. It contains 425 different varieties of potatoes and 160 varieties of wheat, oats, etc.

The exhibit of stock is away beyond any former exhibit, and the blue ribbon is being tied to the successful exhibitors to-day.

As is usual the greatest attraction is the races. The first to-day was the running 3/4 mile dash. It was an exceedingly well contested race, and a close finish, Eclipse winning from Wade by only six inches in the last time of 1:02. The best time at Portland for the same race was 1:03 1/2.

For the 2:26 trotting race six horses entered. Kitty Ham won the first, third and fifth heats. Lady Beach won the second and fourth. The time was 2:27 1/2, 2:23 1/2, 2:23 1/2, and 2:31.

The free for all race was pacing. It was postponed until to-morrow at 12:30 o'clock.

FEARFUL ACCIDENT.

A Cable Road Car vs. the Garbage Wagon.

CINCINNATI, Sept. 17.—The coolness and self possession of a conductor on the Sycamore street cable road to-day prevented an awful horror. Some forty passengers were aboard when the car reached the top of Sycamore street hill, a descent of fully half a mile, with an average of thirty-three degrees and an elbow curve. Just as the train consisting of two cars came around the curve at the top of the hill, the gripman noticed one of the Mulberry street sewer cisterns. He rang for them to clear the track, but the driver was unable to do so. He then rang for brakes, but they refused to work. The train started at a fearful velocity. By the time three squares had been traversed the train was flying like the wind and screams and yells of fear filled the air. It was only a square to the garbage wagon. With a frightful crash the grip car struck it and dashed it into a hundred fragments. A square further on a big beer wagon was on the track. The noise of four wheels made prevented the driver from hearing and it looked as if death was ahead. Then the conductor, who was beside the gripman, dashed back among the frightened people in the rear car and put on the stop break at the risk of his life and stopped the car a foot away from the wagon. BANK ROBBERY.

REPUBLICAN CONVENTIONS.

England's Policy Is Not Liked in Portugal—Prince George in Canada—Kennedy's Speech.

THE DALLAS, Oct. 17.—The largest robbery ever known in this city was made public this morning. The First National bank of Dallas was robbed of \$500,000 Tuesday morning early. The discovery was made the same morning by H. M. Seal, cashier. The matter was kept quiet to allow the detectives to procure a clue if possible. The vault was tunneled up through the concrete pier on which it stands, and a small hole drilled in the back corner of the safe. The work showed professional burglars to be the culprits, as it could not have been done by novices, who would have required three weeks to accomplish the job. The cashier smelled sewer gas for ten days each morning when the safe was opened. About \$5000 was left in the safe. The directors met yesterday and replaced the loss. A new safe has been ordered with the latest improvements. It will be placed in the vault in such a manner that the officers can go all around it. The bank opened for business yesterday morning. The directors congratulate themselves that the loss is no larger.

PRINCE GEORGE'S VISIT.

Grand Banquet Tendered Him Last Night—A Newspaper Man's Joke.

QUEBEC, Sept. 17.—The banquet given last night in honor of Prince George surpassed in its splendor anything of the kind before attempted here. Among the guests were Admiral Watson, Lieutenant-Governor Angier, the officers of the men-of-war now in port, government officers and cabinet ministers.

MONTEBELL, Sept. 17.—Richard O'Brien, who is charged with sending out the report that Prince George of Wales had been mixed up in a fight, appeared this morning before Judge Desnoyers and pleaded not guilty. He was released on his own bonds of \$500, with two sureties of \$500 each. He has retained the services of two leading criminal lawyers here and will contest the case. He says that he got his information from what he considered a good source, but thinks that he was the victim of a practical joke. The feeling against him is very strong, and the prosecution intends to resort to extreme measures.

THE BLUE ROOM REFITTED.

Secretary Bask Presented With a Bust in Bronze Congressional Bad Boys.

Special Correspondence. WASHINGTON, D. C., Sept. 15.—Mrs. Harrison is not only one of the best, if not the best, housekeeper, using that word in the sense which our mothers and grandmothers did, who ever occupied the White House; she is also a very clever artist, and had she not chosen a higher sphere, in raising family, she would probably have filled a niche in the temple of fame. Future visitors to the White House will have an opportunity to judge her artistic taste, as the famous blue room is now being decorated from plans prepared in accordance with her ideas and under her personal supervision. The work is being done in three shades of blue—it will be considered but little short of sacrilege to change the color by which the room has been known since it was a room. A duel to death would be a fitting climax to the numerous personalities by which the present administration of congress has been disgraced in the House and of the Capitol building, and such a duel is regarded by many as among the possibilities. The parties to it are Senator Blair and Senator Reagan, and the quarrel took place in the senate chamber, the cause being the tariff bill. Neither of the gentlemen violated parliamentary rules by indulging in billingsgate. Nevertheless each of them managed to let the other, and incidentally everybody else, know the contempt he felt for him and both of them estimated very badly that they were prepared to hold themselves personally responsible outside the chamber, where no restraints made regarding the other. It is not believed that Senator Reagan has any prejudice against the code of honor as a means of settling differences between gentlemen, and his courage is unquestioned; and it is known that in spite of his New England education and religious ideas that Senator Blair will fight a duel if challenged. He so stated several years ago when it was expected that another Senator would challenge him.

In the meantime, however, the district attorney had made a thorough examination, and yesterday presented the case to the grand jury, which indicted him.

When the defendant's name was called in the police court to lay his attorney on record, and asked for a continuance, but Deputy District Attorney Hume cut matters short by informing the court of the existence of the indictment, and gave the further information that Deputy Sheriff Lounsbury was in waiting with a bench warrant for Bloch.

The judge thereupon suspended proceedings in the police court, and remanded the defendant to the custody of the deputy sheriff.

The warrant fixed his bail at \$250, which Bloch immediately furnished, and was then released, subject to the call of the state circuit court.

Miss Meekline, the victim, is still confined to her bed, and, while very ill, is much better than she was yesterday, and it is thought she will soon be able to get about.
