HEAVY FIRE.

The Losses Will Undoubtedly Be

DETROIT, Sept. 19.—A special

petals. One of the inner sets of

these divisions differs from the

ness and beauty. Orchids are

found in all warm and temperate

parts of the world, although they

are more abundant in the tropics

than elsewhere. They are peren-

nial plants, often with tuber-

bearing roots, and the peculiar

structure of their flowers renders

impossible their unaided fertiliza-

tion, for which they depend on

the visits of insects.

Legislation on Naval Affairs.

WASHINGTON, Sept. 19.—The

house committee on naval affairs

has ordered a favorable report on

the senate bill to pay Crow, of

the United States ship Talapoosa,

for clothing lost by the sinking of that

vessel. The bill providing that

relieved naval officers who have

served a full term, as chief of

bureau, shall receive the rank and

pay of commodore, was also re-

ported favorably.
