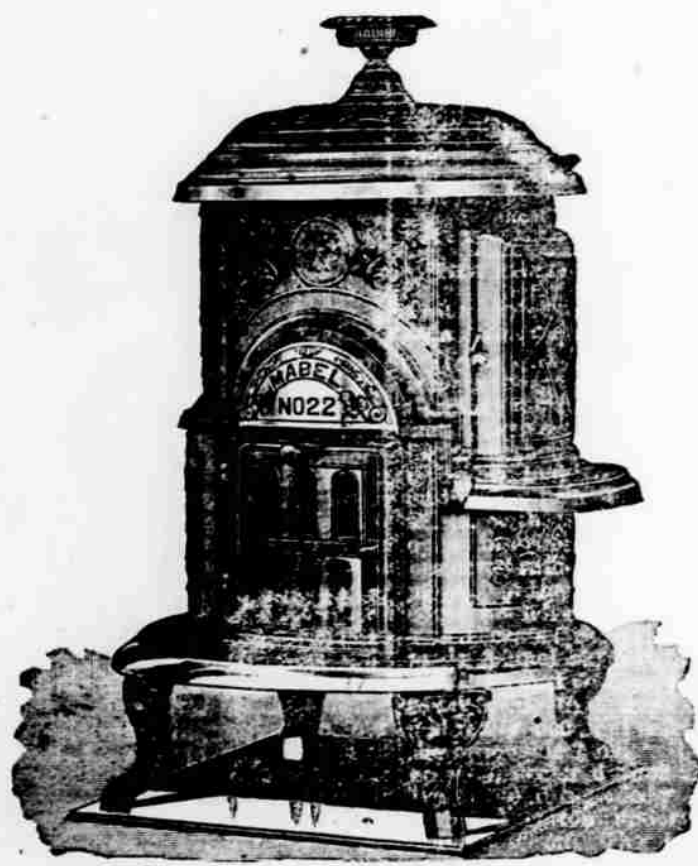

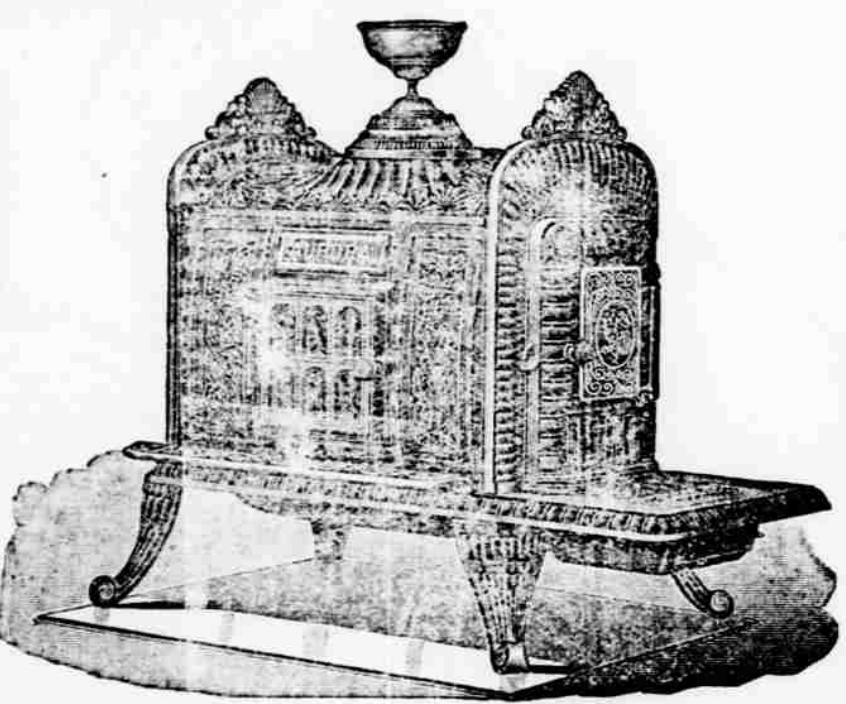

RUN OVER.

A Rain in California Does Considerable Damage.

BOUND BY A CONTRACT.

Vessels Sailing A Fearful Explosion

Relief For Farmers Devastated

Weather Report.

STOCKTON, Cal., Sept. 24.—Richard Verber, who ran over a Chinaman named Tie Yee Chung on the 22nd inst., was brought before Justice today for preliminary examination, on a charge of manslaughter.

After the testimony of several witnesses the court adjudged the evidence insufficient to cause a jury to convict and discharged the defendant.

A man answering to the description of Peter Oleson, the murderer of Mrs. Oleson in Napa county several years ago, was arrested here today and lodged in jail. The man claims that his name is August Oleson.

RAIN IN CALIFORNIA.

Fears That Considerable Damage Was Done

FRESNO, Cal., Sept. 24.—Quite a heavy shower of rain fell here this morning and the heavens still look threatening. No damage has as yet been done to the grain crop, but a continuance of cloudy and moist weather will do irreparable injury. Over a million dollars worth of undried raisins and green grapes are yet in the vineyards and fully as much grain lies exposed in the fields and much anxiety is felt.

THE GERMAN CATHOLICS.

To-Day's Proceedings of the Congress at Pittsburg, Pa.

PITTSBURG, Sept. 24.—The German Catholics had an important meeting this morning. At the last congress in Coblenz it was suggested that all German Catholics in the United States be organized into a national patriotic league. In accordance with this suggestion the following was adopted:

In view of the proceedings at the German Catholic congress of Coblenz, Germany, and with the conviction that a well-defined organization of German Catholics in the United States will be not only a means to foster religion and morality, but a necessity to oppose heresy on many people.

Resolved, That it is the wish of this congress that every German Catholic parish in this country young men's societies be founded for such aims as will be best for local needs; that in German Catholic centers of the United States centralization of such local societies be effected under such regulations as suit the surroundings and circumstances; that the central organization, which does already exist in Chicago, be offered the thanks of this congress for its zealous works, and that its constitution be recommended as an example to be emulated.

COULD NOT ACCEPT.

Is Bound by His Contract Until May.

SAN FRANCISCO, Sept. 24.—Archie McComb, a well-known sprinter of America and Australia, died last night of pneumonia. Jim Corbett today received the following dispatch from the Metropolitan club, New Orleans: "Will you meet Kilrain in a limited number of rounds for \$500 purse?" Corbett said he is unable to accept the offer until he leaves the Olympia club in May.

Relief For Mrs. Fremont.

SAN FRANCISCO, Sept. 24.—The work done in this city in the matter of raising money for the relief of Mrs. Fremont and her daughter has thus far been simply in the nature of preparation. L. M. Holman, president of the Nevada bank, has been chosen treasurer of the proposed fund, but has received no contributions or money from any source. The executive committee of the Native Sons' general committee met last night, but took no action in the matter. It will be considered by the general committee, which will meet in about ten days.

Weather Report.

SAN FRANCISCO, Sept. 24.—For Oregon and Washington: Fair weather except light rains at Walla Walla, Portland and Olympia. Variable winds in the eastern portion, northerly winds in the western portion, cooler in the eastern portion and stationary temperature elsewhere, except warmer at Portland and Olympia.

Mail Car Burned.

SAN FRANCISCO, Sept. 24.—The mail car on the Oregon Short line was burned west of Ferry, Idaho, on Monday night. The paper mail was more or less damaged. No particulars as to how the fire originated has been received as yet. Whether the letter pouches were burned or not has not been ascertained.

Meeting of Passenger Agents.

CHICAGO, Sept. 24.—A meeting

of the Western Passenger Association was held today to consider the threat of the Duluth, South Shore & Atlantic to reduce the passenger rates from St. Paul to New York. Such course would affect all northwest business as far west as the Pacific, but the Chicago lines were averse to reducing rates until they knew just what the South Shore intended to do. The statement was made that the South Shore had all the lower cutting rates and a resolution was unanimously passed informing General Passenger Agent Hibbard of the South Shore, that the Chicago roads would redeem from him all tickets bought from scalpers if he would exchange the proposition.

SOCIALISTS SUPPRESSED.

Not Permitted to Have a Demonstration in Brooklyn.

BROOKLYN, Sept. 24.—Socialists who intended to caricature the Jewish fast of atonement last night did not have the opportunity. At an early hour in the evening Mayor Chapin issued a special order to the superintendent of police not to allow any demonstration at the labor lyceum in Williamsburgh. The action was taken after the socialists had been translated to him. It announced that there would be a speech on "Powder for religion and dynamite for duty," the burlesque having for its theme the assassination of God and that John Most would deliver an oration. Forty policemen were stationed in front of the lyceum at 6 o'clock and performance was allowed. Keppeloff, president of the society, was on the ground early, but decided to accept the invitation to protect those who had only intended to celebrate according to Talmud. Keppeloff said Most was not to speak until to-morrow night.

THE GERMAN CATHOLICS.

To Be Heard in the Morning—Other Suits Filed To-Day.

PORTLAND, Sept. 24.—To-morrow morning in the circuit court will hear the petition of Elizabeth Mocklin, the mistress of M. M. Bloch, for a writ of a habeas corpus. In her petition she says that she is unlawfully restrained of her liberty by Sheriff Kelly in a room on Third and A streets.

She alleges the belief that she is thus restrained of liberty to compel her to appear for the prosecution for manslaughter.

Charles Gilmore has begun an action against the Southern Pacific Railroad Company for \$10,000 for damages for injury sustained while traveling on the defendant's road on the 12th of April, 1890.

Johanna Schmeer against John P. Schmeer for a decree of divorce.

The parties were married in this city on the 31st of October, 1887.

The grounds set up by the defendant are extreme cruelty, habitual drunkenness, etc. The plaintiff also asks that the defendant be restrained from disposing of the community property during the pendency of this suit, and such other relief as she may be entitled to.

THE EXPOSITION.

Getting Ready For the Grand Opening.

PORTLAND, Sept. 24.—The city is rapidly filling up with strangers who desire to be present at the opening of the Exposition to-morrow night. All the hotel registers are crowded with long lists of names, and hundreds of cots which have been stored away since last Fourth of July have been cleaned up for service in halls, and on the roof, if necessary.

All the officers and directors of the association, together with the invited guests, will assemble on the platform at 7:30 o'clock to-morrow evening. The band will execute one number of the music, when President Frank Dekum will introduce the orator of the evening, Hon. M. C. George. At the conclusion of the address the president will declare the Exposition formally opened, when little Miss Alene M. Woods will press a button which will set the machinery in motion and throw the grand edifice into a blaze of brilliancy such as which has never been seen in this state.

Miss Woods is the daughter of Mr. M. Woods, who has superintended all the electrical work of the institution. She will be superbly dressed, and will be encircled by a halo of small electric jets. The great tower, with its thousands of lamps of all colors, will be illuminated with the same movement that will start the machinery. This will be done promptly at 8 o'clock, and for one month thereafter the building will not slumber.

British Ship Ashore.

SAN FRANCISCO, Sept. 24.—A dispatch to the merchants' exchange states that the British ship Selene went ashore at Santa Rosa Sept. 21st and that the R-salia is a bay on the west coast of Mexico. Selene was an iron vessel of 1043 tons burden, and was owned by K. D. Clink, of Greenock, and commanded by Capt. Crook.

THE DAY IN CONGRESS

Kennedy Is Censured for His Conduct.

THE GERMAN CATHOLICS.

The Birchall Trial—The Passenger Agents—Would Not Accept—A Neighbor's Quarrel.

WASHINGTON, Sept. 24.—In the house to-day Miller, of South Carolina, who was yesterday declared elected from the seventh South Carolina district, appeared and took the oath.

The committee on foreign affairs reported a resolution calling on the president for information relative to the killing of General Barandua. Mr. Henry, of Kentucky, strenuously advocated the resolution. The resolution was adopted.

Stewart, of Vermont, from the committee on judiciary, reported the following:

The house denying it a high duty that the utmost courtesy and decorum demanded by parliamentary law and precedent should mark the mutual relations of the two houses. Congress, does hereby express its disapproval of the unparliamentary language used by Hon. Robert P. Kennedy, representative from the state of Ohio, in a speech delivered on the floor of the house on the 3d day of September, 1890, and published in the Congressional Record of September 4, 1890, and considering it impracticable to separate the unparliamentary portions of said speech from such parts thereof as may be parliamentary; therefore be it

Resolved, That the public printer be directed to exclude from the permanent Congressional Record the entire speech of Hon. Robert P. Kennedy in the first resolution mentioned.

Kennedy made an eloquent speech in his own defense, making no reply to the charge of his previous remarks.

The resolution was passed, 151 to 35.

IN THE SENATE.

Frye offered a concurrent resolution (agreed to) directing the secretaries of state, treasury, war and navy to examine the reports and recommendations of the international marine conference of February, 1890, and submit to congress bills or the enactment into a law of such recommendations so far as they apply to their respective departments and meet with their approval.

The senate then proceeded to the consideration of bills on the calendar unobjectioned to. Among the bills passed was the senate bill in recognition of the merits and services of Chief Engineer George Walker Melville and other officers and men of the Jeanette Arctic expedition. It provides for the advance of Melville one grade, and for a medal to each of the survivors and heirs of the dead.

He introduced a joint resolution which went over without action, authorizing the secretary of the navy to purchase at his discretion nickel ore or nickel matter to be used in the manufacture of nickel steel armor plating, armor piercing projectiles and other naval objects, and appropriating \$1,000,000 for the purpose.

The senate passed, 15 to 6, its substitute for the house bill to define and regulate the jurisdiction of courts of the United States.

A LADY'S NERVE.

Saved Her Brother and Foiled the Burglars.

BRAXTON, Pa., Sept. 24.—A very daring attempt to rob the Peoples' bank here was frustrated by the shrewdness and prompt action of an observing young lady, who lives just opposite the bank.

Cashier Womer and his left and Assistant Cashier Elmore Hauer was alone behind the desk in charge. His first visitor was a short, thick-set, strange man with a dark beard, who asked a number of green questions about sending a newspaper.

The next man to enter was a tall person, also a stranger, who, seeing that the assistant cashier was engaged, and apparently being in no hurry, stood in the middle of the door, opened wide a large newspaper and seemed to be reading.

A third man of the party also had just come in, was a light built young fellow with smooth face. The latter's movements were completely hidden from the cashier's sight by the tall man, who stood up, holding spread out his newspaper. Suddenly the young man, unseen, dropped upon his hands and knees and crept around the counter toward the open vault of the bank and toward where Cashier Hauer was sitting.

The young man had a sash clasp in his hand, probably to knock Mr. Hauer unconscious, but before he got near enough a young woman briskly entered the bank.

The tall man with the newspaper turned sharply around, still holding the sheet up so that the lady could not see in the direction of the cashier.

"What do you think of this picture?" he asked, and then, quickly, "Someone is calling you from the opposite side of the street."

The young woman quickly stepped away from the men and shrieked out:

"They are robbers; there is one

sneaking on his hands and knees. Look out, Elmore, they mean to kill you."

Cashier Hauer quickly turned, seized his pistol, and a moment later the three would-be burglars dashed for the door and escaped.

The young lady was Miss Hauer, the cashier's sister, who lives opposite and who saw the strange men acting suspiciously.

TERRIBLE EXPLOSION.

It Results in Several Horrible Deaths.

TRANTON, Sept. 24.—An explosion occurred in the Fegger colliery near this city this morning. The inside works were set on fire and a force of men had all they could do to extinguish the flames. Those Ward, of Branchville, was killed by the explosion, having been literally roasted to death. James Line and Albert Miller were horribly burned and may die.

Nei hours' Quarrel.

ALBUQUERQUE, N. M., Sept. 24.—Richard Page, living on a ranch five miles below this city, was shot yesterday afternoon by Uriah Stevens, a neighbor. The latter had built a ditch to irrigate his land. Page filled up a part of the ditch, the water therefrom backing into the residence of Stevens. On being remonstrated with, Page became threatening and swore at Stevens, when the latter returned into his house, securing his shotgun, emptied both barrels at Page. He is in a critical condition.

SAN FRANCISCO, Sept. 24.—"Cleared": Steamer Janie for Port Townsend, sailed; Bark Federal for Port Townsend; steamer Columbia for Portland.

Flume Progressing.

W. L. Maple of the Green Basin Lumbering company, came down yesterday. The company have their flume half completed, and will be landing lumber at Green Basin siding in about four weeks.

Mr. Maple will erect a hotel building at Green Basin siding to accommodate the increasing demands or accommodations at that place.

WASHINGTON NEWS.

A Very Brilliant Society Season This Winter.

THE CHINESE MINISTERS.

Vice-President Morton Returns to Washington—A Monument to Ericson.

WASHINGTON, D. C., Sept. 24.—Somebody has said that "every celebrated man or woman of the age may be seen in Washington," and I am inclined to believe the statement true, if one waits long enough. I saw a man yesterday who two generations ago was talked about by everybody. It was Gen. Daniel Sickles, now sheriff of the city of New York. He was seated in a cab, his crutches by his side, and was driven within a few feet of the spot whereon he shot and killed a man for flirting with his young and beautiful wife, and if I was not mistaken I saw him cast a hurried, half frightened glance at the house, now occupied by the family of Secretary Blaine, out of which his victim came that fatal day. Gen. Sickles is now an old man, and his face is probably not known to fifty people in Washington. It struck me by a queer coincidence that not two hours before I saw him an old Washingtonian should have been telling me about the sensational incidents which attended the trial of Sickles for murder, and of how Sickles played the crazy dog, then comparatively new, so well that the jury acquitted him.
