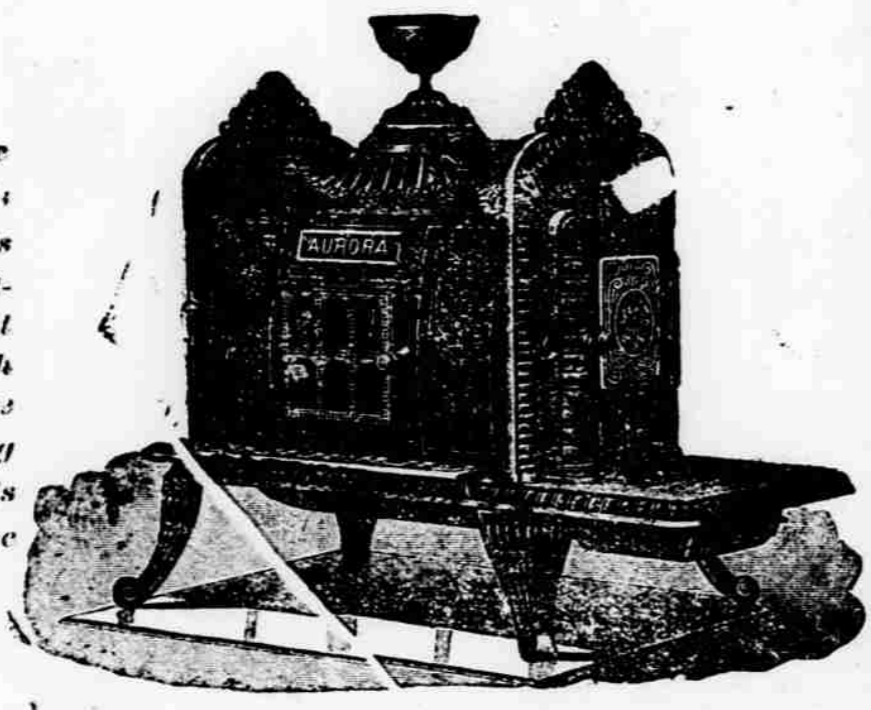

### CHAUNCEY M. DEPEW.

He Talks Very Flatteringly to an Engineers Brotherhood

McKinley and Reed

Sale of Blooded Stock—English Babbs Buying—Quarrel For Progress

PITTSBURGH, Oct. 16.—A school of Locomotive Engineers held a meeting here to-day. Among the addresses was one by Chauncey M. Depew. Mr. Depew spoke highly of the Brotherhood of Locomotive Engineers and said that during the period of its existence and prosperous growth hundreds of labor organizations had been formed and dissolved. It had been started to carry out novel theories and to put in practice mutual aid and united processes. The success of your body is due to its rigid adherence to the right principle upon which it was founded. No labor organizations can permanently succeed whose sole and only object is to increase wages and to diminish hours. The tendency of such organizations is inevitably and rapidly to collisions and failure. The fundamental idea of the engineers' brotherhood is, first, charity in support of the sick and injured, second, contributions to the care of the dead, second, education, which perfects the artisan in the theory and practice of his trade, and broadens him for larger usefulness as a citizen. Third, protection, securing and maintaining contributions to the law of the land, which protects the history of contact between employer and employe, at home or abroad, and the intelligence and prosperity of your members. Mr. Depew spoke of the all-pervading idea of the past few years of truth, and said this universal effort to absorb individuality, to divide people into employing companies and employes, and to destroy competition, will inevitably end in disaster. Hostile legislation and laws of trade will leave only the legitimate enterprises surviving.

Speaking of the recent strike on the New York Central, Depew said: "Years of a successful trial of fair, frank and friendly discussion between the engineers and the N. Y. Central had led me to believe a strike was impossible on that road." In that trust he went abroad on his annual holiday, to have his hopes shattered by a cablegram announcing the strike. "Messages and reports," he said, "were true to the relation which, for many years had been established, and sustained and reinvigorated my fading faith in the efficiency of any effort to maintain a satisfactory and permanent understanding between capital and labor. The citizens of New York, and of the whole country owe to the Brotherhood of Locomotive Engineers a debt of gratitude for the courage, fidelity and intelligence with which they stood by their posts and performed their duties during the recent troubles on the New York Central."

### MUCHLY MARRIED MAN.

Later Developments in the Life of William Spencer.

New York, Oct. 16.—Much interest has been excited by the story of the eventual life of William H. Spencer, of this city, who died suddenly in a Chicago hotel a fortnight ago, and whose body was cremated last Sunday at Fresh Pond, Long Island. Spencer was a son of the treasury, and he married Tyler's daughter. It is stated that the couple were twice remarried. A curious development in the case has been the discovery of two other wives and a daughter left by him. A contest between the two widows over the estate of deceased is expected to follow.

### Sale of Blooded Stock.

New York, Oct. 16.—This afternoon at the entire stock of the Ferncliff stud of brood mares, imported and native stallions, the property of Wm. Astor, was sold at auction. The sale aggregated \$89,475.

### MURDEROUS DESERTERS.

Fire Upon Their Captor, and One Is Instantly Killed.

BUTTE, Mont., Oct. 16.—Two colored soldiers deserted from Fort Shaw last night. Before leaving the garrison, they helped themselves to two horses belonging to a government scout. The scout pursued the deserters and captured them this morning near Hardy station, six miles from Cascade, and started back with them. They offered no resistance at the first arrest, but while being taken to the stockade of the fort, one of the deserters pulled a revolver and shot Roanoch in the chest, who was armed with a shotgun, immediately returned the murderous fire and shot his assailant dead. The other deserter made his escape to the hills, wounded, on one of the stolen horses. Roanoch's wound is not dangerous.

### A Murderer's Suicide.

FRESNO, Cal., Oct. 16.—Ah Gee, a young Chinese murderer, under sentence of death for killing a Chinawoman some months ago, committed suicide by taking opium in the county jail early this morning. He attempted to escape last night, but was captured, and a watch put in his cell, but he secured the poison in some manner. A doctor was sent for, and every effort made to save his life without avail.

### Dividend Declared.

CHICAGO, Oct. 16.—At the Pullman Palace Car Co. meeting to-day the annual quarterly dividend was declared. Total assets of company are \$43,013,550, net earnings for year were \$2,388,130.

### Pickpockets Escaped.

KANSAS CITY, Oct. 16.—To-night it is learned that the robbery on the Missouri Pacific, last night, was committed by a gang of five pickpockets, probably of the bed. Several passengers were robbed. The thieves escaped.

### A DIZZY EGG DANCE.

A Defiance That Vies With the Skill of Sleight-of-Hand Performers.

One of the latest and most entertaining of the writers on artistic lands and peoples, says the New York Journal, is M. Louis Rousselet, a Frenchman, who has been touring in India for four or five years, making meanwhile a skillful use of his pen and pencil. One of the remarkable things he describes is the "egg dance." This is executed in this wise: The dancer, dressed in a costume and very short skirt, carries a willow wheel of moderate diameter fastened horizontally on the top of her head. Around this wheel threads are fastened, equally distant from each other, and at the end of each of the threads is a slip of paper, which is kept open by a glass bead.

Thus equipped the young girl comes toward the spectators with a basket full of eggs, which she passes around for inspection to prove that they are real and not inflated balloons. The music then strikes up a jerky monotonous strain, and the dancer begins to whirl around with great rapidity. Then seizing an egg she puts it in one of the slip-nooses, and with a quick motion, throws it from her in such a way as to draw the knot tight. The swift turning of the dancer produces a centrifugal force which stretches the thread out straight like a ray shooting from the circumference of the circle. One after another the eggs are thrown out in these slip-nooses until they make a horizontal aureole about the dancer's head. Then the dance becomes more rapid, so rapid, in fact, that it is difficult to distinguish the girl's features; the least false step, now, and the eggs dash against each other.

### OLD BOARD RE-ELECTED.

The Rate of Dividend Recommended to Be Increased.

New York, Oct. 16.—The Northern Pacific election to-day there was no contest, the election of directors resulting in the old board being re-elected except E. H. Abbott and D. S. Wegg, who were succeeded by C. Scamman and C. H. Leland. A resolution recommending the directors to increase the rate of dividend or declare an extra dividend passed. The directors organized by re-electing old officers and electing George H. Earle secretary, to fill the vacancy caused by the death of Samuel Wilkinson.

### HE WAS SUSPECTED.

And If He Is Proven to Be the Man.

SEATTLE, Oct. 16.—Early this morning an old man named G. H. Hoard, poorly clad, was found on the streets begging for some place to sleep. It was suspected that he was the fiend who outraged little Stella Mather at Fremont yesterday. He was placed under arrest and taken to Fremont this afternoon for identification. When he arrived there the people gathered to hang him but the girl said he was not her assailant and he was accordingly released.

### She Claimed that She Said No.

SALEM, Ore., Oct. 16.—When Mrs. Mary Dickson, who was arrested yesterday on a charge of polygamy, was arranged in court to-day and pleaded not guilty. She said when being married the last time she made the answer "no" to the ministers question "Do you take this man to be your lawful wedded husband?" although claiming to have lived with her last husband a year and was living with him at the time of her arrest.

Will Spend Four Months Here.

PARIS, Oct. 16.—Dillon and O'Brien arrived here to-day. Dillon said he and O'Brien will remain in America four months and return to England and surrender themselves to the police.

ROBBERS STAND UP A TRAIN.

A Heavy Michigan Fallers—Dillon and O'Brien in Paris Bound For This Country.

SAN FRANCISCO, Oct. 16.—The three men, Captain O'Brien, New York, and Alexander McCullum, Captain O'Brien, from Baltimore, arrived here to-day with scurvy on board. There were four cases on the Thomas and seven on the McCullum. The sailors on the McCullum were in a horrible condition, their bodies being covered with running sores, their gums were black and swollen and hid their teeth.

### THREE BOLD ROBBERIES.

Held Up the Missouri Pacific Train Last Night.

KANSAS CITY, Oct. 16.—A bold train robbery occurred in this city last night. The Omaha express on the Missouri Pacific, which leaves at 8:20, was stopped at the state line station, a short distance from the union depot. Three men without masks entered the first chair car. One pretended to be a news agent, selling papers. They covered the passengers with revolvers and compelled them to hand over their valuables. They made their escape as the train was leaving the station. There were six passengers in the car, and it is impossible to say how much the robbers succeeded in getting. The road officials say only one man was robbed and that he was standing on the platform and the robbers relieved him of \$23. It is generally believed they got much more.

### MARRIES HIS WIFE'S SISTER.

The Third Wife for General John W. Sprague.

MEADVILLE, Pa., Oct. 16.—Gen. John W. Sprague, of Tacoma, Washington, and Mrs. A. W. Vance were married here yesterday. Mrs. Vance is a sister of Gen. Sprague's first wife. The first Mrs. Sprague lived only one year, and after long remaining a widow he married Miss Frances Choate, of Milan, Ohio. She died two years ago. The general came east to visit his daughter in Huron, Ohio. During the trip he came to Meadville and persuaded Mrs. Vance to return for a short visit to Huron with him. The wedding here was the result.

### Stole His Wife.

### NARROW ESCAPE.

In the Darkness They Were Nearly Run Down.

PARIS, Oct. 16.—In an interview to-day Dillon said, after the yacht on which he and O'Brien escaped, had been out two days the supply of illuminating oil ran out, and in consequence it was impossible to light the yacht. This made it dangerous sailing in such a crowded waterway as the channel, and they narrowly escaped being run down by several passing vessels. O'Brien's sole object in refusing to face his accusers to the end in Tipperary was to keep his engagement to speak in aid of the Irish cause in America. Dillon and O'Brien will remain in Paris eight days, when they will take passage for New York.

### A BAD YOUNG MAN.

He Forges His Mother's Name to Deeds.

CHICAGO, Oct. 16.—Three indictments were returned by the grand jury this afternoon against George A. Lipe, son of millionaire George Lipe, of Denver. He is charged with forging his mother's signature to deeds, conveying \$50,000 worth of real estate. Lipe sent the deeds, in which he was granted and his mother grantor from Oregon, where he is now believed to be.

### Brought Fifteen.

G. M. Irwin, superintendent of the Chemawa training school for Indians, has just returned to that place from a three weeks' tour in Southern Oregon after scholars to increase the roll at that institution. He succeeded in bringing 15 children of the forest with him, and the total number there now is 133. Those brought by him were from Coos and Curry counties.—Salem Statesman.

### Why Not Tar and Feather Him.

There is a being on Coos bay who has the appearance of being a fine man, but who is one of the vilest brutes that ever went unhung. ### WILL NOT NOMINATE

Colored Voters Declare It Is Unwise to Nominate Republicans.

FIVE PICKPOCKETS ESCAPE.

Breaking the Record—Fallers Effects—Lowa W. C. T. U. Declares For Non-Partisan Temperance Work.

COLUMBIA, S. C., Oct. 16.—At a meeting of colored republicans from various sections of the state, resolutions were adopted to declare that delegates do not consider it wise or prudent for the republicans to put a candidate in the field. After a heated discussion the resolution was also adopted, recommending the negroes, for the betterment of their condition, to vote for Haswell on the anti-Tillman democratic ticket. The resolutions declare that the negroes do not desire social equality or political supremacy, but as citizens of the United States they demand impartial administration of the government, and a just share in it.

### WOMAN'S CHRISTIAN UNION.

They Have a Warm Fight Over Some New Partisan Views.

DESMOINES, Oct. 16.—There was a warm time at the state convention of the Woman's Christian Temperance Union to-day. The non-partisan question was brought up. Mrs. J. Ellen Foster, with others, left the national convention last year, warmly championed the non-partisan course. There was a bitter discussion, in which some of her opponents attacked her for her sympathies with the republican party. Mrs. Foster replied she, as an American woman, clinging to her right to exercise her liberty under the constitution. She was an intense republican woman, could be an intense democrat and yet do non-partisan work for temperance. Finally after an all day struggle the Iowa union voted to be no longer identified with the National union, headed by Miss Willard, last by a vote of 315 to 68. The dissenters withdrew with the intention of forming an Iowa union on the third party basis.
