SKILLFUL SURGERY.

Albany Can Furnish As Skillful Surgeons As Any City.

Yesterday one of the most difficult surgical operations was performed in this city with careful attention and perfect success. Way should cases requiring surgical operation be taken away from home when all the skill required can be had right here, and a great deal more of personal care and attention than can be had anywhere away from home. Dr. G. W. Maston assisted by Drs. W. H. Davis and J. P. Wallace performed the operation spoken of, and it consisted in removing an ovarian tumor from the wife of Mr. E. L. Ehret, who resides on Lyon street near the Southern Pacific depot. The tumor when removed weighed thirty pounds and was remarkably large. Dr. Maston performed the same kind of an operation for Mrs. Bryan of Scio, in June, that was entirely successful, and the only thing against Mrs. Ehret's recovery is her age which is 57 years. It is certainly a matter of congratulation that Albany is so well supplied with skillful surgeons.

The Mystery Deepens.

In regard to the mysterious disappearance in Chicago of the Salem Statesman says: As time passes no solution offers for the mysterious disappearance in Chicago last Thursday of Dr. Clinton Cooke, whose post office address is near the telegraph yesterday brought neither good nor discouraging tidings of the missing boy. The Oregonian's Chicago correspondent yesterday morning intimates that his friends feared he had committed suicide because of a love affair or financial reverse. But this is unlikely, as he had all the financial aids he required and his love affairs were decided last spring when the engagement was severed between himself and Miss Lillie Wagner, of Portland. Whether his parents in this city nor the Statesman could hear a word in relation to the case from Chicago yesterday. Chauncey Lockwood received a letter in the morning from Clint's brother, Gay, written on the night of the 10th. It was on the evening of this day that Clint was last seen. The letter received yesterday offered no clue, merely stating that Clint was away for the night.

To Kill Condemned Horses.

The East Oregonian says: Stock Inspector E. Gilliam, who was ordered yesterday from the secretary of the state to kill two horses belonging to G. S. Fogers of Milton, condemned at \$15 each, which are afflicted with nasal gleet. An Important Industry.

The lumbering business on the North Santiam river along the line of the Oregon Pacific railroad has already assumed important proportions, and promises next year to be materially increased. Several new saw mills have been built in that region this summer and others are in course of construction, as also a number of lumber chutes and log ways. The timber along the North Santiam is not surpassed by any on the coast. It consists principally of yellow fir with some white hemlock, oak and maple. Long train loads of lumber are daily shipped from the various saw mills along the road to this city, here to be distributed to Salem and various other points in the Willamette Valley, a large amount being consumed in the building here. This is fast becoming an important industry in the region named, and is destined to become even greater as the supply of timber is almost inexhaustible.

Shall Oregon Be There?
