A few of the mountaineers, estimates that there must now be several hundred horses concealed in the mountains. The stockmen have become alarmed at the frequent and almost constant losses to which they are subjected by these horse booters. The probabilities are that an organized hunt will be made in the mountains when some exciting fun may be expected.

A PUBLIC SURVEY NEEDED.

Considerable has already been said in these columns concerning the necessity of a survey of the public lands up the Santiam, both in Linn and Marion counties, but the question is of such vital importance to settlers who are waiting to obtain homes in the rich country now made accessible to the market by the Oregon Pacific railroad that the claims of this district for an early survey cannot be too urgently presented. These lands being unsurveyed settler can obtain no title, and can only occupy them as "squatters."

The Herald's dispatches show that for the public surveys congress has dealt very generously with Oregon this year. Last year \$10,000 was allowed, and this year \$20,000. For several years the Western domain was surveyed with limitations in survey contracts so low that in case of timbered land contractors could not afford to bid, but this session this has been much changed, so far as to allow for "survey of lands heavily timbered" mountainous or elevated with dense undergrowth," rates not exceeding \$18 per linear mile for standard and meander lines, \$15 for township, and \$12 for section lines, and this increase is confined alone to Oregon and Washington. Other states must make special allowances to obtain it. Oregon has 20,000,000 acres of land yet unsurveyed. The present liberal rates will induce numerous surveys, and thus encourage the development of large areas of our public lands in Oregon, which are now retarded. The rapid development and industrial growth of the Santiam district in lumbering, mining and fruit growing, demand that a portion of this appropriation be expended in surveying that region, and it is to be hoped the matter will not be long delayed. As Bad as McGinty. Shelly, a representative of the California Fish and Game Commission, arrived in Portland, says the Telegram, for the purpose of securing about 200 Mongolian pheasants, for the purpose of stocking that state with them. About three years ago the legislature of California made an appropriation of \$200 for the purpose of importing game birds. About the time the appropriation was made, the Sportsmen's Association of Nevada county got some Mongolian pheasant eggs and hatched them out, but the chicks were kept in confinement too long and finally died. SHALL MEASURES BE ADOPTED?

Whereby The Manufacturing Interests of Albany Will Be Protected.

In an editorial, a few days ago, we referred to the condition of the freight business from this city to interior towns, whereby Albany loses prestige as a manufacturing centre. The case being that in changing from one road to another, as from the Oregon Pacific to the west side, or from the Southern Pacific to the Narrow Gauge, double local rates are charged, thus making articles shipped from Albany to towns along the narrow gauge, and also along the west side, pay much higher rates than the same articles from Portland pay. Now is the opportune moment for this matter to be looked into, by our business men, and a fair deal for Albany secured. Just at the time when the Oregonian-Narrow Gauge-railroad is changing from the narrow gauge into a standard gauge, and changes are being made to accommodate the new order of affairs, is the time for Albany to put in her plea and get a hearing to have the changes made while they are in order. Will our business men take hold of this matter and see that it is accomplished? It must be the representative business men that do it, if any effort that work is accomplished. Oregon as a Winter Resort. One would hardly expect residents of Florida to come to Oregon to spend the winter, yet that is precisely what Ed Lewis, a wealthy Florida banker, now residing with his family at the Edmond hotel in Portland is doing. Mr. Lewis wanted to try Oregon at the worst season of the year, for then he could guess what it was like at its best. He arrived with his family a few days ago and likes the country and climate so well that he has concluded to remain over winter. The rheumatism, which troubled him considerably at home, has left him entirely, and he says he never felt better in his life. It will not be long before Californians will come up here to spend the winter, while Eastern people, after once finding out what Oregon is, will come here to live, not only in winter, but in spring, summer and autumn as well. Natural Woods of Josephine Co. Grant's Pass Courier: The natural woods of Josephine county attracted more attention from visitors at the Portland exhibition than anything else sent from Southern Oregon. The collection of fruits which were sent down from the district fair at Central Point were too much bruised to show to good advantage. The few specimens sent from this county were fresh and looked much better than those which had been called upon to do double duty; but there were not enough of them to challenge attention amid the larger displays from near counties. If Josephine county attempts to make an exhibit next year, and we hope it will, it should commence in time and have a full and large collection of everything that grows from our soil, or is found in our mountains. Rich Enough to Build a Railroad. Even at the very low value given in the assessment roll, this county is rich enough to build a railroad for fifty miles, and then bond the road for enough to build twenty-five miles further. When that was accomplished, there would be no trouble in having Albany built enough towards us to meet and connect with the seventy-five miles we had already constructed, and then we would have a through line bringing in a vast amount of business. It is a poor argument against it to say that we have here no practical railroad men to operate such a line, for we have them, and they can be named. Even if we had none, however, it would be the easiest thing in the world to find men of experience in that line of business, who would be glad to take the management of the railroad and operate it successfully. A New Era is Dawning. Oregon has better natural resources than Washington, and should be far ahead in material development. The last census gave our neighbor a larger population, but this was on account of the lack of ability of our enumerators, and a recount should have been made. We are loath to acknowledge that our people are backward in taking hold of any enterprise, and they miss many opportunities for development; but we hope the future will see a change in this regard.
