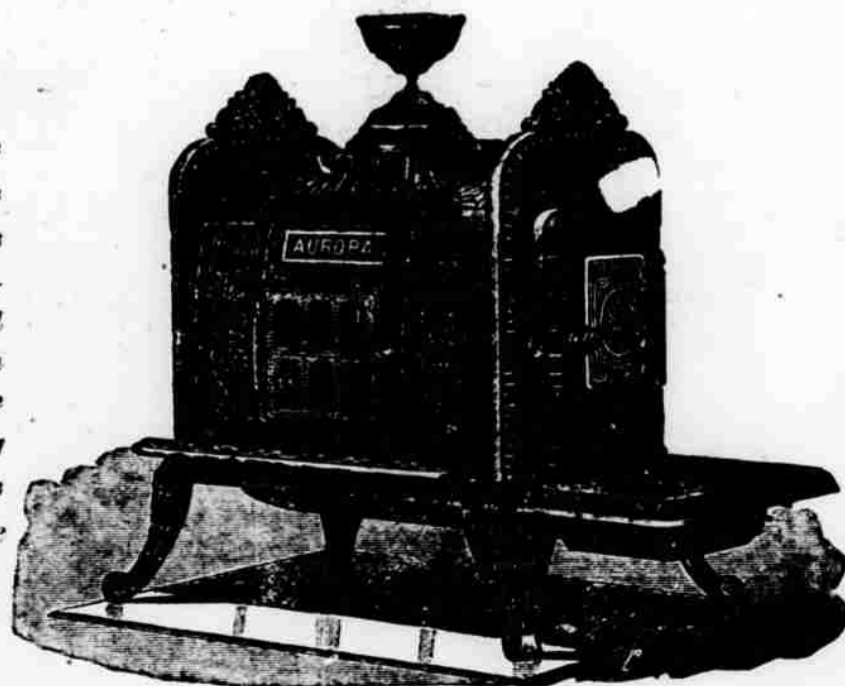

SUGAR TRUST AGAIN.

An Arkansas Postmaster Kicked Into Resigning.

CONTRIBUTE IF THEY CHOOSE

Large Failures in New York - West Destroyed by the Hessian Fly - Heavy Failures - Freight Train vs. Hotel.

New York, Oct. 30.—Application for a receiver for the sugar trust was argued before Judge Pratt today. He reserved the decision, but modified the injunction to allow the publication of a plan of re-organization and financial statement. The plan provides for an issue of \$25,000,000 of seven per cent. preferred stock, \$25,000,000 common stock and \$10,000,000 of bonds secured by mortgage. The statement of the financial combination trust shows assets of \$20,537,836; liabilities, \$8,794,181. The trust originally had no working capital and borrowed \$10,000,000. Dividends paid to stockholders, \$11,900,992; amount expended on improvements of plant, \$2,754,531. The new company will be called the American Sugar Refining Company.

CAMPAIGN FUNDS.

The Clerks Contribute Where and When They Choose.

WASHINGTON, Oct. 30.—A well known republican leader, connected with the congressional campaign committee, has received from Civil Service Commissioner Roosevelt a contribution of \$50, to be used for legitimate campaign expenses in any congressional district where needed. Commissioner Thompson also sent a contribution in aid of the democratic cause. In a conversation today, Roosevelt says: "The clerks are as much at liberty to contribute to one party as to another, and they are perfectly safe and free to make no contribution if they so prefer. Within the classified service the employees are under no obligations to any party. Governor Thompson is a democrat, serving under this administration, and he makes a contribution to his party. I am a republican; I aid mine. If we did not want to contribute we would not. In regard to the political clubs of which the government employees are members, there is no reason why they should not be democratic as well as republican. But any of them will be prosecuted if we have evidence of their trying to force contributions by intimidation."

SEVERE ON FARMERS.

The Hessian Fly Takes Their Wheat.

KANSAS CITY, Mo., Oct. 30.—An evening paper says: "Farmers and grain growers of Missouri and Kansas report the Hessian fly has made an attack upon early sown winter wheat, and that wheat sown during September is ruined. Reports of severe damage come from Ottawa, Kansas, Lafayette, Cass and Jackson counties, Missouri. It is believed that the damage is general and all fields sown in September will have to be plowed up and the grain put in again."

A FREIGHT TRAIN.

Hit Out of the Track and Into a Hotel.

HUNTINGTON, Pa., Oct. 30.—A loaded coal train of thirty-six cars went through a misplaced switch, and was thrown through the hotel Brunswick, and landed in the yard of the Guard house and Jackson house, two hundred feet eastward.
