Judge Kelsey of Corvallis, was in the city yesterday on his way home from Salem, where he has been working in the interest of a measure for the aid of the Oregon Indian war veterans.

The steamers Hoag and Three Sisters are running on the route below Salem. The Oregonian says that the Three Sisters came down Tuesday with a cargo, principally of wheat, and yesterday the Hoag came down with a large load.

Wm. M. Hoag, Wallis Nash, C. C. Hogue and other Oregon Pacific officials returned last evening from Portland, where they have been attending the suit against the company brought by Searls & Dean, former contractors on the road.

The nuptials of Miss Sultana Simmons, of Roseburg, and Mr. Rufus Skipton, of Corvallis, were celebrated in the presence of 500 guests, at the parlors of Prof. J. B. Horner, in Roseburg Wednesday. Mr. and Mrs. Skipton will reside at Corvallis. The presents were numerous and handsome.

At the United Presbyterian church Rec. W. W. Logan preached last night to a deeply interested audience from John 11-28, "The master is come and calleth for thee." He made the invitation of the gospel very plain and personal and many hearts responded. He will continue the service this evening and to-morrow and there will be prayer meeting at 3 p. m. Subject, "Charity."

Division of Umatilla County.

He purposely omitted naming his children in the will, feeling confident that his wife would amply provide for them. Mrs. Eastham is named as sole executrix with out bonds, and she is not required to file an inventory or appraisal of the estate.

THE SWEET HOME CHURCH RIOT.

Preliminary Trial of Rev. H. I. Bittner in Jas. ice Humphrey's Court.

The case of the six defendants arrested for committing riot at Sweet Home, by breaking down the door of the Evangelical church, came up in Justice Humphrey's court at 1 o'clock yesterday. Deputy District Attorney J. E. Wyatt appeared for the state and J. J. Whitney for the defendants. Rev. H. I. Bittner demanded a separate trial, which was granted, and the case was commenced.

The witnesses on the part of the state all agreed in their testimony that they were in the church at Sweet Home, and that they were the first to break down the door of the church to hold services and found the door barricaded by the anti-Bowman men who were inside. Mr. Bittner told his followers that they had a right to go into the church, even if they had to break down the door, and the defendants proceeded a stout pole and converting it into a battering-ram broke down the doors and entered the church.

This defendant admitted except that he testified that he did not advise his followers to use any violence. He testified that the men inside had clubs and a stone was thrown at him as he entered the pulpit. This the witnesses for the state denied, stating that the clubs, one of which was a small hazel stick, was introduced in court, were used in fixing the bell. The stones, which were also introduced in court, were small, flat stones, such as the boys throw at the birds, and the witnesses for the state denied having seen or used them.

The case introduced the tiresome question of the rupture in the church, each faction charging that they were the church and that the other had withdrawn by virtue of that rupture. Some of the witnesses testified that there were no shots or bloodshed, and that Rev. Mr. McElroy received a blow upon the wrist with a club.

The case was continued in the evening, when some more clubs, which were formidable looking weapons, were introduced in evidence. They were found inside the church. The evidence was all in at 9 o'clock, and the court adjourned until 8 o'clock this morning, when the case will be argued.

A Sensible Chinaman.

Usually, when a Chinaman passes to the beyond, the public expects to see the roast pig, pots of rice, joss sticks, and other paraphernalia of paganism at the funeral; but there are exceptions to the rule, and such an exception was witnessed in the funeral of Gee Gay Gong yesterday afternoon. Gee Gay Gong was a tall, who lived on Second street, between Yamhill and Taylor, and having embraced the Christian religion, he desired to be buried with the usual Christian rites and ceremonies. The funeral took place from the Chinese Baptist Mission church, the Rev. Dr. Gordon officiating. It looked not a little singular to see Chinese pallbearers with the conventional white gloves and crapes tied to their arms, but then the Chinese are great imitators, and ere long they may be expected to use knives and forks and finger-bowls at their tables.—Oregonian.

Suit for Damages.

After a rest of several weeks, the Lake Labish disaster is about to get into public print again. The papers at the first damage suit against the Southern Pacific Railroad company, as a result of the Lake Labish railway accident of November 12th, last, have been prepared with the county clerk of Marion county, who is also in the capacity of clerk of the circuit court. "Pet" Beckley, of Oakland, Or., one of the passengers on the ill-fated train, is the plaintiff and seeks to recover damages for personal injury in the sum of \$25,000. Beckley had three ribs fractured, his leg sprained, and was otherwise painfully bruised. Although this is the first suit in which papers have been filed, there are several other cases in the course of preparation in which damages will be asked in sums ranging from a few hundred to a good many thousand dollars.

THE HOSPITAL BUILDING.

The Legislature Cannot Well Refuse the Appropriation Asked For.

A committee from the Ladies Aid Society of Albany, consisting of Mrs. M. J. Train, Mrs. Cora Hopkins, Mrs. L. E. Blain, Mrs. C. W. Sears, in conjunction with a committee of two Mayor J. L. Cowan, and Judge L. Flinn, on the part of the citizens, have been before the committee on ways and means of the Oregon legislature for the purpose of presenting the matter of an appropriation from the state of \$10,000 for the Albany orphan's home and hospital which should certainly be granted.

The following statement presented to the committee shows what the society has been doing and what it asks of the legislature: The Ladies Aid Society, of Albany, Oregon, in presenting a petition to the Oregon Legislature for an appropriation of \$10,000.00, begs leave to submit the following reasons for asking for such appropriation:

Fifteen years ago, this society was organized for the purpose of extending aid to the sick and needy, and during the years since its organization, it has labored at a great disadvantage, owing to the absence of a suitable building in which to care for those in need of a systematic and economical plan. In spite of this fact, the society has dispensed means and support to forsaken and neglected children, the destitute, sick and unfortunate, to the amount of \$7,500.00. This amount would have reached much farther, had the society possessed a home or hospital building, in which to provide for them on a systematic basis.

Realizing this fact, in January, 1889, the society called a public meeting of citizens, in Albany, Oregon, for the purpose of securing money, which should be a nucleus for the establishment of an Orphan Home and Hospital. From all generously tendered by citizens, a block of ground, valued at \$1,000, in the suburbs of Albany, was secured, and money donated which enabled the society to undertake the erection of a suitable building for an Orphan Home and Hospital, upon which \$2,000.00, has been expended and which will cost when finished, \$15,000.00.

To assist in completing this home, the Oregon legislature, which has so generously aided similar, charitable institutions, in various portions of the state, is asked for an appropriation of \$10,000, which with the funds already available by the society, will enable it to carry forward the work now under way.

The steadily increasing number of appeals for relief has rendered the erection of such a building a necessity, as at present the society is paying to have those dependent upon it kept in similar institutions, in other parts of the state. The building is already erected and enclosed, and there is now urgent need for an appropriation of not less than \$10,000.00, with which the society would be enabled to have the Home ready for occupancy by the spring of the present year.

In view of the foregoing facts, your committee respectfully request that the legislature be requested to include this amount for the Orphan Home and Hospital, of Albany, Oregon, in the general appropriation bill. The institution is one deserving aid from the state, and although the present legislature is unfavorable to retrenchment and economy in all legislation it is hoped this appropriation of \$10,000, which Albany is the only city in Oregon of its size having no public institution receiving aid from the state, and in view of the appropriations heretofore made to similar institutions in different portions of Oregon the members cannot consistently refuse this appeal for aid for this deserving charitable enterprise.

Putting up Falsework.

The Eugene Register says: The falsework for the railroad bridge across the McKenzie on the Co. burg road is being erected and doubtless in a short time the bridge will assume shape. Piles have been driven at the north approach, and a temporary track to carry timbers has been laid there. About fifteen men are now at work on the bridge and Mr. Scott, foreman of the work, says he expects about six or eight more on this week and will keep at least twenty men at work hereafter. The general superintendent of the bridge says it will be pushed right along and the road will be completed to Springfield as soon as possible. Work on the bridge has been delayed some on account of being unable to secure some extra large timbers as early as wanted, they had to be obtained at Mill City, on the eastern extension of Oregon Pacific.

COAST NOTES.

Pendleton's delinquent tax roll amounts to about \$1900.

Timothy hay is selling in Walla Walla at \$12 a ton.

Farmers are plowing in the Helix neighborhood.

The East-Oregonian predicts an ice famine for that city next summer. No ice has yet been stored, the winter being too mild for the congested commodity.

Last Sunday, while the family were at church, a thief entered the house of George Merriam at Ellensburg, Curry county, and stole about \$20.

Thus far this winter Grant county stockmen have had but very little hay, and all conditions are favorable toward being able to pass the winter with little or no loss.

A sensation was created at Ellensburg Wednesday by the reported finding of the bodies of two infants in the city reservoir by the ice cutters. Many families have ceased using the water and await developments. How the bodies came there is a mystery.

The Dalles Chronicle: Up to date no ice has been put up in Eastern Oregon and in fact of any consequence formed. Hood River has about 4,000 tons left over from last year.

The Pendleton people are striving to raise a \$75,000 subsidy to secure a \$400,000 manufacturing establishment. It would be the best investment Pendleton ever made.

Sheep and cattle men are rustling for feed in the vicinity of Elgin. Wheat hay is worth \$10 per ton in the stack, while timothy sells readily for \$13 per ton, oats \$1.25 per 50 pounds, and wheat 45 cents per bushel.

Wm. Fisk and his brother-in-law had an exciting chase after a cougar near Eugene last week. The dogs chased the cougar about three miles before treeing it. The men soon arrived and shot at it, wounding it. A bear poked his head up from behind a log near by and both were killed.

Cattle thieves visited the corral of John Skinner, who lives on the O'Brien stock ranch about five miles west of Spangle, Wash., one night last week and drove away seven head of cattle. There will likely be a heavy party if any of the party fall into the hands of the citizens of the community.

At Cathart station, Wash., last Sunday, Frank Peterson and George Williams got into a quarrel and both drew revolvers. Frank, armed with a Winchester, attempted to shoot at Peterson, but Peterson's gun went off and the ball entered Warner's left leg between the knee and the hip, striking the bone and going around it and lodging in the back part of the leg.
