SOLID FOR DIVISION

The Forks of the Santiam in Earnest About the Matter.

THEY WANT A NEW COUNTY.

The Voters in That Portion of the County Are Almost Unanimously in Favor of It.

When the question of dividing Linn county came up a few weeks ago, it was thought the people of the Forks of the Santiam, who are asking for the division, were not generally in favor of it, and the Herald was inclined to oppose it, but recent developments of the division of the county as asked for, show that about 700 voters, which is nearly unanimous in the locality, are in favor of it.

There are a good many reasons in favor of the division of the county as asked for, and it might as well be settled now as a few years hence. There has been for years more or less talk of asking for a division in the southeast portion of Linn county, which would be permanently settled by dividing the county in the way now demanded.

The following private letter, which has been handed in for publication, will show what a vigorous sentiment there is in favor of the proposed division in the Forks of the Santiam:

Scio, Jan. 23, 1891. Mr. S. J. PAUL—Dear Sir—Please send me the following facts and figures and see what position we are in at present, and also what will follow next year if we are not struck off from the old county.

Our taxable property, according to the assessment roll, amounts to \$1,000,000. This multiplied by the rate, 18 mills, makes \$18,000 taxes. The state and school tax is \$8,000, which leaves the amount for county funds alone \$10,000.

Our officers for the Forks are paid for \$2000 each year and pay them big. Remember that the sheriff and clerk are not salaried officers, and a recorder we do not need.

This year has been over an average for bridge building and road expenses in the Forks. Our bridges and roads in the Forks have cost the county this year to exceed \$40,000.

Allowing \$2000 yearly for officers and \$4000 yearly for bridges and roads, we will have left \$3000 yearly for the incidental expenses of the court.

We are paying about one-fifth of the taxes of the entire county, and consequently we will have to pay for one-fifth of the Albany bridge the coming year, which will cost the Forks \$15,000, which will do us no good at all. Fifteen thousand dollars will not build a court house and jail if we want to build them. Now would it not be better for every taxpayer in the Forks to spend their money for a court house and jail at home than to put the same amount into the bridge at Albany?

In the next three or four years Albany and vicinity will certainly build a \$100,000 court house and a \$25,000 jail. These will cost the forks at least \$25,000, add this to the bridge, and we have \$40,000 from the forks to build up Albany.

It seems to me if we are compelled to pay out this amount of money, we would better spend it in our own territory on roads and the like, where it would benefit us.

Please study over these facts and act accordingly. Yours Truly, F. M. DANIEL.

The letter is in error in saying that Albany wants \$100,000 for a new court house. It is true that Albany wants a bridge, and if the people of the "Forks" do not want to pay her just proportion of the cost it would behoove them to work hard and get a new county created for the bridge is a sure thing. It is also true that some repairs will be needed in the shape of a couple of new brick wings upon the court house, and in addition to the jail, but these will not be needed at once, and the cost will not be alarmingly large. If our neighbors in the "Forks" do not wish to join in these improvements, it would perhaps be better for them to have a county of their own.

Train Delayed. The south bound train yesterday noon was delayed at this city two hours on account of an accident to the engine on the special train, which was conveying the Emma Inch opera company to Portland.

Representative Hermann has secured from the department an order for new railway mail service from Albany to Green Basin, Linn county, and the second assistant postmaster general has communicated with the railway company stating the basis upon which it would be proper to establish the service.
