THE LEGISLATURE

The Senate Adjourns Until Two O'clock Monday.

THE HOUSE STILL AT WORK.

The People of the Forks of the Santiam Earnestly at Work for the Proposed Division of Linn County.

SALEM, Jan. 29.—Never before perhaps has the classic Fogs of the Santiam been so largely represented at the capitol as they have been for the past two days. They have a petition of nearly 400 names asking for a division of Linn county. The members from Linn county have refused to introduce a bill in accordance with their wishes, but the petitioners have not given up and will insist upon a hearing.

The afternoon in the senate was consumed in a vigorous debate on the bill providing that graduates of the Normal school at Monmouth shall be entitled to teachers' certificates without examination and providing for aid from the state. The bill was lost by one vote. Friends of the measure say it will be re-considered.

The senate is heard with the work and adjourns until Monday, in order to allow the house to catch up with its business.

THE NATION'S LOSS.

One of the Most Prominent and Able Men Gone.

SECRETARY WINDOM DIES.

The News Is Totally Unexpected—It Will Cause Universal Regret—Brief Review of His Services.

New York, Jan. 29.—Hon. William Windom, secretary of the treasury of the United States, died tonight at 10:35 o'clock in the banquet hall at Delmonico's, where he was the guest of the New York board of trade and transportation. He had been ill for some time, but his illness was not generally known until he was taken ill almost immediately. Every effort was made to restore him, but in vain. He died of heart disease. The great assemblage at once dissolved. Mr. Windom had been the only speaker and the sentiment which he responded was "Our country's prosperity is dependent upon its instruments of commerce."

When Secretary Windom was nearing the end of his speech it had been remarked that he was reading off hurriedly from printed copy, going faster and faster as he neared the end, and at last he had requested the audience not to applaud. A quiver of fear shot through the assemblage like an electric shock as the speaker finished. Windom was standing erect under the glare of the gas lights, with the faces of all turned toward him. For a moment the secretary stood silent while the banqueters equally silent, watched him. Then Mr. Windom sat down quietly and the toastmaster arose to introduce ex-secretary of State Bayard as the next speaker. He began a short speech, but had not proceeded far when Mr. Windom gave a short, sharp moan of anguish, and fell back in his chair. His face grew purple, his lower limbs stiffened and stretched out under the table, his eyelids opened and shut spasmodically, but there was no gleam of intelligence in the eyes which were rapidly losing the lustre of life. The cigar which he had been smoking was held between the grim clutch of his teeth, but only for a moment he appeared thus. The cry went up from those sitting near the guest table, "Look, look at Mr. Windom," and every eye was turned toward the man whose voice had just ceased. As they looked he collapsed in his chair and was falling to the floor. His face was ghastly and a cry of horror arose from the late festive banqueters. There was an immediate rush on the part of all to Windom's chair, but several doctors, who were present at the dinner, got there first and drove the others back. Dr. Robinson bent down and making a close examination of the prostrate form, discovered the heart yet beating, and with some assistance carried him into the room behind the banquet hall, and everything was done to resuscitate him. Electric batteries were applied to his body, but it was rapidly growing cold. For six minutes electric shocks were applied incessantly, but without success. He was pronounced dead.

"I would say the cause of death was apoplexy," said Dr. Robinson, "if it were not for his history of heart disease. I am inclined to think heart disease killed him. Mr. Windom was subject to fits, and heart failure." On Tuesday last he was seized with an attack while on the steps of the treasury at Washington.

The body was removed to the Fifth avenue hotel and a dispatch sent to President Harrison. The body will be sent to Washington on a special train in the morning in charge of a special committee.

WASHINGTON, Jan. 29.—Secretary Windom left Washington this morning, apparently in perfect health, to attend the banquet of the board of trade and transportation at New York this evening, where he was to make an address outlining the fiscal policy of the government. The news of Secretary Windom's death was communicated to the president by the Associated Press and he was so shocked and overcome by the sudden announcement that he was unable to say anything with respect to the loss he has suffered.

William Windom was born in Belmont county, Ohio, May 10, 1827. He received an academic education, studied law at Mount Vernon, Ohio, and was admitted to the bar in 1850. In 1852 he became prosecuting attorney for Knox county, but in 1855 he removed to Minnesota, and soon afterward he was chosen to congress from that state as a republican, serving from 1857 till 1860.

In that body he served two terms as chairman of the committee on education, and also was at the head of the special committee to visit the western tribes in 1865, and of that on the conduct of the commissioner of Indian affairs in 1867. In 1870 he was appointed to the U. S. senate to fill the unexpired term of Daniel S. Norton, deceased, and he was subsequently chosen for the term that ended in 1877. He was re-elected for the one that closed in 1883, and resigned in 1881 to enter the cabinet

of President Garfield as secretary of the treasury, but retired on the accession of President Arthur in the same year, and was elected by the Minnesota legislature to serve the remainder of his term in the senate. In that body Mr. Windom acted as chairman of the committee on appropriations, foreign affairs, and transportation. President Harrison made him secretary of the treasury.

AT WASHINGTON

A CIVIL SERVICE BILL THAT EXCEEDS FORMER YEARS.

Sickness at the White House Attributed to Plant Decorations—Dolph for a Coaling Station.

WASHINGTON, Jan. 29.—The sundry civil bill, as completed by the sub-committee, is the largest appropriation of any similar bill for many years, footing up more than \$36,000. This is due to the heavy appropriations for public buildings heretofore authorized, harbor improvements, special appropriation of \$700,000 for government's exhibit at the world's fair, and a million dollars appropriation for the census.

Mrs. Harrison has nearly recovered from the attack of diphtheritic sore throat, but Dr. McKee has been taken ill with a severe case of tonsillitis. Dr. Gardner has decided that much of the sickness at the White House comes from the almost continuous presence of the large ferns and plants used in decorating the rooms on the occasion of dinners and receptions. They accumulated an unhealthy amount of dampness.

Senator Dolph to-day proposed an amendment to the naval appropriation bill making the amount \$600,000 for the maintenance of a coaling and repairing station for the use of the United States naval vessels on Pearl river, Hawaii islands.

WASHINGTON, Jan. 29.—The committee of Indian affairs received a report from Indian agent Cole, of Colesville agency in Washington, on the recent trouble with the Okanagon Indians. It recites the killing of the freighter, Cole, and the subsequent lynching of the Indian supposed to have committed the murder and the resulting excitement. No further trouble is feared. Agent Cole says, however, that the whisky traffic must be suppressed and that very soon, or trouble is likely to ensue from this cause.

The agency farmer, Mr. Thomas, is authorized to make a statement that there are at least twenty whisky sellers located along the Okanagon river, near the reservation, who make a living by selling whisky to Indians. The agent asks for authority and funds to rid the county of these pests.

THE FINE WAS REMITTED.
HELENA, Mont., Jan. 29.—The senate to-day remitted the fine of the democratic senators, who left the state last session. To-morrow the business of law making will begin.

A Noted Editor Dies.
