Jno. Winker and Wm. Chase, two farmers from Minnesota, were in this city yesterday. They were well pleased with Albany and Linn county and will buy farms near this city.

Messrs. Morehead and Powell, of the Scio Carbonate Coal Mining company, went up to the mines Tuesday, for the purpose of putting men at work preparatory to taking out coal.

The Salvation Army has been instrumental in the conversion of 31 persons during the two weeks prior to and including last Sunday. Fourteen of these were converts from their laborers that morning—Scio Press.

The railroad bridge across the McKenzie river was very nearly carried off last week by the rising river and a heavy wind storm. All the men available were put to work and by hard labor saved the structure.

Sam Veach, a conductor on the Southern Pacific, was thrown from a car of the freight train by a sudden jar, caused by the air brakes, the other day at Turner's station, and fortunately fell into a creek which the train was crossing.

Last week fifty-three young men of McMinnville were mustered into the service of the state as a militia company. Afterwards the following officers were elected, H. L. Heath, captain; C. H. Fleming, first lieutenant; F. L. Harris, second lieutenant.

Parker, secretary, and H. C. Humphrey, treasurer.

THE LAW IN EARLY DAYS.

Unwritten History of the Pioneer Lawyers of Albany.

One of the most interesting chapters in the early history of Albany, and in fact of the entire Northwest, has never been written. It is that chapter which, if written, would tell us something of the trials, privations and difficulties encountered by the pioneers who engaged in the practice of law or wore the judicial ermine on the bench. Lawyers, especially in those days, had a hard road to travel. They were travelers in a land not flowing with milk and honey. They were hewing and building under difficulties. They were laying down the mud-sills, and ground-floor of a structure, the towering proportions of which are but dimly seen. Tools, materials and convenience were scarce. In a new country where foundations were to be laid and tabernacles to be built in the wilderness, lawyers were the master-workmen. It must be remembered that lawyers in those days were scarce. Clients were poor and few in numbers. Access to a library was almost impossible, and a lawyer was considered well equipped, who had in his office a copy of the "Donation Act," an old edition of Blackstone and a few volumes of Patent Office Reports.

In 1820 the only lawyers in Albany were Judge J. C. Powell and H. Cranor. George Helm was a law student in the office of the latter, and this constituted the town's legal fraternity. The seat of justice was strictly a pioneer structure, the court house being a frame building of octagon shape, standing on the lot where the residence of Judge L. Flinn now stands. This served the ends of justice until 1821, when it was burned down, destroying all the county papers which were not in the distinctive new safe, which served as a vault, and the records in it were so badly scorched that they had to be rebound.

It was during the memorial year of 1820 that the famous "Cayuse" ticket flourished in Oregon. Have you ever seen a congressman, on that ticket and was defeated by Geo. K. Shields, democrat, in Linn county that year the democrats were defeated for once. No convention was held by the "Cayuse" men. Judge J. C. Powell, Anderson Cox, J. H. Foster and a few other leaders, simply met with a representative from the outside precincts and set up a ticket. They worked like leavers at the polls and did not allow a single voter to remain at home. The entire ticket was elected except one, but the vote was close, the majorities being for the most part less than half a dozen. Voters were scarce in those days and every ballot counted.

The political gatherings were not large, and were attended by no brass bands or big demonstrations, but they were characterized by earnest, eloquent speeches.

In 1822 the Union party supplanted the "Cayuse" ticket. It was composed of republicans and Douglas men or "war democrats." Judge J. P. Bove was elected district judge and Judge J. C. Powell county judge. James Wilkins succeeded D. Mansfield as county clerk, defeating him by 12 votes. The county commissioners were, O. W. (Wad) Richardson, of the Forked the Santiam, and Joseph Hamilton of the Oakville district. Elias Walters was county treasurer, and P. A. Riggs was sheriff.

J. H. Foster had then just completed the first brick structure in Albany, which is the two-story building now occupied by the HERALD office. The octagon court house being in ashes, this building was used as a court house. There was no county jail and a murderer named Pate, who had killed a fellow-chopper five miles below town was chained down to the floor of the county clerk's office, which was in the front rooms of the building. Pate was tried convicted and hung in the good old way, according to due process of law.

The first county jail was a stout log structure, which stood upon the banks of the classic Calapooia, near where the residence of Mrs. Tate now stands. No big fortunes were made in those times in the practice of law. Nearly all attorneys, in order to make ends meet, assisted the settlers in filing notifications and proofs of donation land claims, and when the home-bugle sounded for assistance in suppressing the Indian hostilities, lawyers, judges, and citizens alike went to the front, and, if history be true, their banners were never seen trailing in the dust.

In 1822 the building of the present brick court house was commenced, but it was not finished until 1825, at a cost of \$35,000. By this time the town was assuming a respectable growth, and other lawyers and business men located here, to be numbered with the pioneer citizens. Among the attorneys who followed in successive years were, N. B. Humphrey, Judge L. Flinn, J. W. Baldwin, M. A. Baker, L. Bliven, H. Br and M. D. Conlay, S. A. Johns, J. K. Waterford, Charles E. Wolvorton, J. J. Whitney, D. R. N. Blackburn, Geo. E. Chamberlain, R. S. Strahan, L. H. Montague, H. H. Hewitt, who were likewise followed by those who were recent arrivals, until to-day Albany can boast of as able an array of legal talent as any city in the state.

It must not be supposed that the pioneer lawyers of Oregon were inferior in point of talent or otherwise. On the contrary they were men of ability. Like all Oregon pioneers, they possessed those characteristics which always command respect and admiration. They were self-reliant, fearless, and independent, loyal to their clients and to the growing empire of the new Northwest.

As has been said, what though

on homely fare they dined wore hdden-gray and big shoes; they left behind them foot-prints on the sands of time, which others might well imitate.

AN IMPORTANT LAW.

One that RELATES to Judgments Rendered in the U. S. Courts, Dockets, Etc.

Heretofore anyone buying real estate in any county in the state, in order to find out whether the title to it was clear, was obliged to go to the United States to find out if there was any judgment lien on record against the property in that county, as there had never been any provision made for making a record of the judgment liens of the United States courts in any other office in the state. On August 1, 1888, congress passed an act, chapter 729, volume 25, statutes at large, page 357, providing that any state, if it saw fit to do so, could regulate the docketing of judgments rendered in the United States courts, and authorizing transcripts thereof to be made and recorded in the several counties of the state, in the same manner and with the same effect as the state provides for the docketing of judgments rendered in its own courts, and for the filing of transcripts thereof in the several counties.

A bill introduced by Senator Willis has been passed by the present legislature, by which this state avails itself of the power which congress has granted it over the judgments and decrees rendered in the United States courts. After the law goes into effect a judgment rendered and docketed in the United States courts in Portland will be a lien upon the real estate of the debtor in that county only, and the lien will not extend beyond that county, unless the judgment creditor takes a certified copy of the docket entry and has this filed and docketed in the office of the county clerk of any other county in which the debtor may have real estate upon which the judgment creditor may wish to secure a lien. Captain Lamson, clerk of the United States courts, has procured a fine set of books and is now getting up a direct and cross index of judgments, decrees and liens that have been rendered in the United States courts.

Fine Collection of Paintings.

Mr. A. W. Best, a talented Pacific coast artist, is in the city and will have an exhibition, beginning this evening, and both day and evening thereafter, for two weeks, in the building opposite Stewart & Sox's, a collection of fine oil paintings, which will be well worth visiting. Some of these paintings were on exhibition at the industrial exhibitions in Spokane Falls and Portland, and are pronounced first-class. He also has some of the famous figure paintings, of Tefft, the well-known San Francisco artist. This exhibition is given in order to allow the public an opportunity to judge of his work, as he is here for the purpose of opening a class in oil painting. He has been teaching a successful class in Salem, and will teach in both places.

Youthful Thieves.

Some boys named Bridges, DeFord and other youngsters, at Toledo are wanted for numerous thefts. They broke out a window light in the Barr's grocery store and stole some cigars and candy. They also stole some chickens to complete their bill of fare, and then stole two horses and left for other parts. They left the horses at Chilwood and continued their way toward Albany on foot. The police would do well to look for them.

Nearly a Fire at Scio.

Mr. Wm. Brenner and family of Scio, awoke Sunday morning to find the house full of smoke. Investigation proved that the heat of the fireplace had ignited some bonnets that were used to make the foundation of the fireplace level, which were slowly burning, the smoke coming up into the room through crevices in the hearth. If the family had been away from home so the fire would have had more time, the house, which is a valuable one, would have been badly injured or burned.

Madison Heard From.

Several of the creditors of the absconding I. M. Madison have received a note from him at Aurora, Illinois, reading something like this: "Death in our family caused me to leave so suddenly. Please send my bill here and I will pay the same." J. M. Madison, Aurora, Ill. It is doubtful if the festive Madison is in Illinois, or that he would pay a bill, unless it was with some of the counterfeit money, which it is said he has been handling.

Eastern Oregon Is Mad.

Ninety thousand dollars for a done on Salem's capital building is all right, but when it comes to appropriating any sum for artesian wells in Eastern Oregon, that is all wrong, according to the ideas of the average "Webfooter."—Baker City Democrat.

BUILDING AND LOAN.

The Albany Association Records a Successful Year.

The meeting of the Albany Building and Loan Association, in the parlors of the Bank of Oregon, was the first meeting of the third year of the association.

The annual reports were read, showing a most prosperous situation and a highly satisfactory year's work.

The following directors were elected for the ensuing year: H. Bryant, J. E. Brown, W. S. Thompson, G. E. Chamberlain, C. H. Stewart, G. W. Hochstetler, E. Washburn, Dr. J. P. Wallace, E. P. Nutting.

For auditing committee: J. L. Cowan, E. W. Langdon, Professor E. N. Condit. The officers for the ensuing year are: President, C. H. Stewart; vice-president Geo. W. Hochstetler; secretary J. W. Blain; treasurer W. S. Thompson; attorney O. E. Irvine; finance committee, H. Bryant, Dr. J. P. Wallace, E. P. Nutting.

Four hundred dollars was loaned on fifty months interest in advance to L. M. Curl, and \$2000 on forty-nine months.

The secretary's report shows the following resources: Total loans in force \$31,790 00 Cash on hand 457 09 Furniture and fixtures 120 05 Due from members 173 40

Total \$32,541 14 Less unearned interest 9,511 56 Due members on advance payments 22 00

The profit on one share of the first series during the year was \$1.71, which shows a profit at the rate of 28.5 per cent per annum. The total expenses for the year was \$316.75, including advertising, hall rent and everything, \$300 of which was secretary's salary.

Perfectly Cool.

The way they perform the highway act down in Coos county is thus related by the Sun, of Marshfield, the initial number of which is 9 or 10 tables. "While the past two or three weeks we have heard of three instances of persons being stood up on our streets, and all of them in nearly the same locality. The last case reported occurred on Tuesday night last, and the victim was an employee of this office. He was proceeding leisurely up a street toward his room and, when in front of the China store a white man stepped out from the doorway of that building and, presented a pistol, ordered him to throw up his hands, which he did without protest. On a demand for money and valuables by the highwayman, the young man informed him that he had neither, which did not satisfy the gentleman of the road, for he proceeded to go through his victim's pockets in style. The search resulting in a find of nothing more valuable than a printer's rule, a case of pipe, which articles were generously left to the owner, he was ordered to move on. The young man says he was not in the least excited by the incident for the reason that he saw the man standing in the doorway before he came abreast of him, and was half-expecting to be stopped, hence eyed the man as closely as circumstances would permit, and describes him as being short, heavy-set clean shaven, except a short mustache, and wearing a heavy, dark colored overcoat and black slouch hat."

Causing Trouble.

It appears that the killing of the Chinaman in Pendleton is likely to cause some trouble among railroad employes. The East Oregonian says there is a rumor current in Pendleton that Brakenham Passage, train partner of Thomas Jeter, has been discharged by Division Superintendent O'Brien on account of killing a Chinaman here, although Mr. Passage had nothing to do with the row which led to the death of the Chinaman at Jeter's hand; also that Conductor Anderson will be relieved from duty. Report further says that the railroad employes generally consider this action unwarranted on O'Brien's part, and there may be trouble if he persists in his course. The matter so far is very indefinite and railroaders are very uncommunicative. A well-known engineer, however, remarks that either he or Mr. O'Brien will be compelled to quit the service if Anderson and Passage are discharged.

He is a man of practical experience in bridge building and other railroad work—and would finish up a useful commission, with the law just past to back it.
