A DAKOTAN'S VIEWS

A Letter Written After a Visit in Oregon and the Willamette Valley.

The following letter appears in a North Dakota paper from a correspondent of that state who had visited the Willamette valley: From what I can learn from the few months I remained in Oregon, the Willamette valley knows fewer sudden changes from heat to cold or vice versa, than any other locality in the same latitude. For health and general usefulness it cannot be beaten. One can see roses and numerous other flowers in bloom here while it is cold enough to freeze a woolen Indian in Dakota. While Oregon, as a whole, possesses qualities and attractions superior to any other western state, the Willamette valley stand out as the "mirage of Eden" of the state, and has no superior in productiveness on the Pacific coast. Albany is located on the east bank of the Willamette river. Steamers ply the blue waters of the river and carry on a transportation business which is envied by the three railroads running parallel with and on each side of the river. Its wooden mills, foundries, planing mills, factories and other industries throw a garb of prosperity around the city. One can clean up as much money here from ten acres of land as he can back east from two hundred acres, and escape a large amount of worry and hard work. Here one can take an all-year-round gain on a ten acre lot of growing orchard, and raise vegetables enough to make a living on while his orchard is growing to maturity. This entirely does away with the old time idea that a man could not afford to plant an orchard and wait ten years for returns. The cultivation of small fruit or vegetables is also a benefit to the growing trees. To the man away back in desert-like Dakota, it looks as though there must be a screw loose somewhere, or there would not be a clamor for the immigrant. The "loose screw" he sees in the fact that the old Oregonians have the happy faculty of taking things easy. Still some of these people are rich, while the rest have made an easy living. There seems to be a disposition among them to discourage eastern people from coming to locate, as the latter invariably succeed. Some of them have come here and purchased the old original orchards, cleaned the moss off and scrubbed them in genuine "yankee" fashion and made them valuable, wealth producing property, some of the orchards bearing tons of excellent fruit now.

TRIBUTE TO SHERMAN.

ABOUT HOPE.

A Circular Letter Concerning This Industry in Oregon and Washington.

PEYALUP, Wash., Feb. 19. The firm of E. Meeker has shipped, during the season of 1890, six solid train loads of hops to London, which, including other shipments, comprised the equivalent in quantity of one-fifth of the Washington crop year under review. From the statistics at hand we estimate that two and a half million dollars have been received for the hop crop of Washington grown in 1890, and nearly a million and a half for the Oregon crop of same year. No statistics are at hand showing the actual shipments from Oregon, but it is fair to judge the crop in that state has likewise been under-estimated and that the total yield has been fully 25,000 bales instead of 20,000 as heretofore estimated by us in our last circular, making a total for the two states of 75,000 bales. Almost all of the Oregon crop has gone forward and into the hands of the consumers. The shipments since December 31st, 1890, including the stock yet on hand, will foot up fully 5,000 bales, Washington's conservative estimate—and may reach the unexpected grand total for the crop year of 1890, of 50,000 bales. The disastrous results to both growers and dealers who scrupulously fulfilled all contracts, coupled with the threatened loss of a portion of the crop by vermin thus rendering the quality uncertain for future crops, has put a stop to the practice of contracting for future deliveries, and it is hoped never to be revived. Had the growers not contracted any of the crop of 1890 until the bale, and then met the market, there would have been more than a million dollars more money in circulation in the two states of Washington and Oregon than now, and a "world" of litigation avoided that now crowds our court dockets. Hereafter this firm will make no contracts for hops until the same have matured and are ready for delivery. Notice has been formally served upon this firm that hereafter no bales will be passed the scales that weigh over 210 lbs. So, growers will please take notice that no contracts for hops until the same have matured and are ready for delivery. There is a good valid reason for this rigid "iron clad rule," in that hard pressed bales never make good summer use hops, and this desirable quality of the Northern Pacific growth of Oregon and Washington is that which has given us such prestige on the London market as to enable us to sell freely on that market. An average of 170 lbs. per bale is better than 180; in fact the lighter press are the better as they retain their "age" and usefulness to the consumer longer. Messrs. Hotharth & Sons, New York, under date of Feb. 9th, 1891, estimates the stock of hops on hand in the United States at 69,000 bales, all of which will practically be needed to supply the wants of brewers not already provided for, assuming there will be no further import or export trade. This leaves the problem of the "world's supply" with the German and English factors, the ways of which are a past finding out, hence the future of the market is as usual shrouded in mystery and beyond the knowledge of the most wise. Contrary to all expectation based upon the known shortage in the world's supply, the market has not fully recovered from the great sag of November, caused by the stringency of the money market, at the beginning of which prices were firmly quoted at from 200 to 210 shillings per cwt. Now, the same qualities will fetch no more than from 165 to 175 shillings per cwt., a difference of fully 35 cents per pound. Our New York telegram reports that market "dull and declining," quoting Washington 30 to 31 cents, with holders pressing the stock on the market. Cablegrams received to-day from our Mr. Fred S. Meeker, who is now in London, quotes that market as "active" with sales of fully 5,000 bales, Pacific, within the week at an average equal to 32 cents here, for choice.

Caught in a Snowslide.

B. Y. Hampton and Charles Spears, miners, were caught in a snowslide last Thursday evening at Boulder camp, twenty miles above Ketchum, says the Walla Walla Union. They were going from the mine to a boarding house 500 yards distant, when an avalanche entombed them under seven feet of snow. They were exhausted thirty minutes later, but the unfortunate men were found dead.

THE NEW LAWS.

A Total of 227 Laws Enacted by the Legislative Session Just Ended.

A total of 227 laws has been enacted by the legislative session just closed. These, aside from the bills passed in the closing days of the session, and which have been published in the HERALD are as follows: GENERAL LAWS. The general appropriation bill. The Australian ballot bill. Regulating primaries in cities of 2500. Appropriating \$45,000 for the legislative session. To provide for the recording of wills. For the protection of sea gulls. Granting consent of the state to the federal government to purchase land for public building in Portland.

Permitting only citizens of Oregon and Washington to fish for salmon in the Columbia river. Authorizing a mother to appoint a guardian by will. Increasing the effectiveness of the act for the prevention of contagious diseases among animals. Protecting laborers in timber and logging camps. Appropriating \$25,000 for new buildings for the State Agricultural college. Amending the law pertaining to suits for the partition of real property.
