There will be a big march of improvements in Albany during the summer of 1891, including a free wagon bridge. This is authentic. It is said that the Oregon Pacific company are asking for bids for a contract to furnish 50,000 ties to be used on the road this summer.

Mr. E. J. O'Connor has returned from Seattle, where he has been engaged for several months in surveying on the Lake Washington ship canal.

According to the calendar, today is the last day of winter, and spring will begin tomorrow. In the Willamette Valley it has been spring all winter, so to speak.

The wheat market is advancing. In this city 65 cents is quoted, and there is a firm upward tendency in the market, which will no doubt cause considerable wheat to move.

E. Graham's drug store at Corvallis was entered by a party a few days ago, and a few dollars worth of merchandise stolen. The offender was arrested and held to await the action of the grand jury.

The members of the Women's Missionary Society of the First Presbyterian church are requested to meet at the residence of Mrs. E. E. Goff, Saturday afternoon at 8 o'clock. Business of importance is to be brought before the society, so a full attendance is desired. By order of the president, Mrs. E. E. Goff.

The students of the Albany college will give an entertainment at the opera house, Friday night March 6, at which will be presented college songs, selected recitations, a large number of recitations, and also a short drama entitled "The Garretors." The college orchestra will make its appearance for the first time.

A Long Race. It is not often that horses voluntarily take a race reaching into miles, but the Corvallis Gazette relates a case of that kind in the following: Last Friday Garrett Long's two buggy animals broke loose at his farm six miles south-west of Corvallis, and with a top buggy attached to them started for Albany at a lively rate with the evident intention of breaking the long distance record of their worthy grandfathers, Alexander's old Lexington. They reached and passed through this city at a speed which bore fair comparison with the Willamette.

Railroad Enterprise. The projected new railroad connections, in different sections of the state, are evincing growth in the state. Grants Pass Courier notes that the Rogue River Valley railroad company has filed articles of incorporation with the secretary of state. Its capital stock is placed at \$100,000. The object of the company is to build a railroad from Medford to Jacksonville and twenty miles beyond. Its principal office will be in Portland. The company has now completed that cars are running from that town to Jacksonville. The people of Crescent City have petitioned the company to extend its line from Jacksonville to that place, offering a liberal bounty if it will do so.

Another Fire at Junction. Fire broke out Thursday morning in Morgan Honit's saloon in Junction, which was burned; also Beebe's boot shop. Train's jeweler store, Schroder & Matt's saloon, John Kirk's barber shop, Millon's saloon. The hotel and general merchandise store were saved by hard work. The town of Junction has had several destructive fires recently.

THE BRIDGE QUESTION

How it is Viewed in Other Portions of Lin County.

A number of citizens from various portions of the county were in the city yesterday, and several of them were interviewed by a Herald reporter on the question of the free wagon bridge across the Willamette, which is a topic of chief interest here now.

The majority of those who were seen said there would not be much opposition to the county paying a reasonable amount toward the construction of a bridge at Albany.

T. L. Dugger, of the Scio Press, said that the majority of the people there would favor a county appropriation for the bridge.

Dan McClain, of Harrisburg, said he had heard of no opposition to it there, and added: Harrisburg is taking on a healthy growth now, and the citizens propose to build a water ditch. The plan is to utilize the old mill-race and construct about a mile and a quarter of new canal, bringing the water from the Willamette two and a half miles distant. The water is wanted to run a flouring mill and other factories. Say, will you help Albany build a bridge, and then ask Albany to help us with our water ditch. That would be fair, eh?

The committee appointed at the special meeting of the city council will soon have the petitions to the county court presented to citizens in every part of the county, and an opportunity will be given them to join in asking the county court to work jointly with the city in the building of the bridge.

In view of the liberal appropriations made by the county court heretofore for bridges in various portions of the county, there can certainly be no opposition to the county aiding in building the bridge at Albany, especially since this city is willing to bind and bond herself to pay half the necessary amount, and this question will doubtless be viewed in a spirit of fairness throughout the county.

THE ODD FELLOWS.

A Banquet Tendered to Visiting Patriarchs in this City Last Evening.

At the meeting of Oregoniana Encampment No. 5, I. O. O. F., held last evening, a number of Odd Fellows from neighboring towns were present to witness the initiation of eleven members into that degree. The meeting was continued until the wee small hours this morning.

The soil was already well-moistened, and the last snow is enough to make the farmer turn a somersault in the back yard and dance a jig in the barn. From every part of the county comes the report, brought in by delighted strangers, that there has not been a better prospect for many years. A good crop is almost a certainty. The presence of a large amount of snow in the mountains will prevent the hot winds so greatly dreaded, and there is nothing to prevent a matilla county from making a record for itself this year in wheat raising.

Noted Steamboat Man.

Every person who has lived in the states bordering on the upper Mississippi, who had any knowledge of the steamboat traffic, will remember the large hearted "Diamond Joe" Reynolds, who is pained to read the following item which is going the rounds of the papers: "Diamond Joe" Reynolds, the millionaire, died at Miners Camp, near Prescott, Arizona, Saturday. He was nearly 80 years old. He was the owner of a line of steamers on the Mississippi and of the famous Hot Springs, E. R. twenty miles long. The fare was at one time five dollars, but at present two dollars. He was also the owner of vast mining properties in Arizona, and was at the time of his death contemplating vast improvements, which would have employed quite a number of men. Among these was a railroad from Prescott to Phoenix, Arizona. He did not leave any children.

HARNEY COUNTY SEAT FIGHT.

The War Between Burns and Harney City A Bloody Clash.

The Huntington Herald is responsible for the following: "News has been received here that on last Friday evening, about three miles from Burns, on the road to Baker City, a fight took place between citizens of the two places. Report has it that citizens of Harney City made a raid on the courthouse at Burns and captured the records of the county and started on their return homeward with the prize, and when about three miles out on the road a party of armed men from Burns overtook them and a fight ensued. Three men, George Triggerson, Logan, manager of Snodgrass's store, and George Stillman were killed. J. B. Huntington, register of the land office; John Vaughan, postmaster at Burns, and John Sawyer were wounded, how badly we do not learn.

"On Sunday night a deputy United States marshal passed through Harney City. For the purpose of consulting the governor and United States marshal on the situation. Excitement is running high in Harney county, and it is feared another bloody fight may take place at any time.

How it Operated.

A lumbering enterprise in Southern Oregon, which sought legislative aid, and which aid was sought to be rendered negative by Governor Penney, is referred to by the Ashland Tribune in the following: "Governor Penney's veto of the bill granting the water franchise to the Sugar Pine Flume company was a brief and fleeting victory. The veto message was made the special order for 2:30 o'clock Friday afternoon in the house, and after some discussion was passed over the veto by the unkind vote of 19 to 11, and in the senate the bill passed over the veto by the vote of 12 to 7. This shows that there was some hard and effective work done by Merritt, and that some business people were not mistaken in him when they felt confident of his ability to put a bill through in spite of the opposition developed in this county and the assurance of the governor that he would see that the bill should never become a law. Now let us hope that the Central Point company will be as successful in making the project a practical business success as they have been in securing the desired legislation. They have a valuable franchise, and if the projected business can be inaugurated soon it will be a fine thing for Jackson county. It will mean that a timber industry of proportions great enough to employ hundreds of men will be added to the productive business of our county, and its effect will be to stimulate business of every kind, from one end of the valley to the other."

A Small Blaze at Lebanon.

As Mr. Carlie went home from church Sunday at Lebanon, a fire discovered in A. Dodge's building, which is occupied by Mr. Robinet. The family had made their bed on the second floor the night previous and it is thought that the children carelessly drew the bedding too close to the stovepipe which runs through the upper room, and the fire originated in this way. The bedding was destroyed but the building sustained little or no damage.

IMMIGRATION GOSSIP.

A Letter from a Linn County Citizen Who Is in Seattle.

The following is, in part, a letter from J. R. Kirkpatrick, written from Seattle and published in the Lebanon Express: "It is a well-known fact that Seattle is the objective point for the largest bulk of Eastern emigration and has become the distributing point for that vast tide of living humanity that is pouring like a living stream from the Atlantic to the Pacific coast. A large per cent of this emigration are farmers, who know nothing of tilling the soil and raising the cereals, fruits and vegetables. This class of people, by no means an unimportant and essential factor in society, commerce and prosperity—are finding it very difficult to get farms and farming lands adjacent to the Sound country, and are turning their faces from here to California and Oregon to find a home. California, always on the alert for immigration, has some of the most expensive schemes for catching the immigrants here in Seattle. On Front and Second streets, occupying the front entrance of some of the most costly apartments, are two vast streams of men, well arranged in the most fascinating and attractive manner, and these establishments are presided over by sharp, shrewd agents, that are using every possible device to get immigrants to go to California. The vast majority of them are the men of every immigrant to the Presidio, California. Just think of it, emigration agents in Seattle to get customers for California. Now there is only one agent here for Oregon, that we have met, who is paid anything at all to help turn this vast stream to the Willamette valley, and this gentleman is from Eugene. All the farming lands, that we can hear of, that are at all accessible and can be bought, are now being sold at from \$100 to \$500 per acre, and when I tell them that we have a large tract of grain lands in Linn county for \$20 per acre, they look at me in astonishment and ask me where is Linn county? I have already induced three families to start for Lebanon this week, and expect some more to start next week. The more I travel and see of this world, and if the proper steps were taken by her citizens to advertise her timber and mineral resources, water power, and also her fruit and garden lands, it would not be long before her material wealth and population would place her in the front rank of any other part of this coast.

A careful study of Linn county will convince her citizens, and also her neighbors, that the county could support a population of 200,000, and the people could have more home comforts and luxuries than are now enjoyed.

Electric Water Power.

Salem is making an attempt to run the electric power for its motor cars by water power. The Journal says the first efforts of the capital city street railway company to use water instead of steam was not attended with success. The belt wheel connected with the water shaft was found to be too small and the head of water not sufficient to give enough power to move the cars at half speed on level track. The needed changes will be put in at once and a fair test made of water power before the scheme is given up. The managers have confidence in the plan and think it will work satisfactorily.
